CRIME REPORT

3 arrested for selling expired/outdated ration, 3 vehicles seized

GANDOH: Police on Saturday arrested 3 persons for selling expired/outdated ration and seized vehicles involved in crime.

Doda Police said that acting on a specific information that expired/ outdated ration was being taken in vehicles for selling to people in Gandoh area, a party of Police station Gandoh led by Insp Vikram Singh SHO Gandoh assisted by PSI Parvez Ali laid a Naka on Gandoh road. During checking, 3 load carriers (JK06A-5306, JK14F-6783 & JKP6A-9379) were found loaded with outdated/expired ration. On questioning, drivers of the vehicles disclosed their names as Irshad Ahmed, son of Nisar Ahmed, resident of Bathri (Kahra); Mohd Arif, son of Ghulam Nabi Wani, resident of Tendla (Chilly Pingal) and Mohd Yaqoob, son of Mareed Bakash, resident of Bathri (Kahara). They were arrested and vehicles were seized on spot. During further questioning, it was also disclosed by drivers that they were going to sell loaded ration in Chilly Bhatoli Haddal area after changing expiry date on ration bags from year 2021 to 2022 with permanent marker. FIR No. 22/2022 under sections 420, 273 IPC was registered against trio at Police Station Gandoh and investigation started. The arrests and recovery were made under the supervision of Additional SP Bhadarwah Aftab Ahmed Mir, SDPO Gandoh Shahzada Kabir Matto.
