## MP Ladakh requests LG to promote JEs, AEs

LEH: A delegation of Junior Engineers (JEs) from Leh called on Member Parliament Ladakh Jamyang Tsering Namgyal and apprised him of the pending demand of promotion of Junior Engineers.

The delegation informed about JEs not getting their promotion, some even after serving as JE for over two decades. Subsequent to the JEs representing before him, J.T Namgyal wrote to the Lt. Governor of Ladakh, R.K Mathur seeking intervention to promote Junior Engineers to Assistant Engineers.

"Whereas, after the appointment of manpower between UT J&K and UT Ladakh, vide Govt order no 09-1K(GAD) of 2022 Dated : 08-03-2022, the employees working in UT Ladakh have

been excluded from the - Seniority /Eligibility list" and as such the employees were not considered for promotion in UT "J&K," Namgyal informed LG Ladakh, adding that most of the Junior Engineers working in the Administration of UT Ladakh have rendered more than 25 years of service on the same post and many are on verge of retirement and have attained more than enough qualified service for promotion.

"There are more than 40 numbers of posts of Assistant Engineers as apprised by the delegation which are lying vacant in the departments and that the department is running short of AEs. The

Administration of UT Ladakh under your guidance has carried out the promotion of AEEs to Executive Engineers (XEn) and XEns to SE during the last one year. Similar procedure may be adopted in case of the promotion from JEs to AEs," he requested.

MP Ladakh recommended that the concerned authority be advised to initiate necessary procedures for appropriate promotion of the concerned JEs at the earliest possible and the left out vacant posts of JEs be advertised for recruitment.
