2/ Special Condition:-

a) It will be mandatory and binding on the contractor to start the work within 12 Hours intimation from the Engineer-In-Charge of the area. As the works are of emergent nature, the intimation can be given by SMS/ Phone Call/Whatsapp on Mobile No. which is required to be mentioned on document uploaded with the documents. If the Mobile Number is not mentioned his Bid will be considered as non-responsive.

b) Photographs of pre, during & post restoration of all the activities need to be maintained and this will be the responsibility of the concerned contractor in Liaison with the Engineer-In-Charge to maintain them. A set of the photographs will have to be enclosed with the payment bills.

c) In case the contractor does not start the work within the stipulated time, the department will be at liberty to get the work done from any contractor/piece workers at the risk and cost of the contractor to whom the work is allotted.

d) Various quantities advertised are indicative only and the actual quantities can vary as per the site conditions and the contractor will be bound to act accordingly.

e) Before commencement of work the Asstt. Executive Engineer concerned will report to the Divisional Office with reference to the damage report and urgency in execution of work duly supported with the photographs clearly indicating the quantum of damages.

f) During execution of work, daily progress report shall have to be maintained at Sub Division level which shall also be intimated to the Divisional Office on weekly basis.

g) During submission of claims of particular work, the daily progress report as per Sub Divisional record shall have to be certified by the Technical Officer of the concerned Asstt. Executive Engineer concerned.

h) In case of heavy damages, immediately motor path shall be restored simultaneously after submission of damage report and photographs.

i) For any new work beyond the scope of providing motor path for the vehicular traffic, the detailed estimate duly supported with photographs, drawings (Site Plan & X-sections etc.) and technical report shall be submitted to the Divisional Office for accord of technical sanction. The work shall be executed / resumed only after accord of technical sanction as per requirement at site.

Public Notice

National Food Security Act (NFSA) has been implemented with an objective to provide food and nutritional security, by ensuring access to adequate quantity and quality food at subsidized rates to poor and vulnerable section of the society. Further, following Inclusion & Exclusion criteria as per the NFSA guidelines has been notified by Administrative Department vide S.O. 389, dated: - 16/11/2021 for Identification & Inclusion of left out genuine beneficiaries under NFSA under the Chairmanship of District Development Commissioner (Head of District level committee).

1. Criteria for inclusion

i. For Urban areas

a. All Antyodaya Anna Yojana Families;

b. Households without shelter;

c. Households with destitute persons who is living on alms;

d. Households headed by a widow or a single woman (un-married/separated/deserted);

e. Households headed by differently abled person or individual having disability of above forty percent or terminally ill;

f. Transgender person;

g. A Household headed by a minor or orphan;

h. Households dependent on daily wage labour;

i. Households with old persons aged 60 years or above with no regular income, support or no assured means of subsistence;

If all earning adult members in a household are irregular wagers then that households shall be included; & Other vulnerable Households such as slum dwellers rag pickers, un-skilled workers, shikarwalas & Panywalas, domestic workers, sweepers etc.

ii. For Rural areas

a. All Antyodaya Anna Yojana Families;

b. Households without shelter;

c. Households with destitute persons who is living on alms;

d. Households headed by a widow or a single woman (un-married/separated/deserted);

e. Households headed by differently abled person or individual having disability of above for percent or terminally ill;

f. Transgender person;

g. A Household headed by a minor or orphan;

h. Households dependant on agricultural labourers;

i. Households with old persons aged 60 years or above with no regular income, support or no assured means of subsistence;

j. Tribal Households with no regular source of income; and

k. Other vulnerable Households such as shikarwalas, Panywalas, Potters, Cobblers, domestic workers, sweepers etc.

11. Criteria for exclusion

a. Households with atleast one member as income or professional taxpayer;

b. Businessman having business turnover of Ra. 25 lacs/year;

c. Persons having land holding above 10 kanals in case of individuals and 20 kanals in case of joint family in urban areas. In rural areas, the same shall be 30 kanals and 50 kanals respectively (all based on self-declarations);

d. All gazetted officers or equivalent ranks in corporations, boards, PSUs etc;

e. All persons holding constitutional authority/positions; and

f. Any Household having annual family income of more than 5 lacs.

Further, as per the Govt. Order no 129-CAPD of 2019 dated 04.12.2019, sanction was accorded to the constitution of District Level Committees and Tehsil level Committees with the following composition.
