- Whereas, as per the contract agreement signed on 28-01-2022, the work was to be started on the same date and had to be completed in 4 months i.e. up to 27-05- 2022.

- Whereas, the contractor started the work at the site after considerable persuasion and partly constructed foundation blocks for 5 no. structures till date which covers negligible percentage of the overall project cost.

- Whereas, the work which was going on at a snail's pace till 15-03-2022, was completely stopped thereafter.

- Whereas, the contractor was repeatedly asked to speed up the work for which he kept on replying that the fabrication work was being undertaken by him at some factory site.

- Whereas, the contractor was asked to give photographic and video-graphic evidence of the fabrication work on a number of occasions, which he failed to furnish.

- Whereas, now it has been conclusively established that no fabrication work has taken place till date resulting into huge time loss for the project.

- Whereas, the contractor was notified vide letter no. RODIC/Jammu/Smart City/03-22/917 dated 10-03-2022 to speed up the work, but he did not mend ways.

- Whereas, the contractor was again notified vide no. DP/Smart City/2022-23/109-12 dated 08-04-2022 (final notice) to resume the work within 15 days as per the Clause 46.1.2 of GCC but he has neither taken any measures in that direction nor has he cared to furnish a reply.

- Whereas, the contractor kept the work suspended continuously for a period of more than 30 days without any justifiable reason.

Now, in view of the fact that the work can't be kept in suspended animation any longer and more so because the traffic police authorities have been constantly pursuing for the completion of the project, Jammu Smart City Limited (JSCL) hereby orders the termination of the contract, "EPC Contract for Smart Traffic Police Booths at various locations in Jammu City" allotted in favour of "M/s Ved Paul Dewan" vide LOI No: CEO/ Smart City /2021-22/3924-26, dated:21-12-2021 as per the provision of termination Clause 46.1.1 (e) of GCC of the contract agreement.

The termination shall be effective from today i.e. 25-04-2022 and the Jammu Smart City Limited shall be at liberty to float a fresh tender for the project at the risk and cost of the contractor.

The liabilities and penalty due for the breach of contract by the contractor and consequent termination shall be realized by JSCL by appropri
