JAMMU: Members of Sainik Colony Social Group on Sunday carried out plogging drive besides visiting New FUNDAW site developed by Narinder Khajuria. Plogging is a combination of jogging with picking up litter (merging the Swedish verbs plocka upp (pick up) and jogga (jog) gives the new Swedish verb plogga, from which the word plogging derives). The New Functional Urban Neighbourhood Diversity in Arid Wastelands (New Fundaw) is a personal initiative of Mr. Narinder Khajuria, a civil servant, to create a network of urban bio-diversity spaces across various neighbourhoods and cluster settlements to develop identified arid wastelands or fall-

low lands into flourishing bio-diversity spaces with a focus on plants suited for arid places and/or with medicinal/aromatic properties which will further serve greater community's varied needs. The New FUNDAW will be prioritizing the development of a network of urban bio-diversity spaces in and around our cities, especially where the urban development has hitherto neglected the element of sustainability.

Members of Sainik Colony Social Group appealed all members of the society to undertake cleanliness drive on regular basis and for development of Urban Neighbourhood Diversity with plantation of suitable plants in their respective areas.

## 1241 ASHAs of NHM appear in NIOS Certification Exam

JAMMU: A total of 1241 ASHAs (Accereditd Social Health Activists)of NHM, J&K on Sunday appeared in NIOS Theory Examination for Certification which was conducted at all India Level.

The Theory Examination was conducted by National Institute of Open Schooling (NIOS) in all the districts of J&K in the designated Centres.

In the J&K, 25% of non-certified eligible ASHAs in J&K appeared in the All India level NIOS examination today. Till date, 51% ASHAs of J&K have been certified by NIOS, which is proportionately the highest in the country.

Mission Director, NHM, Yasin Choudhary while giving details informed that the certification of ASHAs has been envisaged to provide a legal and administrative framework within which the ASHA would be eligible and responsible for providing community level care for a range of ill-

nesses. This would enhance the competency and professional credibility of ASHAs, allow her to use a set of drugs and point of care diagnostics appropriate to that level of care and also provide an assurance to the community on the quality of services being provided by the ASHA. Above all, it would promote a sense of self recognition and worth within the ASHA, Yasin added.

He informed that at present, about 11263 ASHAs have been trained in all modules and various schemes and about 60% of these ASHAs are NIOS certified. All ASHAs engaged in the UT of J&K shall be certified in a phased manner by NIOS in a period of two years after they are trained in all training modules. Since NIOS has started 4 sessions per year; the department is targeting that 1000-1500 ASHAs get trained during every session for appearing in the All India Level ASHA Certification Examination by National Institute of Open Schooling (NIOS) to create a pool of health

activists in J&K. The focus is that after 2024, no ASHA is left uncertified in the Union Territory of Jammu and Kashmir.

ASHAs being engaged by NHM, J&K are working as a bridge between Health Department and the community. All the health schemes of NHM/ J&K Govt. are being implemented by ASHAs at the grass root level. ASHA is a link through which the health care needs of the people are being catered. Viewing their importance for Health care delivery at ground level, NHM has started the project of certification of all ASHAs. This flagship project is very closely monitored and reviewed strictly and periodically by Additional Chief Secretary, Health & Medical Education, Vivek Bhardwaj and MD NHM, Choudhary Mohammed Yasin, and has a direct and active support of Chairperson, NIOS, Prof. Saroj Sharma, Director Evaluation, NIOS Sh. S. K Prasad and Regional Director, NIOS Dr. Tarun Punia.
