Public Service Commission.

for Srinagar Centre.

Mayor discusses various electricity-related issues with MD JPDCL

JAMMU: Highlighting various electricity-related issues faced by
people of Jammu city, Mayor Jammu Municipal Corporation
(JMC), Chander Mohan Gupta along with Raj Kumar, Chairman
Public Health & Sanitation Committee and Ajay Gupta,
Chairman Social Justice Committee, sought a number of correc-
tive measures for further strengthening the power edifice so that
all issues can be resolved.

While addressing media, Mayor said that people often raise
issues regarding construction of drains/ lanes, better sanitation,
power-related with elected representatives because they are easily
approachable. He further said that although the issues regard-
ing water supply have been resolved to some extent due to trans-
fer of Jal Shakti Department (Urban) to JMC but as per as elec-
tricity related issues are concerned, same were taken up with
Managing Director JPDCL, Shiv Anant Tayal and other
Executive Engineers during a meeting. "Various demands raised
during the meeting included requesting stoppage of all unsched-
uled power-cuts as same affect water supply as well. Relief be pro-
vided to consumers who have been imposed heavy electricity bills
by way of settlement & amnesty scheme/ monthly installments.
Further, a foolproof infrastructure will be developed to protect
transformers from getting damaged/ burnt besides keeping a
check on power thefts. Moreover, installation of smart-meters was
opposed until proper infrastructure/ cabling is done," he added.

The Mayor further said that MD JPDCL has assured that
genuine issues of general public regarding PDD will be
resolved on top priority. He also appraised that in order to pro-
vide relief to people of Jammu during ongoing summer sea-
son, LG Manoj Sinha has recently inaugurated 6 Power
Infrastructure Projects costing Rs. 64.10 crores, adding
another 660 MVA capacity to existing power system, which
will benefits more than six lakh population of Jammu.

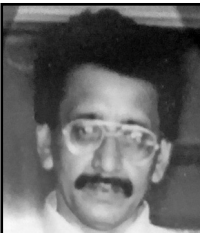
