Govt adopts centralised mechanism for payment of counsel fee

JAMMU: The government has adopted a centralised mechanism for payment of "retainership, counsel fee, incidental expenses etc., to all the counsels representing it" before the Supreme Court of India, High Court of Jammu and Kashmir and Ladakh, Tribunals and other forums.

Consequent to this, all other modes of payment by any department, office, Corporation, autonomous body etc., statutory authority or Head of Department or subordinate office for any case shall stand abolished," read an order issued by the Law Secretary Achal Sethi.

"Sanction is accorded to the adoption of a centralized mechanism for payment of retainership, counsel fee, incidental expenses payable by any Department/Office/Corporation/Autonomous body etc, Statutory Authority or HOD(s) or Subordinate Office in any court case has been abolished from April 1, 2022, except as per the mechanism, manner and mode prescribed in annexure to the Order referred ibid, which shall be the only mode of payment from April 1m 2022 onwards," it stated. "Accordingly, all the Administrative Secretaries/HOD's are impressed upon to comply the aforesaid Order in letter and spirit and not to make any payment(s) relating to any court case in favor of any counsel henceforth except as per the mechanism laid down in the Government Order referred above," it further added.

"Vide Government Order No. 477-JK(LD) of 2022 Dated February 4, 2022 issued in pursuance to Administrative Council Decision No.
