



# CRIME REPORT

## Notorious thief booked under PSA

KUPWARA: Acting tough against anti-social elements and to make society crime-free, Police on Thursday booked a notorious thief under Public Safety Act (PSA) after obtaining necessary sanction from the authorities. As per details, a notorious thief namely Mudasir Ahmad Lone, son of Late Abdul Majeed Lone, resident of Mughalpora Kupwara was detained under Public Safety Act (PSA) by Kupwara Police after obtaining sanctions from concerned authorities for his unrelenting criminal acts. He was involved in at least five cases of burglary and theft in and around Kupwara town.

## 5 bovines rescued, vehicle seized

SAMBA: Police on Thursday foiled an attempt to smuggle bovines by rescuing 5 cattle in jurisdiction of Police Station Ghagwal.

As per details, acting on an information received from reliable sources regarding illegal transportation of bovines, a party from Police Station Ghagwal at Naka Tapyal, signaled a Mahindra vehicle without registration number; Chassis No MA1ZU2TNKMID35961 to stop for checking. But, instead of stopping vehicle, the driver accelerated the vehicle and tried to jump Naka, but was successfully chased by alert cops. On checking of vehicle, 5 bovines were found, which were rescued. In this connection, FIR No. 51/2022 under sections 188 of IPC, 11 of PCA Act was registered in Police Station Ghagwal.

## MC Vijaypur launches anti-encroachment drive

SAMBA: Municipality Committee Vijaypur has initiated strict measures against road encroachment by shopkeepers, Hawkers, Rehri-wallas across town.

Executive Officer MC Vijaypur, Ravi Saini informed that around 150 encroachments by shopkeepers were removed from main bazaar and a fine of Rs 2,600 was imposed on violators. He said that similar action shall be taken in different parts of town in coming days. EO further said that it has been observed that many people

have constructed sheds and structures for car parking at several places in violation of Municipal rules. A few have placed Rehris on road blocking passage of vehicles in area. He said the Municipality has also launched an awareness drive to educate shopkeepers and hawkers regarding the norms.

## 49 bovines rescued; 5 vehicles seized

RAMBAN: Police on Thursday foiled various bovine smuggling bids by rescuing 49 bovines and seized five vehicles.

As per details, acting on specific inputs regarding transportation of bovines, different parties of Police Stations Chanderkote and Ramban intercepted five vehicles (JK19A-1567, JK02CS-4131, JK03G-5251, JK19-9602 and JK03F/4872) and on checking, found 49 bovines laden in them, which were rescued. FIR No 67, 68, 69/2022 were registered at Police Station Chanderkote while FIR No 119, 120/2022 were registered at Police Station Ramban under relevant sections of law and investigation started. The overall rescue operation was done by police parties under the command of Insp P D Singh SHO Chanderkote and Insp Sandeep Charak SHO Ramban under supervision of Pardeep Singh Sen DySP HQ Ramban with overall supervision of SSP Ramban, Mohita Sharma.

## Absconder evading arrest for 30 years arrested

JAMMU: Police on Thursday arrested an absconder who was evading his arrest for 30 years in various cases.

As per details, an information was received at Police Station Nowabad regarding an absconder namely Vijay Kumar, son of Mani Ram, resident of Kher Majur Tehsil Chowki Choura who was evading arrest since 30 years i.e., 1992 in FIR no 190/1992 registered under section 380 of RPC , FIR no 175/1992 registered under section 379 of RPC , FIR no 189/1992 registered under section 380 of RPC, FIR 165 /1995 registered under section 379 of RPC at Police Station Nowabad. On this, a team of Police Station Nowabad under the supervision of DySP Hqrs Swati Sharma led by SHO Nowabad Insp Vijay Kumar, after putting in strenuous efforts, arrested the absconder, who was produced in the Court of Special Municipal Magistrate, Jammu.

## Two bootleggers arrested; 147 bottles of illicit liquor seized

JAMMU: In an act of alertness and prompt action, police arrested two bootleggers and recovered 147 bottles of illicit liquor from them at two different Nakas.

As per details, information was received at Police Station Miran Sahib through

reliable sources regarding sale of illicit liquor. On this, a team of Police Station Miran Sahib under supervision of SDPO R S Pura Surinder Singh led by SHO Miran Sahib Insp Sultan Mirza while on Naka duty at Marallian Morh and Kotli Mian Fateh Bus Stand, rounded up two suspects coming on two vehicles (JK02CU 8339 and JK02BH 3840).

During search, 147 bottles of illicit liquor i.e., 60 bottles at Marallian Morh Naka and 87 bottles at Kotli Mian Fateh Bus Stand Naka, were recovered and seized by Police. On this, FIR No 29/2022 under sections 48-E of Excise Act and FIR No 30/2022 under section 48-A of Excise Act were registered at Police Station Miran Sahib and both accused were arrested, who were identified as Tejinder Singh, son of Karam Singh, resident of Makhanpur Gujran, Miran Sahib and Jyoti Gupta, son of Chander Bushan, resident of Rattian, Tehsil R S Pura. Further investigation is going on in the matter.

## Two missing persons traced, reunited with families

JAMMU: Police on Thursday traced two missing persons and reunited them with their families.

As per details, two different complaints were lodged at Police Station Miran Sahib and Police Station Gharota, by legal heirs of a person namely Kaka Singh, son of Dewan Singh, resident of Simbal Camp Tehsil R S Pura and a woman, stating that they went missing from their respective homes.

In this regard two different missing reports i.e., report vide DDR No.11 March 19, 2004 regarding missing of man and report vide DDR No. 15 dated March 15, 2022 regarding missing of woman was registered at Police Station Miran Sahib and Police Station Gharota respectively and investigation started.

On this special police teams were formed under supervision of SDPO R S Pura Surinder Singh and SDPO Akhnor Varun Jandial. The teams led by SHO Miran Sahib Insp Sultan Mirza and Insp Rajesh Khajuria, after putting in hectic efforts, traced both the missing persons. Subsequently families of missing persons were informed and traced man and woman were handed over to their respective family members after completing all legal formalities.

## VDC member's son commits suicide

JAMMU: 28-year-old man allegedly shot himself dead using his father's rifle in Poonch district on Thursday, officials said.

Gulzar Ahmed, the deceased, is the son of Mohammad Fazal, member of a Village Defence Committee in Murrah, they said.

Police said they have registered a case and launched an investigation.
