as its vice-president's residence as well as an office where he holds meetings with party MPs and others.

"There is a rent agreement between the NC and a Mumbai company for it. Rent is regularly paid by cheque from the party accounts," they said.

Slamming the questioning of Abdullah by the ED, the NC further said, "Over recent years, we have seen that wherever state elections are due, agencies like the ED move in and target those parties who pose a challenge to the BJP."

A party spokesperson said the summons to its vice-president is in the same vein. "We have no doubt that this fishing expedition will yield no concrete results to the BJP and the people will give a ringing endorsement to the National Conference as and when required."

The spokesperson said Abdullah had been asked to appear before the ED in Delhi on the grounds that his attendance was necessary in connection with an investigation.

"In spite of it being the holy month of Ramzan, and Delhi not being his primary place of residence, Mr Abdullah did not seek a postponement or a change of venue and appeared as per the notice," he said.

The party alleged that the central government has "made a habit of misusing investigative agencies" and 'Thursday's questioning of Abdullah was "another step in the same direction".

"No political party that puts up meaningful opposition to the BJP has been spared, whether it is the ED, CBI, NIA, NCB all have been used for political purposes," the NC spokesperson said.

The party said the summons is another step in the "vicious vilification" campaign that started even before August 5, 2019, when constitutional position holders like the then governor were used to make "slandorous accusations" against opponents of the BJP, knowing well that there was no legal recourse available to those at the receiving end of these "lies".

Even though this exercise is political in nature, Abdullah will cooperate with investigative agencies as there is no wrongdoing on his part and he is not an accused in any matter under investigation, the spokesperson said.

Department. Dr Mehta said that the current year would be a transformational year with respect to the education system and important changes would be required in the process. He said that the UT will implement the NEP from April 1 and sought suggestions from VCs about the modalities to be adopted for making a smooth transition in its implementation. The VCs unanimously suggested the need to synchronize the academic calendar with the national academic calendar and move to a single calendar. They said that adoption of uniform calendar system would not only enable the students from JK to compete with students in rest of the country for admissions to top institutions but also save valuable time.

The Chief Secretary advised the universities to ensure implementation of the calendar in such a way so not to lead to any disruptions or loss of time. He also advised them to start the admissions process as soon as possible and also offer foundational courses to the students in line with the NEP.

Asserting that Universities have a great role to play in research and vocational development, the Chief Secretary said that universities should become a centre of innovation and students instead of chasing government jobs should become innovators and job creators. He said that the government will provide every kind of support to all universities in this regard. He said that the focus of this year's financial budget will be to address the gaps in terms of academic infrastructure and teaching resources. He emphasized for greater coordination among higher secondary schools, colleges and universities that only greater coordination and supervision could lead academic excellence. He said that J&K universities should chase excellence in education and obtain the best possible rankings

He asked the VCs to develop a robust framework for getting feedback from the students as academic feedback is more strongly and consistently related to achievement and quality of higher education. He also stressed on the need for a vibrant academic and cultural ecosystem, organizing more intra and inter University competitions and a healthy campus life.

Principal Secretary Higher Education briefed the meeting regarding the various steps being taken for the implementation of the NEP. He informed the meeting that all degree colleges in J&K would apply for accreditation or provisional registration (PAC) under the NAAC framework this year. In addition, at least 10 Government

Degree Colleges across Jammu and Kashmir would identify sister Colleges which would have collaboration with reputed International Institutions to boost faculty and student exchange programs. From the academic Session 2022-23, 14 Centers of Innovation, Invention, Incubation and Training would be established under Hub and Spoke model. In addition, IIT and IIM Jammu would develop 10 Incubation Centers (each) in Degree Colleges under Hub and Spoke model.

Regarding Learning Management System (LMS), Principal Secretary informed that JK Higher education department has launched its own LMS that supports Online Learning for students. In the first phase, 22 GDSCS have been connected while all GDSCS will be connected with LMS in next Phase. It was also informed that JK Higher Education department has directed all institutions to ensure equitable access to quality education, with a special emphasis on Socio-Economically Disadvantaged Groups (SEDGs).

182 KP families...

specially invited for the programme, a state government statement said.

The rest of the families received the letters from the state's ministers and officers, who virtually attended the programme, it said.

A total of 209 families had purchased land in Sector 2, Bahadurgarh, some three decades ago, but could not occupy it until now.

Today is a historic day in Haryana's history as the wait of families of Kashmiri Pandits who had purchased land during 1991 and 1993 has finally ended.

In these 30 years, they must have even lost the hope of getting their land which was sold to them without even telling its disputed status, Khattar said, as per the statement.

After making suitable amendments in 1997, some of the plots were released in favour of Kashmiri Pandits, but those that did not get the land at that time had to wait for almost three decades, he said.

On April 6, 2022, after verification and required measurement of these plots being recorded at that time, the allotment process has already been done through a draw and today, the letters to 182 families have been distributed to them.

Other than this number, some of the families have already got their plots. Thus, through this entire process, promises made to these 209 families have been fulfilled, he added.

Khattar said Vachanpurti Mission', which translates to a mission to fulfil a promise, is a befitting reply to the claims of the Opposition, which has been alleging that the present state government had stopped financial aid of Rs 5,000 per month to the Kashmiri Pandit families.

I would like to clarify that the scheme of giving Rs 5,000 per month as financial aid to these families was not started by us, it was the Congress that had framed these rules that any family would get the said amount for a period of five years.

As per our official data, right now, out of the total five such families, only one family is getting this aid because it has not yet completed the five-year rule, while the rest have completed their five-year norm, he said.

The chief minister alleged that the opposition was now making baseless statements as it was unable to digest the success of the movie, 'The Kashmir Files', which is based on the exodus of Kashmiri Pandits from the Valley.

The beneficiaries thanked Khattar for allotting the land that they had purchased with their hard-earned money almost 30 years ago, after they were forced to vacate their houses in Kashmir overnight with the onset of militancy in the Valley.

In 1991-92, we came to Bahadurgarh. After coming here, we purchased a small piece of land hoping to restart our scattered lives, but it took us almost three decades to get possession of it. We can't express our happiness and gratitude towards the chief minister because of whom we got our land back, said one of the beneficiaries, as per the statement.

soldiers and protesters. The injured were identified as Abdul Ahad Mir and Majeed Ahmad Sofi, the officials said, adding that they were rushed to the SKIMS hospital at Sura here.

"Troops of 21 Rashtriya Rifles were on a routine patrol in Handwara town. In view of an Iftar party planned by the Army near the Town Chowk, the troops took a few photos of the Jamia Masjid in Handwara at about 1.30 pm to showcase happiness and offering of prayers during the holy month of Ramzan," the spokesperson said, adding that they also requested a local resident to get a few photos clicked from inside the mosque.

"When he was going to take the photos, some rogue elements protested and insti-

gated others to get into an altercation with the troops. While attempting to pacify them, two-three individuals got into a scuffle with the troops, wherein there was an accidental discharge of weapons, injuring two civilians," he said.

Political parties condemned the incident, with People's Conference chairman Sajad Lone, who hails from Handwara, claiming that it was a result of the "sorry state of affairs" prevailing in the Union Territory.

"What a sorry state of affairs. One of the most peaceful towns Handwara at the receiving end. Hoping against hope the guilty are punished," he said in a tweet.

People's Democratic Party (PDP) president Mehbooba Mufti expressed dismay and shock over the incident.

Hitting out at the security forces for "barging" into a religious place, "profiling" worshippers and "shooting civilians at will without any fear of justice", she said such incidents highlight the level of unaccountability pervasive across institutions in Jammu and Kashmir.

J&K administration launches portal for verification of Government works

JAMMU: The Jammu and Kashmir administration launched a physical verification portal to monitor development works and ensure transparency, officials said on Thursday.

Additional Chief Secretary (Finance) Atal Dulloo launched the portal at the civil secretariat here.

The portal has been developed by the Directorate of Economics and Statistics in collaboration with National Informatics Centre (NIC) for filing of online verification reports of development projects in a structured and standardised format.

The aim of the portal is to carry forward an institutionalised system of transparency and accountability at all levels of governance for ensuring financial discipline and proper project management of works, Dulloo said.

COVID: 7 new cases in J&K

SRINAGAR: Jammu and Kashmir reported seven fresh Covid cases on Thursday that took the infection tally to 4,53,845, officials said.

All the fresh cases were reported from the Kashmir division, they said.

Of the new cases, six were recorded in Srinagar while Budgam district registered one case, officials said.

Eighteen of the 20 districts in the Union Territory did not report any fresh case.

There are 148 active cases while the overall recoveries has reached 4,48,947, officials said.

The COVID-19 death toll stands at 4,750. No Covid-related fatality was reported in the last 24 hours, officials said.

There were 51 confirmed cases of mucormycosis (black fungus), they added.

Curtains on Parliament’s Budget Session; stormy scene in RS

NEW DELHI: The Budget Session of Parliament concluded on Thursday, a day ahead of schedule with the Rajya Sabha witnessing stormy scenes as opposition disallowed Chairman M Venkaiah Naidu to complete his customary valedictory address.

The Session, which had 27 sittings spread over two months, witnessed spirited debates on a range of issues, while opposition members said the Narendra Modi government had concluded the proceedings ahead of schedule as it wanted to "run away" from the debate on high fuel prices.

While proceedings in the Lok Sabha were by and large smooth, the Rajya Sabha witnessed an angry exchange between Naidu and opposition members, including Mallikarjun Kharge, Derek O'Brien who wanted a discussion on repeated hike in fuel prices.

In the Rajya Sabha, Shiv Sena members Sanjay Raut and Priyanka Chaturvedi tried to raise the issue of FIR registered against the BJP's Kirit Somaiya for allegedly siphoning off donations collected for saving INS Vikrant.

Congress members supported the Shiv Sena with some remarking that the issue of spiraling prices of essential commodities including those of petrol, diesel and cooking gas wasn't allowed to be raised in the

entire session, but at least "this scam" should be discussed.

However, Naidu rejected the opposition plea and called for Zero Hour. As opposition members trooped into the Well, Naidu adjourned the proceedings sine die without the customary valedictory address.

"Rajya Sabha adjourned two days early... To suit its political convenience, Modi government ran away from discussion on price rise, broken promises to farmers, and the Labour Minister didn't even reply to debate on labour & (un)employment," Congress leader Jairam Ramesh said.

Ramesh contended that since Parliament was adjourned at 11:00 a.m. on Thursday, no business could be transacted and it amounted to proceedings of two days being washed out.

Parliamentary Affairs Minister Pralhad Joshi hit back at Ramesh claiming that he was "lying". Joshi claimed that the Congress leaders had made the suggestion to the Rajya Sabha Chairman to end the session early.

The Budget Session had begun on January 31 with the address of President Ram Nath Kovind to the joint sitting of both the Houses. It was followed by the presentation of the Union Budget by Finance Minister Nirmala Sitharaman on February 1.

The first half of the Budget Session con-

cluded on February 11 when Parliament went into recess to examine the budget papers.

The session resumed on March 14 and concluded on Thursday, a day ahead of schedule after completion of the budgetary process and passage of key bills such as the Delhi Municipal Corporation (Amendment) Bill and the Criminal Procedure (Identification) Bill.

"The total productivity of the eighth session of the 17th Lok Sabha was 129 per cent," Lok Sabha Speaker Om Birla said, noting that the House had sat 27 sittings.

Birla said members also sat late for 40 hours to discuss issues of national importance.

The Rajya Sabha lost nearly nine-and-a-half hours due to disruptions and forced adjournments, but made up for the lost time by sitting extra for nine hours and 16 minutes, Naidu said.

"The productivity of the House during the Budget Session was 99.8 per cent. If only the House had functioned for 10 more minutes, the productivity would have been 100 per cent," Naidu said.

The Lok Sabha passed 12 bills, including the Finance Bill, Delhi Municipal Corporation (Amendment) Bill, The Weapons of Mass Destruction and their Delivery Systems (Prohibition of Unlawful Activities) Amendment Bill.
