CRIME REPORT

Youth from majority community 'rapes' minor community orphan girl, people seek justice

JAMMU: A case of gang-rape of an orphan minor community girl by some majority community youth has come to light in Kathua district on Saturday. The victim has pleaded for justice by submitting a complaint to the SDPO. The accused are influential due to which police has not yet registered the case under pressure and trying to hush-up the matter. At the same time, many minor community organizations staged protest and demanded strict action against accused.

As per details, a girl from Lohai Malhar has given a written complaint to SDPO Billawar that she was gang-raped by some majority community youth on April 7 when she was on way to her aunt's house. She was dragged into car and was later raped by some youth. The victim said that she is an orphan and lives with her brother. She has recognized one of the accused and said that accused has a lot of property in the area and his father is a government employee. On the other hand, SDPO Billawar Arvind Kumar has assured that accused will not be spared.

Baramulla at a checkpoint established at Stadium Colony Baramulla intercepted a vehicle (Verna) bearing registration number JK05TH-0916 driven by Mohd Rafeeq Lone son of Mohd Yousuf Lone resident of Nadihal Baramulla.
