In addition to Hindi and English, the question paper will be set in Assamese, Bengali, Gujarati, Marathi, Malayalam, Kannada, Tamil, Telugu, Odia, Urdu, Punjabi, Manipuri and Konkani.

The announcement comes days after Tamil Nadu Chief Minister MK Stalin wrote to Shah, urging him to include Tamil as a language for the written exam in the recruitment for CRPF personnel.

In his letter, Stalin said that in the notification for the CRPF recruitment written exam, it was mentioned that the test could be taken in English and Hindi.

The Ministry of Home Affairs said the decision will result in lakhs of aspirants taking the examination in their mother tongue or regional language and improve their selection prospects

The ministry and the Staff Selection Commission will sign an addendum to the existing Memorandum of Understanding to facilitate the conduct of the examination in multiple Indian languages, the statement said.

Constable (general duty) is one of the flagship examinations conducted by the commission and attracts lakhs of candidates from across the country

The examination in 13 regional languages, in addition to Hindi and English, will be conducted from January 1, 2024.

The state governments and Union Territory administrations are expected to launch a wide campaign to encourage local youths to use this opportunity of taking the examination in their mother tongue and participate in large numbers to make a career serving the country, the statement said.

The ministry, under the leadership of Modi and the guidance of Shah, is fully committed to encourage use and development of regional languages, it said.

The farmers of India ensured the coverage of nearly seven hundred thousand hectares of farmland by micro-irrigation. Fulfilling the mantra of 'Per Drop More Crop', this has saved a huge amount of water, he pointed out.

"Under Mission Life, our efforts are spread across many domains such as: Making local bodies environment-friendly, saving water, saving energy, reducing waste, and e-waste, adopting healthy lifestyles, adoption of natural farming, promotion of millets," Modi said.

ve over 22 billion units of energy, save nine trillion litres of These efforts w water, reduce waste by 375 million tons, recycle almost one million tons of e-waste, and generate around 170 million dollars of additional cost saving by 2030, he said.

"Further, it will help us reduce the wastage of 15 billion tons of food," Modi said, noting that the global primary crop production in 2020, according to the Food and Agriculture Organisation, was about nine billion tons.

India updated its Nationally Determined Contributions (NDCs) - plans to limit global warming to 1.5 degrees Celsius - in August last year, promising to reduce emissions intensity of GDP by 45% by 2030, from the 2005 level, and achieve 50% cumulative electric power installed capacity from non-fossil fuel-based energy resources by 2030.

punishment to the convict. It is to be noted here, that the convict had also attempted to kill his wife when she intervened and tried to save the deceased from the brutal attacks of the convict. Had the wife stayed there or the Sickle had not dropped from the hand of the convict, he would have definitely killed his wife also.

Court further observed that in the instant case, the convict Jeet Singh has been convicted under section 302, 307 RPC and 4/25 of Arms Act. This court hardly finds any mitigating circumstance in favour of the convict. The fact that convict is illiterate person, hence was not aware of the consequences of the Act committed by him, resides in remotest area of this District having no access to transport and road facilities, the offence was not committed in premeditated manner, in my opinion obviously will not constitute the mitigating circumstance. Even for that matter, the convict who is 45 years of age at this moment, will also be not consider as the mitigating circumstance.

The aggravating circumstances against the convict are: The accused had committed murder of his old age mother who was helpless and unarmed at the time of commission of offence just for 02 kanals of land besides asking her to live with other son. He had further committed the offence of attempt to murder of his wife with the use of Sickle and Axe, when she intervened to save the deceased from the attacks of con-

The offence of murder committed by the convict seems to be pre-meditated one. The convict has committed the offence of murder upon the age old defenseless mother who had given birth to the convict by first attacking with Sickle on the neck of the deceased mother and thereafter chopped off her head with the use of Axe in a very inhuman and barbaric manner. Deleterious impact of the crime on social order and human psyche added to the list of the aggravating circumstances. Nature of offence and manner of committing the crime aroused extreme resentment to the

Thus, on the existence of aforesaid mitigating and aggravating circumstances and evaluation thereof, this Court finds that the aggravating circumstances are much grave and serious than the mitigating circumstances. As such the instant case falls within the ambit of "rarest of rare cases" and therefore, in my pensive opinion the accused Jeet Singh does not deserves any leniency in the sentences to be awarded to him except sending the convict to gallows would be adequate. The court observed, "Convict namely Jeet Singh is sentenced to undergo rigorous imprisonment for 10 years and pay a fine of Rs 3000 for the commission of offence under section 307 RPC and in default of payment of fine, he shall further undergo simple imprisonment for one month. The convict is sentenced to death for the commission of offence under section 302 RPC and he shall be hanged by neck till he is dead and for the commission of offence under section 4/25 of Arms Act, the convict is sentenced to undergo rigorous imprisonment of 3 years and fine of Rs 2000. In case of failure to pay the fine he shall further undergo rigorous imprisonment for one month. All the sentences shall run concurrently. The case was professionally investigated by Insp. Deepak Pathania (then SHO Police Station Ramnagar) who was Investigating Officer (I.O.) of case. Evidences were very meticulously joined by the I.O. which led to the conviction of accused in such a barbaric murder which had created sensation at that time.

The Jammu Smart City Limited, a special-purpose vehicle constituted in August 2017 by the Jammu and Kashmir government for the implementation of smart city development projects, has set up a network of docking stations across the city.

It has installed 120 docking stations for 720 mechanical bicycles and 80 pedalassisted electric bicycles in prominent locations, including Jammu University, Jammu bus stand, Indira Chowk, the exit gate of the Government Medical College Super Speciality Hospital, Parade Chowk, the entrance gate of the Jammu airport and the Ragunath Temple, the official said.

The users can rent a bicycle through the 'Yaana Bikes' mobile app, which is available on both Android and iOS, the official added.

The minimum membership fee is Rs 50 for five 30-minute rides a day. The highest fee is Rs 1,500 for 1,500 rides of 30 minutes each over a one-year period.
