

## GDCW Kathua organises lecture on 'Health risk of drugs and tobacco consumption'

KATHUA: The Drug De-Addiction Cell and Department of Zoology, Government Degree College for Women (GDCW), Kathua on Monday organized a lecture on the topic 'Health risk of drugs and tobacco consumption' to make students aware about the current scenario of drugs and tobacco consumption and the related health risk. The lecture was delivered by Dr. Mustafa Ali, Senior resident, Department of Psychiatry, GMC Kathua. The event was organized under the patronage of Dr. Savi Behl, Principal. The

programme began with the welcome address by Dr. Deepti Salotra, Assistant Professor, Department of Home Science. Dr. Ali shed light on the increasing drugs dependence and smoking in the society, youth in particular.

He mentioned about the drug abuse that occurred due to the use of illegal drugs, the use of prescription or over-the-counter drugs for purposes other than those for which they meant to be. He also discussed about nicotine dependence that leads to tobacco addiction and it occurs when you need nicotine and can't stop using it.

Nicotine consumption produces temporary pleasing effects in the human brain that lead to enhanced reach for another dose. Drug abuse and tobacco consumption lead to social, physical, emotional and financial problems.

He further talked about the various methods of solving the drug and tobacco consumption problem such as: By exploring addiction treatment options, support for addiction recovery, finding healthy ways to cope with stress and living a meaningful drug-free life.

Dr. Ali also talked about the initiatives taken up by the government of India and also shared a toll free number of 'Tele-MANAS'. A memento along with a letter of appreciation was presented to Dr. Mustafa Ali by college Principal. The vote of thanks was given by Convener, Drug De-addiction Cell, Prof. Shivani Sharma.

The event was also graced by other committee members and staff members viz. Dr. Poonam Sambyal, Prof. Pallavi, Dr. Vaishno Devi, Dr. Rajni Khajuria, Dr. Varchaskam Sharma, Dr. Surekha Rani.
