Dr Jitendra announces written test for jobs in 15 languages

NEW DELHI: In a landmark decision, the Department of Personnel and Training (DoPT) has approved conduct of the Staff Selection Commission Multitasking (nontechnical) Staff (SSC MTS) examination and CHSL Examination for government jobs in 15 languages in total, that is, 13 regional languages in addition to Hindi and English.

This was announced here on Tuesday by Union Minister, Dr Jitendra Singh, who is also the Minister Incharge DoPT.

This historic decision has been taken at the behest of Prime Minister Narendra Modi to give



Union Minister Dr Jitendra Singh briefing media about the DoPT decision regarding job selection at New Delhi.


youth and encourage regional languages, said the Minister.

In addition to Hindi and English, the question paper will be set in the 13 regional languages i.e. Assamese, Bengali, Gujarati, Marathi, Tamil, Malayalam, Kannada, Telugu, Odia, Urdu, Punjabi, Manipuri (also Meiti) and Konkani, he said.

To start with the Commission has MTS to $\operatorname{conduct}$ Examination, 2022 and CHSLE Examination, 2022 in 15 languages (13 regional languages + Hindi + English) as used by Institute of Banking Personnel Selection (IBPS) / Railway Recruitment Boards (RRBs) for conducting their examination. The notice of MTS Exam has already been issued. Notice for CHSL Exam in Multi-Language will be issued in May-June 2023.

The Minister said that the MTS 2022 exam notice has received positive response amongst the candidates especially belonging to South India and also on social media. The first exam in multi-language (MTS 2022) will commence from May 2nd.

JAMMU: Under the Union Government's programme Bharat Abhiyan, Anti-Narcotics Task Force (ANTF) J&K, the specialised unit of JKP to tackle the menace of drugs, on Tuesday recovered a large quantity of formulated narcotic drugs from a sleeper bus and arrested the

"The team of ANTF conducted series of raids in Jammu and finally zeroed in and arrested one of the most wanted drug suppliers who was identified as Mohd Ishaq alias Shaka, son of Rehmat Ali, resident of Gujjar Colony, Channi Himmat, Jammu along with the consignment of 120 Codeine Phosphate Bottles at ISBT Transport Yard Narwal

Vinay added that the accused is main drug peddler of Channi Himmat Jammu and involved in multiple case of NDPS at different police "The arrested person is the

main supplier of Narcotics and Psychotropic substances which are being smuggled from NCR to J&K UT and a Case FIR No 3/2023 under Section 8/21/22 NDPS Act of Police Station ANTF has been registered against the habitual offender." SSP Vinay said adding that there is nexus between narcotics drug peddlers and few distributors of Delhi, NCR, Solan, who supply the formulated narcotics to the peddlers in Jammu and Kashmir and the suppliers

nexus between the suppliers and the distributors and owners of the bus if any to transport narcotics to different statesm," Vinay said. The arrest and the recovery were done by Inspector

In yet another successful operation, ANTF Jammu has conducted raids at multiple locations in Kashmir Valley recently and arrested one of the hardcore narcotics drug suppliers with the help of Budgam Police from Ichgam in Budgam district. The arrested person has

been identified as Nisar Ahmed Rather, son of Mohd Qasim Rather, resident of Ichgam Budgam, who is a notorious Kingpin/Supplier and wanted in Case FIR 15/2022 under Sections 8/15/20/25/29 NDPS Act 201 IPC of Police Station ANTF Jammu, SSP Vinay said adding that Nisar is the main supplier of Narcotics and Psychotropic drugs which are being smuggled from Jammu and Kashmir to Punjab and other states of northern India. He was operating from Kashmir Vallev and was associate of another drug dealer of Punjab Surinder Pal and his other associates who used to collect the consignments and sell it to the local youth of Punjab to earn hefty illegal amounts.

The Punjab based main receiver namely Surinder Pal is already arrested and lodged in jail.

With the arrest of these main notorious drug dealers, ANTF Jammu has been able to break the nexus of Narcotics and Psychotropic drugs suppliers and receivers from Kashmir Valley to Punjab.

The raids were led by Inspector Amandeep Singh of ANTF under the guidance of senior officers.
