Srinagar-bound SpiceJet flight returns to Delhi due to false warning

NEW DELHI: A Delhi-Srinagar SpiceJet flight returned to the IGI airport here on Tuesday due to a false warning in the cockpit, the airline said on Tuesday.

"On April 18, SpiceJet B737 aircraft operating flight SG-8373 (Delhi-Srinagar) returned back to Delhi as the AFT cargo fire light illuminated in the ockpit," the airline said in a statement.

The light later extinguished upon actions taken by the captain, SpiceJet said and added that before landing, all operational parameters were observed to be

"The light later extinguished upon actions taken by the captain. Subsequently, pon opening of AFT cargo no sign of fire or smoke was found and based on initial assessment, the warning was observed to be false," the statement added. The aircraft landed safely and passengers were deplaned normally, it added.
