Online Applications are invited from the eligible/desirous candidates who intend to appear in the Entrance Test for admission to B.Sc. Nursing /B.Sc. Paramedical / B.Sc. Technology Courses for the academic session-2023 in Government / Private Colleges / Institutions of UT of J&K. The selection of the candidates to such courses shall be regulated by the J&K Board of Professional Entrance Examination Act, 2002 and the Rules and Regulations there under; Jammu & Kashmir Reservation Act, 2004 as amended vide J&K Re-organization Act, 2019, J&K Reservation Rules, 2005 as amended vide S.O. 69 dated 28-02-2020, S.O 127 dated 20-04-2020, S.O. 249 dated 23-07-2021, S.O. 277 dated 13-08-2021 and subject to further amendments, if any, made by the Competent Authority, from time to time and the guidelines as contained in the Electronic Information Brochure-2023.

The candidates who are interested to participate in the Mop-up (3rd Round) of Physical Counselling are advised to report at J&K BOPEE offices Srinagar/Jammu between 09:00 a.m. to 10:00 a.m. on their respective dates of counselling for registration and fulfillment of other counselling related formalities.

Submission of Online Application Forms:

The interested candidates are required to upload the following scanned original / self-attested certificates in PDF format with size from 100-200 KB along with the Application Form: -

- domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates of UT of Ladakh, ST certificate issued by the Competent Authority of Ladakh shall be treated as Domicile Certificate),
- Qualifying marks (12th Class) certificate; (where result is declared),
- Date of Birth Certificate (only Matriculation Certificate issued by the Board);
- Valid Reserved category certificate, if any,
- Any other documents, as requested.

However, it is for the information of all the concerned that afore-titled documents as required for submission of application form shall be considered provisional and subject to change(s), if any, as may be notified by the Government subsequently.

A. Eligibility for B.Sc. Nursing Programme:

The candidates applying for admission to B.Sc. Nursing Programme must fulfill the following eligibility criteria;

A candidate must:

- be a domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates belonging to UT of Ladakh, ST certificate issued by Competent Authority of Ladakh shall be treated as Domicile certificate);
- be 17 years old on 31st December of the year in which admission is sought.
- have passed the qualifying 12th Standard examination (10+2) and must have obtained a minimum of 45% marks in Physics, Chemistry and Biology taken together and passed in English individually including the candidates from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government having Science subjects and English only.
- For the candidates belonging to reserved categories, the marks obtained in 3 core subjects shall be 40% instead of 45% for General category candidates.
- The candidate must be medically fit.

Further the candidates appearing/appeared in 10+2 (12th Class) examination 2023 can also apply, provided such candidates have qualified the examination at the time of declaration of the result of the Entrance Test or before the date of counseling/admission as may be notified by the Board;

B. Eligibility for B.Sc. Para-Medical Courses:

The candidates applying for admission to B.Sc. Para-Medical Courses must fulfill the following eligibility criteria;

A candidate must:

- be a domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates belonging to UT of Ladakh, ST certificate issued by Competent authority of Ladakh shall be treated as Domicile certificate);
- be at least 17 years old on 31st December-2023;
- have passed 10+2 or equivalent examination with Science (PCB) and English through a recognized Board / University securing minimum 50% marks and above for Open Merit Candidates and 40 % marks and above for candidates belonging to Reserved Categories in aggregate;

Further, the candidates appearing/appeared in 10+2 (12th Class) examination 2023 can also apply, provided such candidates have qualified the examination at the time of declaration of the result in the Entrance Test or before the date of counseling/admission as may be notified by the Board;

Syllabus:

The candidates applying for the courses mentioned above at (A), (B), (C), are advised to go through the syllabus for Common Entrance Test referred to in e- information brochure of B.Sc. Nursing/ B.Sc. Paramedical / B.Sc. Technology Courses available on BOPEE website www.jkbopee.gov.in.

Note - I

The eligibility is bare minimum/provisional and shall be subject to such changes/bench marks as may be fixed by the concerned Competent Authority/ University. The Board shall on receipt of any such communication from the concerned authority/University notify the same, which shall govern the eligibility criteria.

Original Documents required to be submitted in the Institution at the time of Admission: -

- Marks certificate of the qualifying examinations (12th class marks certificate);
- Date of birth (Matriculation / Secondary School Certificate) from a recognized Board;
- Domicile Certificate for candidates belonging to UT of J&K and ST certificate as a Domicile for candidates belonging to UT of Ladakh;
- Category Certificate, if any;
- Any other document as may be required by the Institution.

Roll No Slip/Admit Card:

The Notification for downloading of online electronic Admit Cards will be issued separately.

Venue for Conduct of Examination:

The Common Entrance Examination, if any, shall be conducted offline at Jammu / Srinagar centres simultaneously as may be decided by the Board.

Issuance of Admit Cards and Date of Test (if test is conducted):

Information with regard to availability of Online Admit Cards, Venue and Time of the Common Entrance Test will be issued separately in due course of time.

Note-II

- The online submitted Application Form is purely provisional and is liable to be cancelled at any stage subject to the final verification of the documents and even at any stage, where such a document is proved to be fake/false.
- In case the Board shall not conduct the entrance test, the selection of the eligible candidates shall be made on the basis of the percentage of the marks obtained in the qualifying examination.
- The candidature of those candidates, who may have submitted incorrect / wrong application form during online process, shall be liable to be rejected without any further notice to such candidates. However, they can rectify their correction(s), if any, by submitting a representation physically at BOPEE office Jammu / Srinagar on or before last date fixed by Board for filling up of online application forms.
- Mere submission of the Application Form and appearance of the aspiring candidate in the Entrance Test shall not confer any preferential right/claim for admission upon the intending applicants, but shall be subject to the fulfillment of the eligibility criteria and the qualification prescribed for the said course.

- Bids must be accompanied with cost of Tender document in shape of e-challan through Treasury indicating Treasury Voucher No. & date, e-NIT No. and name of work duly crediting to 0059 (Revenue) favoring Executive Engineer PWD (R&B) Division, Kishtwar uploading a copy of treasury challan and EMD/Bid Security in the shape of CDR/FDR (The date of Treasury Challan / Bid Security/Affidavits between date of start of bid submission and bid submission end date) duly pledged to Executive Engineer PWD (R&B) Division Kishtwar as mentioned in the bid documents. The earnest money of the unsuccessful bidder shall be released only after submission of Treasury Challan.
- The electronic bidding system would not allow any late submission of bids after due date and time as per server time. Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder need not make any additional payment towards the cost of tender document. For bid modification and consequential re-submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification / withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. No bid shall be modified or withdrawn after the deadline of submission of bids.
- The date and time of opening of Financial-Bids shall be notified on Web Site www.jktenders.gov.in and conveyed to the bidders automatically through an e-mail message on their e-mail address. The Financial-bids of Responsive bidders shall be opened online in the Office of Executive Engineer PWD (R&B) Division Kishtwar. The date for same shall be intimated separately.
- The bids for the work shall remain valid for a period of 120 days from the date of opening of Technical bids.
- The bidder shall be disqualified from bidding for any contract with this office for a period of 03 Years from the date of notification, if :
a) Any bidder/tenderer withdraws his bid/tender during the period of bid validity or makes any modifications in the terms and conditions of the bid.
b) Failure of Successful bidder to furnish the required performance security within specified time period after issue of letter of acceptance.
- Instruction to bidders regarding e-tendering process.**
Bidders are advised to download bid submission manual from the "Downloads" option as well as from "Bidders Manual Kit" on website www.jktenders.gov.in to acquaint bid submission process.
a) To participate in bidding process, bidders have to get 'Digital Signature Certificate (DSC)' as per Information Technology Act-2000. Bidders can get digital certificate from any approved vendors.
b) The bidders have to submit their bids online in electronic format with digital Signature. No financial bid will be accepted in physical form.
c) Bids will be opened online as per time schedule mentioned above.
d) Bidders must ensure to upload scanned copy of all necessary documents mentioned in NIT and SBD with technical bid online.
- Note:- Scan all the documents on 100 dpi with black and white option.**
- The department will not be responsible for delay in online submission due to any reasons.
- Scanned copy of cost of tender document in shape of e-challan through Treasury indicating Treasury Voucher No. & date, e-NIT No. and name of work duly crediting to 0059 (Revenue) favoring Executive Engineer PWD (R&B) Division, Kishtwar uploading a copy of treasury challan and EMD/Bid Security in the shape of CDR/FDR (The date of Treasury Challan / Bid Security/Affidavits between date of start of bid submission and bid submission end date) duly pledged to Executive Engineer PWD (R&B) Division Kishtwar.
- Bidders may contact office of the Chief Engineer-PW (R&B) Department, Jammu or concerned Executive Engineer for any guidance for getting DSC or any other relevant details in respect of e-tendering process.
- Bidders are advised not to make any change in BOQ (Bill of Quantities) contents. In no case they should attempt to create similar BOQ manually. The BOQ downloaded should be used for filling the item rate inclusive of all taxes and it should be saved with the same name as it contains.
- The unit rates and prices shall be quoted by the bidder entirely in Indian Rupees and the rates quoted shall be deemed to include price escalation and all taxes up to completion of the work unless otherwise specified.**
- Bidders are advised to use "My Documents" area in their user on R&B e-Tendering portal to store such documents as are required.
- Defect Liability Period:** The DLP shall be calculated from the date of certified completion of work and shall be 12 Months.
- No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without permission of the Government. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's Service.
- The key construction materials like Cement, Tor Steel, Bitumen of required grade from refineries as per Circular of MORT & E H dated August 24, 2018 shall be arranged/purchased by the Contractor / Firm on his own for the above said work and the quality of these materials arranged/purchased by the Contractor/Firm shall have to be verified/checked by Engineer Incharge before start of the work and during the currency of the work. The approved brands of Cement/Tor Steel are as under:-
i/ Cement of Ambuja, ACC, Birla Plus, Ultratech or equivalent brand manufactured on Major Plant as approved by the concerned Asstt. Executive Engineer.
ii/ Tor steel of SAIL, TATA TISCO, Jindal Panther & Rashtriya Ispat.
- Bids from Joint Venture are not allowed.
- Performance Security.**
- Within 07 (seven) days** after the date of receipt of the Letter of Acceptance, the successful bidder / contractor shall deliver to the Employer/concerned authority, a **Performance Security in any of the required forms for an amount equivalent to 3% of value of contract plus additional performance security** in the shape of CDR/FDR/BG for the unbalanced bid in terms of clause 7 of ITB.
- If the Performance Security is provided by the successful bidder in the form of a bank guarantee, it shall be issued by either (a) at the Bidder's option, by a Nationalized / Scheduled Indian Bank or (b) by a foreign bank located in India and acceptable to the Employer.
- Failure of the successful bidder to comply with the requirements of Sub-Clause 17.1 of e-NIT shall constitute sufficient grounds for cancellation of the award.
- The Performance Security shall be provided to the Employer not later than the date specified in the Letter of Acceptance and shall be issued in an amount and form and by a bank or surety acceptable to the Employer, and denominated in Indian Rupees. The performance Security shall be valid until a date 28 days from the date of expiry of Defects Liability Period.
- As per Chief Engineer PW (R&B) Department Jammu's Circular No. CEJ/PS/M/19 dated 22-09-2020, no bidder will be allowed to withdraw his bid once he participated in the tendering process what so ever case may be.
- Any damage caused to the private/public property during execution of works shall be in the liability of the contractor and no claim on account of any such restoration to be carried by the contractor shall be entertained by the Department.
- If the contractor fails to start the work within the time mentioned in the award of contract, the contract will automatically stand cancelled after forfeiting the performance security of the contract.
- That the payment is restricted to the contract cost only and will be subject to the condition that no cost overrun of any kind is to be paid unless and until approved from the competent authority.
- The Performance Security Deposit (3% of the Advertised Cost of the tender) from all the bidders in the shape of CDR/FDR before evaluation of technical bids. The Performance Security of successful bidder shall be released after completion of the Defect Liability Period of one year.
