Whereas, land measuring 189 Kanals 13 Marlas (local) situated at village Shajroo, Tehsil Mahore, District Reasi is required for public purpose namely Construction of Budhal-Mahore-Gool GREF Road; and

Whereas, on the recommendation of Collector Land Acquisition (Sub Divisional Magistrate) Mahore vide No.SDM/M/2022-23/42-45 dated 06-04-2022, sanction was accorded vide No.DC/Rsi/SQ/22-23/976-80 dated 19-05-2022 for land measuring 189 Kanals 12 Marlas (local) for exemption from undertaking Social Impact Assessment Study u/s 9 by invoking urgency clause under section 40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013; and

Whereas, Collector Land Acquisition (Sub Divisional Magistrate) Mahore vide No. CLA/SDM/M/2022-23/160-174 dated 08-06-2022 issued preliminary notification u/s 11(1) of Right to Fair Compensation & Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for calling upon the objections, if any, from the interested persons/ land owners within stipulated time period from the date of issuance/ publication of the said notice ; and

Whereas, in response to said notification, 15 objections were received from the land owners/interested person in the collectorate of Sub Divisional Magistrate Mahore and the same have been disposed of. In the instant case, no family will be affected due to acquisition of subject quantum of land and hence no rehabilitation and resettlement scheme is required under section 16 of the Act. Now the actual quantum of land to be acquired is 189 Kanals 13 Marlas instead of 189 Kanals 12 Marlas; and

Whereas, as per S.O. No.17 dated 14-01-2022 issued by Government of Jammu and Kashmir, Revenue Department, the appropriate Government as defined under Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 shall be Deputy Commissioner upto 400 Kanals (50 acre) ; and

Whereas, as per section 19 (1) of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the appropriate Government is satisfied that the land is required for public purpose viz. Construction of Budhal-Mahore-Gool GREF Road; and

Now, therefore, declaration u/s 19 (1) of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 is hereby accorded for Acquisition of land measuring 189 Kanals 13 Marlas (local) situated at village Shajroo, Tehsil Mahore, District Reasi for public purpose viz. construction of Budhal-Mahore-Gool GREF Road.
