- (v) The candidates appearing/appeared in 10+2 (12th Class) examination 2023 can also apply, provided such candidates have to qualify 12th Class examination on or before the date of declaration of the result of the Common Entrance Test /or on or before the date of counseling, as may be notified by the Board, otherwise their candidature shall be cancelled ab-initio.

B. GNM Course:

- (ii) be 17 years old and not more than 35 years of age as on 31-12-2023.
- (iii) have passed 10+2 or equivalent examination from a recognized Board with Science/Arts and English securing minimum aggregate 40% marks for Open Merit Candidates and 35% marks for Reserved Category candidates;
- (iv) have passed 10+2 with English having 40% marks in Vocational ANM course from Schools recognized by INC/Vocational stream in Health Care Science from a recognized CBSE Board/Centre;
- (v) be a Registered ANM with pass marks;
- (vi) be medically fit;
- (vii) The candidates appearing/appeared in 10+2 (12th Class) examination 2023 can also apply, provided such candidates have to qualify 12th class examination on or before the date of declaration of the result of the Common Entrance Test / or on or before the date of counseling as may be notified by the Board, otherwise their candidature shall be cancelled ab-initio;

C. ANM Course:

A candidate must:

- (iii) have passed 10+2 or equivalent examination from a recognized Board with Science/Arts and English securing minimum 40 % marks in aggregate;
- (iv) be medically fit.
- (v) have qualified in 10+2 Arts or Science examination conducted by National Institute of Open School can also apply.
- (vi) The candidates appearing/appeared in 10+2 (12th Class) examination 2023 can also apply, provided such candidates have to qualify the 12th class examination on or before the time of declaration of the result of the Common Entrance Test / or on or before the date of counseling as may be notified by the Board, otherwise their candidature shall be cancelled.

D. Medical Record Technician Course in SKIMS Soura, Srinagar:
