On the modus operandi, he said that the terrorists first did recce of area, understood the terrain and considered aspects like speed of the vehicle to come down to zero in view of downhill terrains and sharp turn at the place of attack.

"They came close and ambushed the vehicle. Then they fired on the vehicle which got damaged. The troops got injured. They planted an IED, set it afire and exploded it," he

Singh said there is floating population of terrorists coming from Pakistan.

"They remain here for several months. They do recce and such acts. We have neutralised several of them also in the past. Two to four such terrorists remain active during a period of time," he said

According to Singh there are 10 to 12 such elements operating in the area

"The terrorists come better prepared for such attacks," he said.

DGP during his visit took stock of the prevailing security situation of the District particularly the infiltration attempts, Narco trade and drone activities from across the border. He also visited the Darhal area in the outskirts of the District.

The CBI registered two FIRs in connection with the corruption allegations levelled by Malik in awarding contracts for a group medical insurance scheme for government employees and civil work worth Rs 2,200 crore related to the Kiru hydroelectric power project in Jammu and Kashmir.

Malik had claimed that he was offered a Rs 300 crore bribe for clearing two files during his tenure as the Jammu and Kashmir governor between August 23, 2018, and October

The agency has booked Reliance General Insurance and Trinity Re-Insurance Brokers Limited as accused in its FIR related to the medical insurance scheme for Jammu and Kashmir government employees reportedly cleared by Malik at a state administrative council meeting on August 31, 2018. The scheme was subsequently scrapped.

Unknown officials of the finance department of the government of Jammu and Kashmir, by abusing their official positions in a conspiracy and connivance with Trinity Reinsurance Brokers Limited, Reliance General Insurance Company Limited and other unknown public servants and private persons, have committed the offences of criminal conspiracy and criminal misconduct," one of the FIRs allege.

They caused "pecuniary advantage to themselves and wrongful loss to the state exchequer during the period 2017 and 2018 and thereby, in this manner, cheated the government of Jammu and Kashmir", it further alleges.

In the second FIR about alleged malpractices in the awarding of contracts for the civil work package of the Kiru hydroelectric power project, the CBI alleged that the guidelines related to e-tendering were not followed.

"The case was registered on allegations of malpractices in the award of the contract worth Rs 2,200 crore (approximately) of civil works of the Kiru Hydro Electric Power Project (HEP) to a private company in the year 2019." it has said.

The probe agency has booked senior IAS officer Navin Kumar Chaudhary, former chairman of Chenab Valley Power Projects (Private) Limited, M S Babu, former managing director, M K Mittal and Arun Kumar Mishra, former directors, and Patel Engineering Limited.

"Though a decision was taken in the 47th board meeting of CVPPL (Chenab Valley Power Projects Limited) for re-tender through e-tendering with the reverse auction after the cancellation of the ongoing tendering process, the same was not implemented (as per the decision taken in the 48th board meeting) and the tender was finally awarded to Patel Engineering Limited," the FIR alleged.

On the other hand, India's rich art and cultural heritage has mesmerised around 12,000 people who have visited the country (so far for various G20 meetings).

"And when I say this sitting here in Leh, you can well understand why this place was chosen for the Y20 Pre-Summit. Ladakh and Leh have left the youth mesmerised. All the delegates I met and interacted with here from G20 countries were spellbound by the beauty of Ladakh, its monasteries, river, culture...they say they will return with their families and friends." He added that when the world talks about the future of youth, democracy and governance, there can be no better place than India to be hosting the G20.

"The Y20 Pre-Summit is progressing in the right direction and if I speak about the topics...when we speak about shared future, youth, democracy and governance, there is no better example than India. The country has the biggest youth population, the startup ecosystem, the entrepreneurship, Indians being at the helm of some of the biggest companies in the world," said Thakur.

the sovereignty and territorial integrity of all member states under a regional framework for cooperation came amid the three-year border row between India and China.

The Pakistani defence minister did not participate in the Shanghai Cooperation Organisation (SCO) conclave and Special Assistant to Pakistan prime minister on defence affairs Malik Ahmed Khan joined the deliberations virtually.

Highlighting the threat of terrorism, Singh called upon SCO nations to collectively work towards eliminating it in all its forms and fix accountability on its supporters.

Any kind of terrorist act or support to it in any form is a major crime against humanity and peace and prosperity cannot coexist with this menace, Singh asserted while stressing the need to contain terrorism effectively.

"If a nation shelters terrorists, it not only poses a threat to others but to itself too. The radicalisation of youth is a cause of concern not only from the point of view of security, but it is also a major obstacle in the path of socio-economic progress of society," Singh said.

"If we want to make the SCO a stronger and more credible international organisation our topmost priority should be to effectively deal with terrorism," he added.

Defence Secretary Giridhar Aramane told reporters that all the member nations arrived at a consensus on several areas of cooperation, including dealing with terrorism, and the security of vulnerable populations in various countries.

He stated that all member states were unanimous in their statements that terrorism, in all its forms, must be condemned and eliminated.

Sharing his insights on the vision to ensure collective prosperity, Singh, in his address called for concerted efforts by the SCO member states so that the region, with limitless possibilities in today's multilateral world, shifts to the mindset of 'great gain from win-win par adigm' from 'great game of zero-sum, win-lose paradigm'.

"India has always followed the principle of 'Let us walk together and move forward together'. Every era has a zeitgeist (defining idea). The zeitgeist of the present era is 'winwin cooperation for the great gain'," he said. At the end of the deliberations, all the SCO member countries signed a protocol, expressing their collective will to make the region secure, peaceful and prosperous. Singh also voiced India's commitment towards defence capacity building of SCO member states through training and co-manufacturing and codevelopment of items. He stated that as security challenges are not limited to any one country, India is moving forward with a collaborative approach in the field of defence partner ship, keeping in mind the shared interests. The defence minister also highlighted the concept of 'SECURE' floated by Prime Minister Narendra Modi during the SCO summit in China in 2018. He said that every alphabet of the word 'SECURE' reflects India's commitment towards the multi-dimensional welfare of the region. Elaborating on it he said S stands for security of citizens, E for economic development for all, C for connecting the region, U for uniting the people, R for respect for sovereignty and Integrity and E stands for environmental protection.

The Rutherford Appleton Laboratory (RAL) is one of the national scientific research laboratories in the UK operated by the Science and Technology Facilities Council.

In addition to hosting facilities for the UK, RAL also operates departments to coordinate the UK programme of participation in major international facilities. The largest of these are the areas of particle physics and space science. The site hosts some of the UK's major scientific facilities, including the ISIS

Neutron and Muon Source, a spallation neutron source, the Central Laser Facility, the Diamond Light Source synchrotron. Singh said India's Department of Science and Technology (DST) has a major collaborative project under the Nano Mission, which enabled Indian researchers to pur-
