6. The contractor should install fixed wedge V shape snow plough for Backhoe Loader cum Excavator during the Snow clearance operation without any additional charge from the Department.
7. Since the quantum of stage work is not predictable, AAA and Technical sanction for the works shall be taken before payment in the best interest of Govt. works.
8. In view of upcoming parliamentary Elections, the connectivity has to be maintained for smooth conduct of elections.
