CRIME REPORT

Passenger vehicle seized for traffic violations

DODA: Continuing its drive against the traffic violators, Doda Police has seized a vehicle for its involvement in violation of traffic laws in Gandoh area.

Giving details, Doda Police said that one the basis of reliable information to the effect that one vehicle Sumo bearing registration No. JK02AG-6619 being driven by driver namely Tousif Ahmed son of Syed Ahmed resident of Trankal Tehsil Kahara was on way from Gandoh towards Kahara in a rash and negligent manner; thus putting the vehicle /travelers travelling in the area in high risk besides endangering the life of passengers. Acting swiftly on the information, a police party of Police Station Gandoh under the supervision of Inspector Parvaiz Ahmed Khanday SHO PS Gandoh seized the vehicle and while conducting checking, the vehicle was found overloaded beyond the seating capacity.

In this connection, case FIR No. 28/2024 under relevant section of law has been registered in Police Station Gandoh and investigation started up.

Narcotic smuggling bids foiled, 4 held with Charas, Ganja

RAMBAN/REASI: In a decisive move against narcotics smuggling, Ramban Police, under Operation Sanjeevani and the astute guidance of SSP Ramban Anuj Kumar, thwarted a narcotics smuggling attempt in Ramban area, apprehending one individual with a significant quantity of Charas-like substance.

A reliable sources alerted Police Station Ramban about the illicit activities of Mohd Younis, suspected of being involved in the illegal smuggling of Chars, a narcotic contraband substance. Mohd Younis, a resident of Ward No. 01 Ramban, Tehsil, and District Ramban, was reportedly in possession of Charas and was traveling in an auto-load carrier with registration number JK19-2133 (Blue Colour) from Ward No. 1 Ramban.

Acting swiftly, a case under FIR No. 78/2024 U/S 8/20 NDPS Act was registered, and PSI Shiv Dutt was assigned the investigation. Upon receiving the information, a police team established a checkpoint along with a Magistrate and intercepted Mohd Younis. Subsequently, 115 grams of Charas-like substance were recovered from Mohd Younis Sheikh, son of Abdul Salam Sheikh, residing in Ward No. 1 Ramban.

The accused has been apprehended, and the contraband has been seized. Investigations are underway to uncover any connections or networks associated with this illegal activity.

The arrest and seizure were executed by Police team of PS Ramban under the guidance of SHO Ramban under the supervision of Dy.Sp Hq Ramban, Adl. SP Ramban and under the overall supervision of SSP Ramban.

Meanwhile, Police team of Police Station Katra received an information that one person namely Liaquat Ali, son of Mohd Kala, resident of Chak Bhagtha, Katra who is already involved in sale/purchase of Charas & Ganja and at this time he along with other 2 persons were consuming and also have possession of Charas & Ganja like substance in an abundant shed at Nomain near Peer baba.

On this information, Police party of Police Station Katra alongwith EMIC Katra raided the spot and recovered (1) 82 grams of ganja & 34 grams of Charas from the possession of Deepesh Pal, son of Ranveer Singh, resident of Kashganj, U.P at present Matyal, Katra, 51 grams of Ganja & 16 grams of Charas from the possession of

Liaquat Ali, son of Mohd Kala, resident of Chak Bhagtha Katra and 50 grams of Ganja & 16 grams of Charas from the possession of Sanju Kumar, son of Rashid Kumar, resident of Landar, Panchari, District Udhampur. In this regard, a case FIR No. FIR No.65/2024 under section 8/21/22 NDPS Act was registered at Police Station Katra and investigation is ongoing to unearth backward and forward linkage. The whole operation was led by SHO P/S Katra Inspr. Nishant Gupta under the supervision of SDPO Katra Surinder Singh Baloria.

Police reunites missing persons with families

SAMBHA/REASI: Samba Police has reunited a missing person with his family whose missing report was lodged at Police Station Vijaypur.

On April 10, 2024, a written report was lodged at Police Station Vijaypur by the father of missing Person namely Prem Singh, son of Pritam Singh, a resident of Gagore, Vijaypur stating therein that his son went to the market and did not return. All efforts were made out by the family members but the whereabouts of the missing person could not be ascertained.

Acting on complaint, a missing report was entered at Police Station Vijaypur and search started to trace out the said missing person.

Police team raided at different locations and recovered the missing women. After completing all the legal formalities the missing women reunited with her family. All family, relatives & community people expressed gratitude to Police for sincere efforts in searching & recovering the missing women.

2 terrorist associates booked under PSA

SOPORE: Police in Sopore have booked two terrorist associates under Public Safety Act in Sopore.

4 drug peddlers arrested; contraband substances recovered

SRINAGAR: Continuing its efforts to eradicate the menace of drugs from the society, Police have arrested 04 drug peddlers in Baramulla, Kulgam & Spore and recovered contraband substances from their possession.

During his personal search, 700 grams of Charas was recovered from his possession. He has been arrested and shifted to PS Kulgam where he remains in custody.

Meanwhile in Sopore, a Police party of Police Station Bomai, at a checkpoint established at Zonipora Crossing, Tujjer Shareef, arrested a drug peddler identified as Irfan Ahmad Pir @Bit Pir son of Mohammad Sultan Pir resident of Tujjer Shareef Sopore. During search, 560 grams of Charas was recovered from his possession. He has been arrested and shifted to police station where he remains in custody. Accordingly, cases under relevant sections of law have been registered at respective police stations and investigations have been initiated.

We urge the common masses that if you witness drug peddling or any other crime anywhere near you, feel free to contact nearest police establishment or dial 112. People are requested to cooperate with police in curbing the menace of drugs from the society. We reassure the community members that police will act tough against the criminals as per law.
