

# SC/ST Atrocities Act can't be misused to cause harassment to individuals of other communities: Rajesh

JAMMU: Bahujan Samaj (BSP) General Party Secretary and Media head, Rajesh Gupta on Saturday said SC/ST Atrocities Act was enacted with the aim of providing protection to the Schedule Caste Schedule Tribe community from social disabilities.

The same provisions which have been laid down to cure the atrocities of the SC/ST community cannot be misused to cause harassment to individuals of other communities, Gupta added.

BSP leader referred the Supreme Court judgement dated 20 March 2018 says, "The anti-atrocities law, which protects Scheduled Castes and Scheduled Tribes from casteist slurs and discrimination, has become an instrument to "blackmail" innocent citizens and public servants."

Besides this precaution, a preliminary inquiry should be conducted before the FIR is registered to check whether the case falls within the parameters of the Atrocities Act and if it is frivolous or motivated.

"Innocent citizens are termed accused, which is not intended by the legislature. The legislature never intended to use the Atrocities Act as an instrument to blackmail or to wreak personal vengeance,

Supreme observed.

Instead of blurring caste lines, the Act has been misused to file false complaints to promote caste hatred, the apex court said. The current working Atrocities Act may even "perpetuate casteism" if it is not brought in line and the court needs to intervene to check the "false implication of innocent citizens on

"The Act cannot be converted into a charter for exploitation or oppression by any unscrupulous person or by the police for extraneous reasons against other citizens. Any harassment of an innocent citizen, irrespective of caste or religion, is against the guarantee of the Constitution. This court must enforce such a guarantee. Law should not result in caste hatred," the Supreme Court held.

## 3 drug peddlers arrested; Contraband substances recovered

HANDWARA: Continuing its efforts to eradicate the menace of drugs from society,

Police have arrested 02 drug peddlers in Handwara and recovered contraband substances from their possession. A police party of Police Post Magam led

by Incharge PP Magam under the supervion of SDPO Handwara and SHO PS Handwara intercepted a vehicle (Tata sumo) bearing Reg No. JK09-4301 at Khanpora Crossing with 02 persons on board. They have been identified as Irshad Ahmad lone (Driver) son of Ab Gani lone resident of Taratpura and Shabir Ahmad Marazi son of Gh Rasool Marazi resident of Summer Bug Lasjan Srinagar. During search of the vehicle, about 106 grams of charas like contraband substance was recovered from their possession. They have been arrested and shifted to police station where they remain in custody. Vehicle used in the commission of crime has also been



Accordingly, a case under relevant sections of law has been registered at Police Station Handwara and investigation has been initiated.

Meanwhile, A police party of Police Station Qazigund at a checkpoint established at Shampora crossing, intercepted a suspicious person carrying a nylon bag. During search, officers were able to recover 2.5 Kgs of Poppy Straw like contraband substance filled in the said bag from his possession. He has been identified as Arbaaz Ahmad Lone son of Shabir Ahmad lone resident of Qazigund. He has been arrested and shifted to police station where he remains in custody.

Accordingly, a case vide FIR number 107/2024 under relevant sections of law stands registered in Police Station Qazigund and investigation has been initiated.

#### 2 bovine smugglers arrested, 14 bovines rescued STATE TIMES NEWS

SAMBA: Continuing its drive against bovine smugglers and their propagators, Samba Police foiled two bovine smuggling attempts in the jurisdiction of Police Station Samba, arrested two bovine smugglers and rescued fourteen bovines.

Acting on reliable information regarding smuggling of bovines near Bindu Paida Mansar, a police party of Police Post Mansar headed by Incharge PP Mansar has successfully foiled bovine smuggling attempt and rescued seven bovines which were being smuggled by foot in a very cruel manner from Samba side towards Kashmir valley. The arrested bovine smuggler has been identified as Anzar, son of Noor Hussain, resident of Kokernag, district Anantnag.

A case FIR No.96/2024 U/S 188 IPC, 11 PCA Act has been registered at Police Station Samba and investigation started.

In another incident of bovine smuggling, a police party of Police Post Goran headed by Incharge Police Post Goran has successfully foiled bovine smuggling attempt near Dhaki road Sumb, arrested bovine smuggler and rescued seven bovines which vere being smuggled by foot.

# Heroin smuggling case along LoC: Subsequent recoveries of Narcotics and Seizures of conveyances

RAJOURI: Carrying forward further investigations and working on further leads in FIR No.36/24 U/S 8/21/23 NDPS Act in Police Station Nowshera on 10th of April in which police recovered 8.5 KG heroine, Rajouri Police made subsequent recoveries of Heroine like narcotic substance weighing 1.44 KGs

During investigation, Police team headed by SDPO Nowshera Jaswant Singh and SHO PS Nowshera Sumit Magotra under the supervision of SSP Rajouri AmritPal Singh IPS, carried out extensive search operations and arrested three accused persons namely Naveen Kumar son of Moti Ram, Sukhvinder son of Babu Ram and Davinder alias Munna son of Rajesh Kumar, all residents of village Makri.

Notably, each of the arrested accused persons admitted their involvement in commission of crime during sustained questioning. Worth to mention, multiple subsequent recoveries of heroin like narcotics weighing as much as 1.44 kgs were made by the investigation officer, who happens to be SHO PS Nowshera. The total recovery made in the instant case is 9.98 Kgs till now. Mentionable that during preliminary investigation it came to fore that three vehicles, Dumper bearing regd. number JK11G 8174, Motorcycle bearing regd. number JK11C 3442 and Load Carrier (Mini Goods carrier vehicle) bearing regd. number JK11C 9644 were used as conveyance in commission of crime. Police has seized these vehicles in instant case.

Further investigation in case is going on and all forward and backward linkages

shall be identified and dealt strictly within the ambit of law. SSP Rajouri Amrit Pal Singh while sharing the details conveyed that Rajouri Police is working on multipronged strategy to deal with the problem of drug abuse, on one hand awareness programs are being organized in every nook and corner of the district and on the other hand drug peddlers are being booked under PITNDPS Act on regular basis. SSP Rajouri while giving tough message for drug peddlers added that there is no space for Drug Peddlers in Rajouri District. Drug peddlers should shun the path of spoiling our generation and must return to mainstream otherwise they will be dealt with Iron hand.

### Ganderbal and handed over to police station Janipur for further investigation. IED found in Rajouri, destroyed in controlled explosion

RAJOURI: An improvised explosive device fitted inside a mobile phone box was detected and subsequently destroyed in a controlled explosion in Rajouri district of Jammu and Kashmir on Saturday, officials said.

Weighing around 700 grams, the explosive was found in Draj village in the upper reaches of Budhal by police acting on leads gathered during an ongoing investigation in a terror-related case, they said. On April 2, Director General of Police R R Swain announced the busting of a module of the Lashkar-e-Taiba (LeT) in the twin border districts of Rajouri and Poonch and said three out of its seven identified members were arrested.

Swain said the module was involved in receiving and distributing arms, ammunition, explosives, cash and narcotics dropped by drones from across the border. A bomb disposal squad accompanying the police party destroyed the IED on the spot the officials said.
