

DEO Jammu reviews preparations for polling day

JAMMU: District Election Officer (DEO), Sachin Kumar Vaishya, who is the Returning Officer for 5-Jammu Parliamentary Constituency, on Friday convened a meeting with AROs, Nodal Officers and district officers to rally efforts for smooth conduct of polling in the Constituency scheduled on April 26, under the

2nd phase of Lok Sabha Elections-2024. The meeting delved significant focus on SVEEP activities, stressing the need to engage people from all walks of life and sections of society. Key discussions revolved around preparations for the dispatch and reception of EVMs and poll parties, as well as the provision of facilities in accordance with ECI guidelines, including medical

facilities. Special arrangements for Green Polling Stations, Model Polling Stations and all Women Polling Stations were meticulously reviewed to ensure seamless operations on polling day. Deliberations also centred on postal ballots and voting arrangements for service voters and essential service employees, with a strong emphasis on meticulous implementation.

All attending officers were briefed on their critical roles in the massive electoral exercise, underscoring the collective responsibility towards ensuring free, fair, and transparent elections. The meeting was also attended by ADDC Sher Singh, ADC Shishir Gupta, Deputy DEO Rameshwar Kumar, along with district officers and senior officers from line departments.

The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential- submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. In case the original documents are not submitted by the Lowest Bidder (L-1) within 07 (Seven) days after opening of financial bid, the tender of lowest bidder will be rejected and the lowest bidder (L-1) will not be allowed to participate in any further/future tendering process in the Divisional office for a period of two years. The work can be offered to L-2 after necessary approvals etc. from competent authority.
- The complete bidding process shall be online from 18.04.2024 to 06.05.2024 04.00 PM and shall be opened on 07.06.2024 at 3.00 PM or on any convenient date in the office of Executive Engineer JAL SHAKTI (PHE) City Division No.II Jammu. In case office happens to be closed on the date of opening of the bids due to holiday, bids shall be opened on the next working day or any other date convenient to the tender opening authority, particularly keeping in view the ongoing restrictions on account of COVID-19.
- If any bidder quotes rates below than 25%, any item of the advertised cost his bids shall be rejected.
- The performance security shall be forfeited, if any bidder withdraws his onlinebid/tender during the period of bid validity or fails to start the work within stipulated period.
- No Engineer of Gazettedrank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without permission of the Government. The contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as foresaid before submission of the tender or engagement in the Contractor's Service.
- The contractor or intending bidder are advised to understand the nature of job advertised in E NIT. He may contact this office for any further discussion in case of a doubt.
- If any, typographical error/ omission in respect of rate/ unit is found in the E NIT it shall be corrected as per sanctioned schedule of rates 2022.
- Any item other than the advertised, required to be executed at site, shall be allowed to be executed by the contractor at par with the SSR 2022 Rates.
- The work identified for execution shall to be started within 07 days from the date of allotment. Delay in completion of particular work within the stipulated period shall attract a penalty of upto 10% of the contract value for delay upto one month and @ 20% for the period exceeding one month shall be imposed upon the concerned contractor
- The accepting authority reserves the right of accepting or rejecting any or all e-tenders without assigning any reason.
- Nothing extra shall be paid on the negotiated rates.
- In case contractor fails to take up/ complete emergent/ urgent works in time, the same shall be got executed at the risk and cost of the contractor and the allotment may be terminated without any notice besides, the CDR shall be forfeited. Any additional amount involved for execution of work shall be recovered from the contractor.
- The bids of responsive bidders shall be opened on the specified date or any other days convenient to the tender opening authority in the office of Executive Engineer JAL SHAKTI (PHE) City Division NO.II Jammu .
- The bidders are instructed to read the BOQ carefully , any items showing blank cells in the column of rates shall be treated as rates to be quoted . The bidder should accordingly bid rates for all the items.(unbalanced bids shall be rejected). Moreover, nothing extra than the advertised items shall be paid instruction to the bidder regarding e-tendering process.


