In case contractor fails to take up/ complete emergent/ urgent works in time ,the same shall be got executed at the risk and cost of the contractor and the allotment may be terminated without any notice besides, the CDR shall be forfeited. Any additional amount involved for execution of work shall be recovered from the contractor.
