Delving into the complex world situation, Singh said it affects everyone globaly. "Unconventional and asymmetric warfare, including hybrid war, will be part of the future conventional wars. Cyber, information, communication, trade and finance have all become an inseparable part of future conflicts," he said.

"This necessitates that the armed forces will have to keep all these facets in consideration while planning and formulating strategies," the defence minister said. He highlighted the stellar role played by the Army in guarding the country's porders and fighting terrorism, apart from providing assistance to the civil administration in every need of the hour.

"The Army is present in every domain, from security, HADR (humanitarian assistance and disaster relief), medical assistance to maintaining the stable internal situation in the country," he said.

"The role of the Indian Army is very important in nation building as also in the overall national development," he noted.

The defence minister complimented the leadership of the Army for successfully taking ahead the country's "defence and security" vision to new heights.

He also hailed the Army's approach on the infusion and absorption of cuttingedge technology.

Singh paid tributes to all bravehearts who made the ultimate sacrifice in the defence of the motherland.

The Army Commanders' Conference is an apex-level biannual event that is held in April and October every year. The conference is an institutional platform for conceptual-level deliberations, culminating in making important policy decisions for the Army.

The commanders comprehensively deliberated upon all aspects of the existing security scenarios, the situation along the borders and the hinterland and the challenges for the present security apparatus.

In addition, the conference also focused on issues related to organisational restructuring, logistics, administration, human resource management, modernisation through indigenisation, induction of niche technologies and the assessment of the impact of various existing global situations.

In his address, Singh appreciated the Army's efforts to develop niche technologies in collaboration with civil industries and thereby progressing towards the aim of 'modernisation through Indigenisation'.

"The nation is proud of its Army and the government is committed to facilitatng the Army in their forward movement, on the road to reforms and capability modernisation," he said.

The defence minister emphasised that a regular interface of armed forces with emerging technologies is a must.

Singh concluded by saying that issues related to "defence diplomacy, indigenisation, information warfare, defence infrastructure and force modernisation should always be deliberated upon in such a forum."

The recommendations and suggestions made by the senior leadership in forums such as the Commanders Conference should be deliberated upon and be taken to a logical conclusion with midcourse review and modification if required, he said.

the money laundering case linked to the "scam", the Enforcement Directorate (ED) said the political party, which was the "major beneficiary" of the proceeds of the crime, has committed the offence through Kejriwal.

"Arvind Kejriwal, Chief Minister of NCT of Delhi, is the kingpin and key conspirator of the Delhi Excise Scam in collusion with Ministers of Delhi Govt. AAP leaders and other persons.. Arvind Kejriwal was directly involved in the formulation of the Excise Policy 2021-22.

"This policy was being drafted considering the favours to be granted to the South Group and was formed in collusion with Sh Vijay Nair, Manish Sisodia and members representatives of the South Group," said the response

The AAP has committed the offence of money laundering through Kejriwal and the offences thus are covered by section 70, PMLA 2002, it said.

"The Aam Aadmi Party (AAP) is the major beneficiary of the proceeds of crime generated in the Delhi Liquor Scam. Sh Arvind Kejriwal was and is not only the brain behind the AAP but also controls its major activities, he was also one of the founding members and was also involved in the decision making of the policy as evident from the statements of the witnesses," it added.

AAP MP Sanjay Singh gets bail

NEW DELHI: In a relief to AAP leader Sanjay Singh, the Supreme Court on Tuesday granted bail to him in the Delhi excise policy-linked money laundering case after the Enforcement Directorate conceded that it has no objec-

The grant of bail to the Rajya Sabha member is a reprieve to the beleaguered Aam Aadmi Party (AAP) in midst of Lok Sabha poll campaigning as two of its top leaders -- national convener and Delhi Chief Minister Arvind Kejriwal and former deputy chief minister Manish Sisodia -- are in jail in

Polling for the Lok Sabha polls will be held in seven phase between April 19 and June 1, and Delhi will vote on May 25. Counting of votes is schedaled for June 4

A bench of justices Sanjiv Khanna, Dipankar Datta and P B Varale ordered the release of Singh, who has been in jail for six months, observing that no money has been recovered from his possession and there is no trace

The bench ordered that the AAP leader can continue with his political activities but cannot make any statements with regard to the case. It said Singh will remain out on bail during the course of the entire trial

and that the terms and conditions for the bail will be fixed by the special

During the post-lunch session, Additional Solicitor General SV Raju, appearing for the Enforcement Directorate (ED), said he has taken instructions from the probe agency and it has no objections if Singh is enlarged on

"I am making the statement without going into the merits of the case and keeping all the rights and contentions open," he said.

Taking note of the statement, the bench ordered, "In the morning session ASG SV Raju was asked to obtain instructions. He states they have no objections if Sanjay Singh is released on bail in proceedings arising out of the FIR...In view of the statement made, we allow the present appeal and direct that Sanjay Singh be released on bail during pendency of trial on terms and conditions set by the trial court."

The bench said the concession of bail granted to Singh will not be treated as "precedent". Consequently this bail order may not be of much help to other ailed AAP leaders, including Kejriwal.

The bench clarified that the bail was granted to Singh on the concession granted by the ED and not on merits.

The top court was hearing Singh's plea challenging denial of bail by the Delhi High Court and an appeal challenging his arrest and remand in the monev laundering case.

The bench in the morning session had asked Raju to take instructions or whether the ED needed further custody of Singh. The bench told the ASG that apart from the statements there are no impli-

cations and the approver, Dinesh Arora, who initially did not implicate him has named him in the tenth statement. "No money has been recovered from his (Singh) possession and the Rs 2 erore bribe allegations can be tested in the trial. There is no trace of it

Maybe a lot of time has passed but all this can be examined in trial and tested in a witness box. He is in custody for six months," the bench said. It said if the court were to grant bail to Singh on merits, then it would have o give a prima facie finding that he has committed no offence, given the

mandate of Section 45 of the Prevention of Money Laundering Act (PMLA). "This might have ramifications on the trial," the bench told Raju. The ASG said he will respond to the submissions of Singh against his

arrest and remand in the post-lunch session. As soon as the bench assembled in the post-lunch session, Raju at the outset said the ED has no objection to the grant of bail to Singh, provided it is not made a precedent.

During the hearing, senior advocate Abhishek Singhvi, appearing for Singh, said the AAP leader was arrested on the basis of approver Arora, who n the tenth statement recorded before the agency has named him.

While concluding his arguments on merit, he alleged that the ED had not objected to the bail of Arora after he had named Singh in his statement. Singh was arrested in the case by the ED on October 4 last year.

Before the high court, Singh had sought bail on the grounds that he has een in custody for more than three months and no role has been attributed o him in the predicate offence. The ED had in the high court opposed the bail plea and claimed that Singh

vas involved in acquiring, possessing, concealing, dissipating and using proceeds of the crime generated from the alleged Delhi liquor scam pertaining to the policy period of 2021-22. The agency had also claimed that the AAP leader had gained illegal money or kickbacks which are proceeds of crime generated from the alleged liquor

'Bad habits', countries should not comment on others' internal affairs: S Jaishankar

stern warning to the international community of Tuesday, External Affairs Minister S Jaishankar cautioned against unwar ranted political commentary on India's internal matters, stressing that any

such interference would be met with a "very strong reply." Jaishankar's remarks came in the wake of recent statements by envoys from the US Germany, and the United Nations regarding the arrest of Delhi Chief Minister Arvind Kejriwal by the Enforcement Directorate. India has vehemently protested these statements. "Somebody asked a person from the UN (about Kejriwal's arrest), and he

gave some reply. But in other cases, I would say very frankly these are old nabits, these are bad habits," Jaishankar told reporters here The Minister emphasised the importance of respecting the sovereignty of

nations and refraining from meddling in each other's domestic affairs. "There is a certain 'maryada' (restraint) among countries. We are sovereign

ountries, we should not be interfering in each other's internal affairs, we

should not be passing comments about each other's politics," he added. There are certain etiquettes, conventions and practices which must be followed in international relations, the minister said, adding that if a foreign country comments on India's politics, "they will get a very strong reply from

us, and that is what has happened." "...we sincerely urge all the countries in the world that by all means you have your views about the world, but no country has the right to comment or another country's politics especially in situations like this," Jaishankar said. The External Affairs Ministry last week had summoned a senior American liplomat to protest against the US state department's call for a fair legal process for the arrested Delhi chief minister. A similar protest was lodged

vith Germany. The External Affairs ministry had issued a strong statement, saying that in diplomacy, countries are expected to be respectful of the sovereignty and internal affairs of others. "This responsibility is even more so in case of felow democracies. It could otherwise end up setting unhealthy precedents".

During his interaction with the media here, Jaishankar also condemned China's actions in renaming places in Arunachal Pradesh as "senseless," reiterating that the northeastern state is an integral part of India.

In response to China's release of a fourth list of new names for locations in Arunachal Pradesh, Jaishankar reaffirmed India's unwavering stance on the region, emphasising that Arunachal Pradesh has always been and will remain an integral part of India.

"I want to be very clear that Arunachal Pradesh was, Arunachal Pradesh is, Arunachal Pradesh will always be India. I hope I am saying it so clearly that not only in the country but beyond the country also people get that mes sage very very clearly," he said. The MEA, earlier, averred in a statement that assigning invented names will not alter the reality that Arunachal Pradesh is, has been, and will always be an integral and inalienable part of

The minister further criticised Congress leader P Chidambaram for his remarks on the Katchatheevu island issue, asserting that the facts must be cknowledged, regardless of political affiliations.

In a tweet on X earlier, Chidambaram said any "untruthful and belligerent" statement by the Indian government about the island will bring the Sri Lankan government and 35 lakh Tamils into confrontation. Jaishankar did "somersault" on the issue, and once a liberal foreign service officer, he has become a mouthpiece of the RSS-BJP", the Congress leader said.
