Simpliforge sets world record with 3D Printed Structure in Himalayan Range

JAMMU: In a landmark achievement for India's defense infrastructure and construction technology, Simpliforge Creations, in collaboration with HT Hyderabad and the Indian Army, has successfully completed the world's highest on-site 3D printed protective military structure in Leh, at an altitude of 11,000 feet. Executed under Project PRABAL this feat sets a global benchmark in in-situ 3D construction printing under extreme high-altitude and low-oxygen (HALO)

The project was spearheaded by Arun Krishnan, a PhD student at IIT Hyderabad and Indian Army representative, under the academic mentorship of Prof. K.V.L. Subramaniam. Together with the technical team from Simpliforge Creations, they developed a cutting-edge 3D printing solution tailored to operate in severe environmental challenges such as low oxygen, high UV radiation, and thermal fluctuations.

The protective bunker was constructed using a form-optimized design and locally sourced materials, with a total printing time of just 14 hours. The entire project, including printer deployment and commissioning, was completed within five days-demonstrating the agility and efficiency of the technology. Simpliforge CEO Dhruv Gandhi highlighted the operational difficulties, stating that power systems and human performance were both affected by the low-oxygen environment, yet the team achieved the project goals on time.

One of the project's core innovations was the development of a custom-engineered concrete mix, specifically designed by HT Hyderabad's materials team. This mix had to maintain mechanical integrity and printability in an environment with low humidity and wide temperature variations. Extensive lab testing was conducted using local sand and aggregates to simulate high-altitude stresses, ensuring that the material would perform optimally on-site.

Arun Krishnan remarked that Project PRABAL originated during his M.Tech program, and despite prior attempts by various organizations, none had succeeded in overcoming Leh's extreme conditions-until now. This project underscores the strength of Make-in-India innovation, academic-industry synergy, and technological self-reliance, paving the way for rapid, on-demand military infrastructure in remote and hos-
