A combing operation is underway in the Kathua district of Jammu to track down three terrorists who escaped after a brief encounter with security forces late on Monday.

The joint operation of the Special Operations Group (SOG), army and the Central Reserve Police Force (CRPF), entered its tenth day on Tuesday.

On March 27, two terrorists were killed in an encounter in the district's Saniyal area in which four police personnel also lost their lives.

The terrorists were believed to be from a group that had its first face-off with the security forces in the Nursery area near the International Border on March 23. All of the terrorists had managed to escape

Four days later, security forces engaged them in an encounter in a forest area of the Sanival belt and eliminated two terrorists. The rest managed to flee. During this exchange of fire, four policemen were also killed and three injured.

With the terrorists changing their locations in the jungle, the security forces have aunched a multi-agency operation to track them down.

Meanwhile, Abdullah was asked if Shah's visit was a sign of an improved relationship between the Union Territory government and the Centre.

In reply, the chief minister said this was not the first time that the home minister vas visiting Jammu and Kashmir.

"He (Shah) has come here before and he will continue to come. When I was the chief minister of the (erstwhile) state, home ministers used to come here then as well. P Chidambaram and (Sushil Kumar) Shinde also came, so it is not a big deal,"

"These visits should continue, our talks with him (Shah) are on. He has tried to help Jammu and Kashmir in the last few months. Last year, we asked for some more money and we got that money. This time also, we are hoping that the Centre will

provide whatever help Jammu and Kashmir needs," Abdullah said. In response to a question about the Waqf (Amendment) Bill, he said MPs from his National Conference party would strongly oppose it.

"I have said this before that it will be difficult for people like us to accept this Bill. From this Bill, it seems that only one religion is being targeted. I have also said that every religion has its institutions and every religion has a charitable wing, and for as it is the Waqf," he said.

Abdullah, the National Conference vice-president, further said, "Targeting Waqf like this is very unfortunate because it seems that action is being taken only against our charitable process. It would be better if it does not happen. Now, it is up to Parliament. We cannot support this Bill. Our MPs will strongly oppose it."

The National Conference has two MPs in the Lok Sabha from Jammu and Kashmir.

by Ayushman Kotwal and Tejashwar Chib, who argued that the dredging activities were not intended for river maintenance or flood disaster management, as permitted under Clause 7 of Appendix IX of the EIA Notification, 2006.

Instead, it was alleged that the extracted material was being commercially utilized for road construction, violating environmental norms.

The applicant pointed out several irregularities in the ongoing dredging operations. One of the major concerns raised was the failure to notify the State Pollution Control Board (SPCB) before commencing dredging.

As per the Office Memorandum (OM) dated August 21, 2023, any such activity requires a 15-day prior notice to the SPCB, which was allegedly not given in this case. Additionally, it was noted that an official order dated February 13, 2024 (Annexure VII) recommended the disposal of 90,744 MT of extracted Nallah muck, raising concerns over whether the necessary environmental clearances were sought.

The applicant also submitted photographic evidence (Annexure VIII), showing large-scale dredging that suggested violations of environmental norms.

During tendering process, M/S Luman Engineers was found as L-l, however, instead of allotting works to L-1 firm, the then VC JDA Vinod Sharma deliberately and intentionally under a well knit conspiracy hatched with T.R Sargotra, the then Superintending Engineer, JDA (now expired) and Ashok Gandotra, the then Executive Engineer, JDA-1 to confer undue benefit to a particular firm M/S Ess Que furniture Works, approved the renovation/interior works including Air Conditioning of office complex at JDA office for a cost of Rs. 40.83 lakh.

The scope of work was changed from the installation of ACs/ Electrical works to renovation/interior works along with installation of ACs without any tendering process, which resulted into the increase in expenditure incurred in this regard.

The work was allotted on nomination basis to the above said firm without any justification as well as without any tendering in blatant violation of tendering process and requisite codal formalities.

Verification had further revealed that as per validity of license, the said firm was not authorized to execute electrical executed/completed the entire work of electrical/renovation/interior works at exorbitant rates in July-August-2011 for which payment amounting to Rs. 40.53 lakh was released in favour of M/S Ess Que Furniture Works. By acting in this manner, the then VC JDA Vinod Sharma, T.R Sargotra the then Superintending Engineer, JDA (now expired) and Ashok Gandotra, the then Executive Engineer JDA- 1 in league with each other and with the proprietor of beneficiary firm M/S Ess Que Furniture works, by abusing their official positions illegally and dishonestly conferred undue pecuniary advantage upon the proprietor of beneficiary firm M/S Ess que furniture

The Engineering Wing of ACB, as such projected a total loss of Rs. 2,12,295 on account of civil works so executed based on sanctioned scheduled rates (SSR) and against installation of 04 Nos ACs, make carrier cassette design concealed type 1.5 TR configuration\working on remote system, based on rates for the said ACs procarrier company. The loss to the state exchequer on account of electrical/renovation/interior works was estimated as Rs.2,12,295.
