# Modi's speeches on culture complied in book

NEW DELHI: From his 2015 Independence Day address in Delhi to the one delivered at an eye hospital opening last year in Varanasi, a set of 34 speeches made by Prime Minister Narendra Modi on a wide range of cultural subjects has now been complied in a book.

Titled 'Sanskriti Ka Paanchva Adhyay', the curated collection lays emphasis on Modi's addresses on Indian culture, traditions, spiritual values and heritage delivered on various occasions in the past 10 years.

The book was released on Friday Acharya Mahamandaleshwar Pujya Swami Avdheshanand Giri Maharaj, the head of the Juna Akhara, in the presence of Rajya Sabha Deputy Chairman Harivansh, at the Indira Gandhi National Centre for the Arts (IGNCA) here.

The compilation contains 34 speeches, arranged chronologically, beginning with his 2015 Independence Day address delivered from the ramparts

of the Red Fort in Delhi and the last

in the series, being his speech at the

inauguration of the R.J. Shankar Eve

Hospital in Varanasi on October These speeches cover a wide range of cultural contexts -- from sacred shrines like Kedarnath, Ram Janmabhoomi, Kashi Vishwanath Dham and Omkareshwar to occasions such as the launch of various editions of the 'Bhagavad Gita', Guru Nanak Jayanti, the Global Buddhist

Conference, the birth anniversary of

Maharaj and the World Sufi Conference, the IGNCA said.

The IGNCA is an autonomous institution under the Ministry of Culture. These speeches reflect a quest to

identify the Indianness in various religious traditions. The appendix contains reflections by Acharya Shri Pragya Sagar Ji Maharaj and Shankaracharya Shri Shankar Vijayendra Saraswati Swami Ji of Kanchi Kamakoti. Both appear to affirm the cultural vision espoused by the prime minister," it said in a state-

The Rajya Sabha deputy chairman in his address said the country is currently in 'Azadi ka Amrit Kaal' period.

"And the prime minster gave a resolve to make a 'Viksit Bharat' by the time we complete 100 years of our Independence. This dream of 'Viksit Bharat' was dreamt after 2014 and not dreamt before it." he added.

Rich material on taking pride on "our culture" is in this book, Harivansh said.

"After 2014, we have begun to speak about Indian culture and 'sanatan' values with pride, and that has been a big change. And, therefore, this book has greater significance," he said.

In his address, Harivansh referred to Ramdhari Singh Dinkar's seminal work 'Sanskriti ke Chaar Adhyay', whose foreword was written by then prime minister Jawaharlal Nehru.

Member Secretary, IGNCA, Sachchidanand Joshi highlighted the significance of the prime minister's oft-repeated maxim of 'Virasat bhi, Vikas bhi' (heritage as well as develop-

# No possibility of coming back to Himachal politics: Nadda

DHARAMSHALA: With the party expected to soon elect his successor, BJP chief J P Nadda on Sunday ruled out a return to Himchal Pradesh pol-

"I am in a responsible position and there is no possibility of coming back to the state, Nadda, who was elected BJP's national president in February 2020 and has been on an extension since his three-year term ended, said at a press conference here.

The BJP is in the process of picking the chiefs of several state units in the coming days to pave the way for the election of its national president, sources said earlier this week.

"Once the appointment is made in some of the states, the process for electing Nadda's replacement will begin soon," a

party leader had said. The state BJP president

would be elected soon, Nadda said while replying to a question on Sunday. He attacked the Himachal Government, alleging that it was the "most corrupt" among the Congress governments in the country.

Nadda claimed that the Congress government in the state has given advertisements worth crores of rupees to the National Herald which is not being published.

"Himachal Government is the most corrupt among the Congress governments in the

country and tops the list in financial mismanagement," he alleged. Nadda claimed that the Congress government led by Sukhvinder Singh Sukhu is trying to spread a false narrative that the Centre is not giving funds and is not concerned about the state.

"If you cannot run the government, then step down, but do not blame others," Nadda said and pointed out various initiatives taken by the BJP-led central governments for the state, including an "industrial package when A B Vajpayee was the prime minister".

### Kathua police attaches movable/immovable property worth 14.58 lakh of drug kingpin

BILLAWAR: As a part of its relentless effort against drug peddlers/smugglers, Police has executed attachment operation by PS Billawar resulting in the freezing / seizure of moveable property i:e scooty bearing Regd. No. JK08M-4244 worth rupees 80 thousand approximately and immovable

Shobit Saksena IPS under sections 68 A.2 (c), & E read with 68-F of the NDPS Act of 1985, dealing with provisions for attachment of properties of drug ped-

The drug Kingpin Rahul is presently in Judicial custody in case FIR No. 69/2023 U/S 8/21/22/29/ NDPS Act of Police Station Billawar and is also involved in multiple cases registered under NDPS Act at PS Billawar district Kathua which ncludes FIR 69/2023 U/S 8/21/22/29/ NDPS Act of Police Station Billawar; FIR 170/2024 U/S 8/21/22/ NDPS Act of Police station Billawar.

The Immovable property (Double storey building )and Moveable Property (scooty Activa) was identified as illegally acquired property during the course of investigation/inquiry conducted by the police with the help of transport and Revenue department. The properties was prima facie acquired from illicit trafficking in Narcotic Drugs and Psychotropic Substances by the drug peddler.

### Approx. 2000 litres of Lahan destroyed; Approx. 45 litres illicit liquor seized, one held

"This initiative is not just about addressing manpower gaps," Dr. Zargar added. "it also aims to promote the ancient Indian System of Medicine, known for being natural, cost-effective, and free from harmful side effects-thus making it accessible and beneficial to the larger population."
