They unanimously resolved that such acts of inhuman violence must be condemned unequivocally and collectively. An appeal was made to the people of Jammu and Kashmir, civil society, members of the Bar and Bench and all conscientious citizens to stand united in this hour of grief and express their unwavering commitment against terrorism in all its forms.

JAMMU: Chief Engineer, (Distribution) JPDCL, Jammu has informed that the power supply to Jarai, Main Bazar, Ward No. 4, 5, 8, 9, 10, 11 and 12, Taraf Sanji, Bhagthali, Court, Jail, PHE installations, Parliwandi, Basantpur, Lakhampur Dhanna, Thein and adjoining areas will remain affected on April 24 from 8 am to 8.30 am and 4 pm to 4.30 pm.

Likewise, the power supply to Sarthal, Kuntwara, Trigam, Bhawan and adjoining areas will remain affected on April 24 from 9 am to 4 pm.

Two smugglers arrested; illicit liquor seized

REASI: Reasi Police recovered illicit liquor and arrested two bootlegger involved in smuggling of illicit liquor. During routine patrolling, a team from Police Station Reasi apprehended one Jambal S/O Amarnath R/O Karoot, Gabbar, Tehsil Bhomag, District Reasi, and recovered 5 bottles (750 ml each) and 30 quarters (180 ml each) of JK Special Whiskey from his possession. In this connection, FIR No. 72/2025 U/S 48(A) of the Excise Act has been registered at Police Station Reasi. In another operation, a police team from Police Station Reasi intercepted a vehicle bearing registration number JK20-8541 at IRP Chowk, Reasi. The vehicle was coming from Thapa Chowk towards Silla. Upon search, 5 bottles (250 ml each) and 24 quarters (180 ml each) of JK Special Whiskey were recovered from the dickey. The accused has been identified as Charan Singh S/O Baldev Singh R/O Babbar, Tehsil & District Reasi. A separate case under FIR No. 73/2025 U/S 48(A) of the Excise Act has been registered, and the investigation is initiated.
