# Dr Jitendra updates Lok Sabha about Modi Govt's 'Pension Adalat' concept

NEW DELHI: Updating the Lok Sabha about the 'Pension Adalat' concept introduced by the Modi Government which has helped resolve cases, particularly family pension cases pertaining to widows or survivors, that had remained unresolved for decades together under the successive governments in the past, Union Minister for Personnel, Public Grievances, and Pensions, Dr. Jitendra Singh said that in last less than five years, 4,944 long pending cases have been resolved through these Pension

In reply to a question, the Minister reaffirmed the government's commitment to ensure justice for pensioners through the Pension Adalat initiative, a pioneering concept introduced under the leadership of Prime Minister Narendra Modi. The Union Minister emphasized that this mechanism, launched in 2017, has successfully resolved 4,944 cases in the last five years, bringing long-overdue relief to thousands of pensioners, particularly destitute widows and elderly citizens who had been waiting for justice for decades.

Dr. Jitendra highlighted that before 2017, there was no structured platform for pension grievance redressal in India. Many cases had been pending for as long as 25-30 years, with successive governments failing to act on repeated representations and complaints from pension-



ers. "Through Pension Adalats, we have been able to deliver on-the-spot resolutions, cutting through bureaucratic delays and ensuring that pensioners receive what is rightfully theirs without unnecessary hurdles,'

The Minister further emphasized that these Adalats, conducted in the presence of the Minister and Secretary in charge of pensions, bring together all stakeholdersincluding the Head of Office (HOO), Pay and Account Office (PAO), Central Pension Accounting Office (CPAO), Pension Disbursing Banks, and the pensioners themselves-to facilitate swift settlements.

Dr. Jitendra cited several cases where pensioners had suffered due to prolonged administrative delays but found immediate relief through the Pension Adalat. He mentioned the case of Ms. Anita Kanik Rani, a widow who had been denied her family pension for 20 years due to com-

plications surrounding a succession certificate. The Pension Adalat expedited her case, ensuring the sanction of ?22 lakh in arrears, bringing her long-overdue financial security.

Similarly, Dr. Arvind Kumar, a retired Associate Professor from the Indian Military Academy, had struggled for leave encashment due to pending administrative issues. Diagnosed with prostate cancer and in urgent need of funds, he approached the Pension Adalat, which swiftly facilitated the release of ?26.75 lakh, enabling his timely medical treatment. Another case was that of Ms. Geeta Devi, the mother of a BSF martyr, who had been receiving only a normal family pension instead of the Extraordinary Family Pension she was entitled to. The Pension Adalat corrected this longstanding injustice, ensuring she finally received the rightful benefits.


Dr. Jitendra Singh underscored that the Pension Adalat initiative is a testament to the government's commitment to citizen-centric governance. He reiterated that pension reforms under the Modi government go beyond financial settlements; they aim to uphold the dignity and wellbeing of retired employees. He also highlighted the government's push for digital interventions, including face authentication for digital life certificates, reducing pensioners' dependency on physical visits to

not dependents. It is our responsibility to ensure their financial security and recognize their contributions to Dr. Jitendra Singh society," remarked.

The Minister concluded by reaffirming the government's unwavering commitment to transparency, efficiency, and citizen welfare. Under Prime Minister Modi's leadership, the Pension Adalat will continue to evolve and expand, ensuring that no pensioner is left unheard and every grievance is addressed with the urgency it deserves.

In reply to the another question, Dr Jitendra Singh informed the House that "Bharat Atta" was launched on 6.11.2023 with a view to provide atta (wheat flour) to general consumers at subsidized rates under Open Market Sale Scheme (Domestic) policy through Semi-Government and Cooperative Organizations like Kendriya Bhandar/NAFED/NCCF and tie-ups of these Organizations with other retail outlets (like SAFAL in Delhi, other retail chains/cooperatives in other States) to make Bharat Atta available at large number of outlets throughout the country. A quantity of 5,09,000 MT of wheat was allocated to Kendriya Bhandar For sale as Bharat Atta during Phase-I. A total of 5,07,399 MT of wheat was lifted for Bharat Atta by Kendriya Bhandar from FCI during Phase-1 and the entire quantity of lifted wheat was sold as Bharat Atta.

# In 2012 Centre decided to list long pending Jammu-Poonch Rail Link as National Project entitled for priority with special financial provisions

## Now it is time for NC Congress J&K Government to take up Jammu Poonch Rail project with Centre for start as 'National Project'

Parliament Jammu-Poonch and senior BJP leader Jugal Kishore Sharma had on 15th March 2022 while appreciating 2022-23 Union Railway Budget as pro far flung area with huge amount of Rs 140367.13 crores for the development of Railways in the country had requested that since survey for laying of Jammu to Rajouri and Poonch railway line had been completed so provision of funds should be made available soon for laying that new railway line. People of J&K have been since very hopefully waiting to see the inauguration of the laying of the project. But as per information shared by a senior RTI Activist Sh. Raman Sharma of J&K in response to his RTI applications in 2022 the Jammu-Poonch rail project is said to have been 'shelved'/ not taken ahead by Railway Board since project had been found financially unviable .Application of Raman Sharma dated 26-02-2022 wasreplied 08-03-22 s/d Director Project Management & CPIO < Survey of new broad gauge line between Jammu and Poonch (223km) was completed in 2018. As per survey report the project was unviable. As such the project could not be taken forward.>and Application of Raman Sharma dated

12-03-2022 was replied 15-03-2022 s/d & CPIO < Survey for new line Jammu to Poonch was completed in 2017-18. The project could not be taken forward being economically unviable. Presently there is no proposal under consideration on this line. The survey has been shelved

with the approval of Railway Board>. It was on 7th Jan 2025 that LG J&K Shri Manoj Sinha, expressing gratitude to Prime Minister Narendra Modi for dedicating the new Jammu Railway Division, was quoted as having said on 6 Jan 2025 that enhanced connectivity was unlocking J&K's potential and DPR is under examination for new line between Baramulla-Uri (46kms), Baramulla-Kupwara (39kms), Jammu-Poonch via Akhnoor-Rajouri (223kms), Manwal-Talra via Ramkote, Billawar Dunera (117kms). Sopore-Kupwara (37kms), Pathankot-Leh (664kms), Bilaspur-Manali-Leh (489kms) and doubling of Baramulla-Banihal line where as surveys were ongoing for the Anantnag-Bijbehara-Pahalgam (78km) and Awantipora-Shopian (28kms) rail lines. Before that according to PTI input of 17 Mar 2025 it was also reported that 223- km Jammu-Poonch railway line project had been shelved 'again' for being 'financially unviable' by the central government as per the information given by The Ministry of Railways in response to two applications filed by Jammu-based activist Raman Sharma under the Right To Information (RTI) Act for which the final survey report ( estimated cost of Rs 22,771 crore ) for laying broad-gauge line between Jammu & border district of Poonch via Rajouri was submitted in 2018. In was on 13 March 2025 also that the Railway Minister was quoted as having said in Lok Sabha that Rajouri and Poonch

Earlier also Railway Minister Shri Ashwini Vaishnaw had said in Lok Sabha on 31-07-2024 that a survey for the railway line between Jammu and Poonch via Akhnoor and Rajouri was carried out, and the cost of the 223 km long project was assessed at Rs 22,771 crore and while responding to a question raised by Anantnag-Rajouri MP Mian Altaf from J&K about the Government's plans to connect the twin districts of Rajouri- Poonch by way of railway he did not quote any plans for

implementing the project. 5It is not out of place to mention here that in was as far back as 2012 (22-03-2012) that the then Railway Minister Shri Mukul Roy while replying to the Railway Budget in Lok Sabha had said that the Jammu-Poonch rail link that will pass through treacherous hilly areas

was first approved during the UPA-1 times when Lalu Prasad Yadav was the Minister and a survey was also got conducted by him which was a long pending project of a railway line via historic township of Akhnoor which will finally see light of the day with Centre deciding to include it in the list of national projects which are under this category are taken up on priority with special financial provisions. The then Jammu-Poonch MP, Shri Madan Lal Sharma had said in 2012 that in the earlier year's Budget also it had been decided to include the project in the 12th five vear plan as it was an important rail link that would connect strategic areas all along the Line of Control. Shri Madan Lal Sharma had in 2012 while welcoming listing the Jammu Poonch rail line project as a national project worth taking up on priority with special financial provisions had informed that Jammu- Poonch rial line will help in the economic development of large number of backward and hill areas in the region opening up new vistas of tourism in the historic Poonch and Rajouri districts and even in 2012 itself demanded that Jammu should be made the Divisional Headquarter of the Railways instead of Ferozepur suggesting that was necessary as with the growing railway network in J&K it will not be feasible to

control the areas from Ferozepur. The information that has been available in public domain all these years about Jammu- Poonch rail project has been giving sweet & bitter tastes to the common man and the J&K Government need to take up the matter with Central Government for taking up the execution immediately (if not held back) and if there are any reservations that may be got dismissed keeping in view the truthful needs of such like projects which have been denied to these areas for decades even after independence .
