sanction study leave. Any breach of standing orders or service rules constitutes nisconduct, warranting disciplinary action.

Legal precedents further support this position. In Rabindra Nath Barman vs. Gauhati High Court (2012), the court upheld that obtaining a law degree without authorization constituted misconduct and led to disciplinary action. Similarly, in Nongmaithem Rejan Singh vs. State of Manipur (2013), it was ruled that an unauthorized degree could not be used for career advancement, as it encouraged mis-

Based on these findings, the Jammu and Kashmir Government has issued a comorehensive order under Government Order No. 264-JK (Edu) of 2025, dated April 3, 2025, prescribing specific measures.

Employees who completed regular classwork before joining government service out appeared for final exams after entering service will have their cases reviewed v the committee formed under Government Order No. 188-JK (Edu) of 2024 dated March 15, 2024. The committee will recommend their eligibility for seniori-

Employees who began their higher education before joining service but completed their degrees after entering government employment will have their study period marked as Dies-Non. Recovery of salaries for that period will be enforced on a case-to-case basis by concerned DDOs.

Employees who pursued and completed higher education during service without drawing salaries during that period will also have their study period marked as Dies-Non. Additionally, they will face the penalty of withholding two annual increments under Rule 30 of the J&K CCA Rules, 1956, and will be excluded from sen-

Employees who pursued and completed higher education during service while drawing salaries will have their study period treated as Dies-Non. They will also face the penalty of withholding two annual increments, and salary recovery will be initiated by the respective DDOs in consultation with departmental authorities. These employees will be permanently excluded from seniority lists.

Moreover, the government has directed that seniority for eligible employees will be reckoned from the date of acquiring higher qualifications, ensuring transparency in promotions. To prevent similar cases in the future, amendments will be made in the J&K Government Employees Conduct Rules, 1971, or other applicable regulations, ensuring strict compliance with service rules.

This firm action by the government underscores its commitment to maintaining discipline and integrity within the education sector. The School Education Department has been directed to take immediate steps to enforce these measures, ensuring that violations of service rules do not undermine the merit-based promotion system in the state.

The infamous daylight heist at Anand Jewelers, Greater Kailash, Fowara Chowk, Jammu, had sparked concerns among the Sawarnkar community and sent shockwaves throughout the city.

Jammu SSP Joginder Kumar said the focused, professional, and dedicated efforts of the police led to the identification and arrest of the criminals behind this nighly planned crime.

On February 1, during noon, two armed robbers stormed into Anand Jewelers wielding a deadly weapon, a Toka, to intimidate the lone woman owner present inside the shop. By placing the sharp-edged weapon on her throat, they induced instant fear of death and looted valuable gold, cash, and a mobile phone (Vivo V20,

SIM No. 9906015489) before fleeing the scene. A case was registered under FIR No. 19/25 at PS Gangyal under Sections 309(3), 311, and 3(5) of BNS, and a highly skilled investigative team was deployed to begin the investigation. Recognizing the gravity of the case, SSP Jammu later constituted a Special Investigation Team (SIT) under the supervision of SP City South and headed by SDPO City South, Jammu.

Preliminary questioning revealed a shocking and disgraceful inspiration behind the robbery-a similar gold heist that took place in Delhi's Samaypur Badli in 2023. More arrests are likely to be made shortly.

SSP Joginder Kumar urged the public to remain vigilant and report any suspicious activities to the nearest police station or dial 100.

"Business owners are advised to install CCTV cameras around their establishments, keep valuables locked, and ensure that minimal stock is kept for display. The swift and precise action in this case sends a strong message that crime will not be tolerated, and offenders will be brought to justice-no matter how elaborate their planning may be", SSP said.

The culprits made an attempt to sell the jewellery in Delhi and the Jammu police got a tip, which led to their arrest.

odhi National Old Age Pension Scheme (IGNOAPS), the Under the Indira pension for individuals aged 60-79 years has been increased from Rs 1,000 to Rs 1,500, while those aged 80 years and above will now receive Rs 2,000 instead of Rs

Similarly, under the Indira Gandhi National Widow Pension Scheme (IGNWPS), widows aged 40-59 years will receive Rs 1,250 (earlier Rs 1,000), those aged 60-79 years will receive Rs 1,500 (earlier Rs 1,000), and widows 80 years and above

Additionally, the Indira Gandhi National Disability Pension Scheme (IGNDPS) has been revised, with pensions for disabled individuals in the 18-59 years category raised to Rs 1,250, those 60-79 years receiving Rs 1,500, and those 80 years and above now receiving Rs 2,000.

Furthermore, under the Integrated Social Security Scheme (ISSS), which is UTfunded, pension rates have been revised across multiple beneficiary groups

Old Age Pensions have been increased to Rs 1,250 for females aged 55-60 years, Rs 1,500 for those 60-79 years, and Rs 2,000 for those aged 80 years and above. Similarly, Widow/Divorcee Pensions have been enhanced to Rs 1,250 for widows below 60 years with a legal marriageable age, Rs 1,500 for those 60-79 years, and Rs 2,000 for those 80 years and above.

The Disability Pension has been revised to Rs 1,250 for those below 60 years, Rs 1,500 for those 60-79 years, and Rs 2,000 for those 80 years and above.

A similar structure applies to the Transgender Pension, ensuring increased financial assistance across all age categories.

Furthering his Government's commitment to women's empowerment, the Chief Minister had also flagged off the Zero-Ticket Travel Initiative-a free Government bus service for women-on April 1 from the Sher-i-Kashmir International Convention Center (SKICC).

Speaking at the launch event, CM Omar Abdullah said, "This initiative will create an environment where women feel empowered to travel freely, without financial constraints. It marks another step towards ensuring gender equality and mobility for women across Jammu and Kashmir." The Omar Abdullah-led Government has fulfilled yet another promise by implementing Zero Stamp Duty on property transfers through Gift Deeds within blood relations. In this regard, the Government of Jammu and Kashmir has issued S.O. 75, dated 27th March 2025, under Section 9(a) of the Stamp Act, 1977, to remit Stamp Duty on such transfers.

The term "Blood Relations" includes parents, siblings, children, and grandparents. This notification has come into force w.e.f. 1st April 2025.

# **DB** reject bail of LeT supporter

JAMMU: A Division Bench of Jammu & Kashmir and Ladakh High Court (Srinagar Wing) Comprising Chief Justice Tashi Rabstan and Justice MA Chowdhary upheld the rejection of bail of Javed Ahmed Bhat who is supporter of

According to the police case that the appellant Javaid Ahmed Bhat had accommodated the foreign terrorists initially in his hotel and then in his house and also arranged sim card for them, besides accommodated them in Padshahibagh and used to meet them in Bishambar Nagar area occasionally to discuss and plan their movement and other terrorist activities.

The police concluded the investigation establishing that all the accused persons including the appellant conspired with each other to wage war against the Govt. of India by receiving, transporting, concealing, harboring and by extending all physical and communicational logistics to the freshly infiltrated Pakistani terrorists of proscribed terror organization "Lashker-e-Toiba" with the aim and motive to spread terror by way of carrying out terror attacks on the security forces and on the persons working in the security grid in J&K in particular and based on the investigation, the chargesheet was concluded against the appellant for the commission of offences punishable under sections 13, 18, 19 & 39 of UAP Act as he was alleged to have voluntarily provided accommodation to the two alleged slain militants in his hotel (Section 19 of UAP Act) and asked one of his employees (Saqib) to provide a SIM card to one of the two alleged slain militants for use (Section 18 of UAP Act).

DB further observed that the trial court while considering the application for grant of bail and so this appellate court while hearing the appeal against the rejection of bail cannot go into the intricate questions of whether the offences are made out or not as the evidence cannot be appreciated so minutely at the stage of consideration of bail, which is expected to be considered at the trial stage.

It appears that the learned judge presiding over the NIA Court has discussed all the points raised by the appellant before the trial court and the point wise determination has been given with elaborate discussion on each and every point raised.

DB after hearing both the sides, perusal of chargesheet and other incriminating material, while exercising appellate jurisdiction, does not find any illegality or perversity in the impugned order, which is, thus, upheld, as a result the appeal fails and is, accordingly dismissed.

# Kathua combing operation enters 12th day to track down terrorists

JAMMU: The multi-tier operation to track down three infiltrating terrorists, who escaped three encounters and are believed to be hiding in a forested area in Kathua, has entered its 12th consecutive day with security agencies also cracking down on terrorist supporters and setting up ambushes

Additional troops have been deployed to beef up the multi-tier cordon and set up ambushes over a 6-7 km radius in the region. "The combing operation has been going on. It is underway to track down terror-

ists on the run," said an officer. The search operation was intensified with aerial surveillance, including the use of

choppers, UAVs, and sniffer dogs. Teams comprising joint operations of the army, NSG, Police, SoG, CRPF, and BSF are combing all areas to cover the region, offi-

They said additional troops have been deployed in the rugged terrain and dense forested areas to ensure that terrorists do not escape towards upper reaches.

The troops have established multiple ambushes in a large area to apprehend the terrorists. They have further expanded the area of operation to include Billawar, Bhaddu, Ghatti, and Kog-Mandli. To dismantle the overground network supporting terrorists, security agencies are

focusing on OGWs and cracking down on them to cut off the supply of food, shelter, and guidance in the hills, the officials said. Over 27 individuals have been questioned for gathering information about the terrorists' movements. Terrorists have entered two houses to get away with food too

during the operations. Security agencies emphasise that it is difficult for terrorists to survive without a network of overground workers who provide them with food, shelter, and guidance from the International Border (IB) to the hills of Kathua and other districts like

The forces have detained six individuals, including three females from a single family, for questioning. It is alleged that they provided assistance to terrorists oper-

ating in the region, officials said. The detained persons belong to the family of suspected over ground worker Mohammad Latief, who is already in jail under the Public Safety Act (PSA) for aiding terrorists in Malhar during an attack on an Army truck last year, resulting in the deaths of six soldiers

It is believed that the slain terrorist Abu Tala also stayed at Latief's house. Officials said the three terrorists are believed to be part of a group that first

engaged security forces in the Nursery area near the International Border on March 23. All terrorists managed to escape after a brief encounter, during which a girl was njured. Four days later, security forces encountered them in a forested area of the Sanyal belt in Kathua. Two terrorists were eliminated, while the rest escaped.

With the hiding terrorists constantly changing their locations in the jungle, security forces are maintaining a high level of pressure in a multi-agency operation to track them down. This led to an encounter with terrorists in the Panjtirthi-Juthana on March 31, but they managed to escape.

# Two major bovine smuggling bids foiled; 44 bovines rescued, 2 vehicles seized

SAMBA: Tightening noose against the bovine smugglers and their propagators, Samba Police has foiled two major bovine smuggling attempts in the jurisdiction of Police Station Ghagwal and rescued forty four bovines from the clutches of bovine smugglers. The vehicles used for illegal transportation of bovines were also seized.

An information was received at Police Station Ghagwal from reliable sources regarding smuggling of bovines in a truck container bearing registration No. NL01N-0553. Acting on information, a Police team headed by SHO Police Station Ghagwal successfully intercepted the said truck at naka NHW Tapyal for its checking. During checking, twenty six boyines found inside the vehicle which were tied in a cruel manner and were being transported illegally without any valid permission. All the bovines have been rescued and the said truck has also been seized.

A case FIR No. 48/2025 u/s 223 BNS, 11 PCA Act has been registered at Police Station Ghagwal and investigation started. Similarly in another bovine smuggling attempt foiled by Police, a truck container without registration No. was intercepted at naka NHW Tapyal and during its checking, eighteen bovines were found inside the vehicle which were tied in a cruel manner and were being transported illegally without any valid permission. All the bovines have been rescued and the truck has also been seized. A case FIR No. 47/2025 u/s 223 BNS, 11 PCA Act has been registered at Police Station Ghagwal and investigation started.
