#### Contract for 650-bedded Army Hospital: DB dismisses appeal challenging termination of tender STATE TIMES NEWS power. JAMMU: In a LPA filed by

M/s Vijeta Projects & Infrastructure Ltd against judgment of Writ Court whereby the Court has dismissed petition of petitioner challenging cancellation of contract of construction of a 650-bedded hospital at Northern Command. A Division Bench of Jammu & Kashmir High Court comprising Chief Justice Pankaj Mithal and Justice Rainesh Oswal, while dismissing appeal, observed that as contract in the case at hand was purely of a civil nature between a private individual and the State was not acting in any statutory capacity, the writ court rightly held that it was not having any public law character and was not in domain of public law. There is no dispute to the fact that the agreement vide Clause 70 provided for Oresolution of disputes through arbitration.

During the course of hearing, Sr Adv Pinaki Misra submitted that aforesaid clause is illusory in nature as it limits invocation of the same only after the contract work is completed through some other agency. DB after hearing Sr. Adv Pinaki Misra for appellant whereas ASGI Vishal Sharma for the Union of India. observed that agreement does provide for an alternative remedy of arbitration and complete reading of the arbitration clause reveals that aforesaid remedy can be invoked as soon as respondents award a fresh contract for purposes of completing the balance work and appellant need not to wait till completion of the contract for invoking the arbitration. The appellant having waited since March 2019 can certainly wait for some more time to get the matter adjudicated through arbitration, as the respondents very fairly submitted that they would be finalizing the contract for the remaining work without wasting any time at the earliest which could not be done earlier due to this litigation. Moreover, arbitration happens to be a complete remedy for redressal of all grievances of the parties which can be settled or adjudicated on the basis of evidence including that of summary proceedings. DB further observed that the

other point, which arose for consideration before the writ court was whether the termination of contract vide order dated March 18, 2019 is illegal or unjustified.

The court has categorically concluded that the contract had been terminated in accordance with the terms and conditions of the agreement and that there was no arbitrariness in such termination. The slow pace of work or the delay in completing construction work, which is one of the main factor for terminating the contract. was more or the less attributable to appellant as the appellant in various meetings, admitted the same. The alleged deviations were within the four corners of the agreement and were not the major ones. The issue whether the deviations exceeded the permissible limit of 10 per cent to classify them as major deviations, is certainly a question of fact dependent upon the evidence which could not have been looked into and adjudicated upon by writ court in exercise of its extra ordinary

DB observed that thus, in overall facts and circumstances, there is no error or illegality on part of the writ court in refusing to entertain the writ petition both on the ground that it is not a case which warrants exercise of extraordinary jurisdiction and that there is no ex-facie illegality in the termination of contract leaving it to be adjudicated upon by appropriate forum on the basis of evidence without prejudice to any observations or finding recorded by the High Court in the writ petition or in this Letters Patent Appeal.

Briefly stated, the facts necessary for the disposal of the instant appeal are that the appellant was awarded a contract for construction of a 650bedded hospital along with OTM ACCN, Lift, Central AC Plant, Hot Water Supply, Fire Hydrant, Sprinkler System. Fire Alarm System and External Service for a Command Hospital, Northern Command, Udhampur and Contract Agreement No. CEUZ/UDH/09/2010-11 dated January 27, 2011 was executed. Time period for the execution of the work was 27 months commencing from February 10, 2011. It is the case of the appellant that after the site was handed over to the appellant on February 10, 2011, the appellant started the construction work of the hospital and during the course of execution of the work, due to number of changes in the scope of work as well as in the goods to be consumed by the appellant, the pace of the execution of the work was severely affected.

# **Resurgent Mumbai Indians favourites against SunRisers Hyderabad**

NEW DELHI: Back in the groove after two consecutive wins, defending champions Mumbai Indians will be firm favourites to put it past the turbulence-hit and bottom-placed SunRisers Hyderabad in an IPL game here on Tuesday.

Mumbai will enter the game after their four-wicket win over in-form Chennai Super Kings courtesv Kieron Pollard's blitzkrieg.

SunRisers, in contrast, suffered a humiliating 55-run loss to Rajasthan Royals, their sixth in seven games this season. They are also battling a transitional phase in which Kane Williamson has taken over captaincy from an out of form David Warner; leaving him disappointed.

Mumbai openers Rohit Sharma (250 runs) and Quinton De Kock (155 runs) would be itching to give the fivetime champions another strong platform and also convert their starts into big scores.

Mumbai's hard-hitting middle-order has clicked in the last two games, which would be



quite pleasing for the team management. Pollard (168 runs), who blazed his way to a match-winning 87 off 34 balls in the last game, would be keen to continue from where he left. The likes of Krunal Pandya (100 runs), Hardik Pandya (52 runs) and the flambovant Suryakumar Yadav (173 runs) can be destructive on their day

and the trio would be aiming to fire in unison. Also, it remains to be seen if

Mumbai plays Ishan Kishan or Jayant Yadav in place of allrounder James Neesham, who neither scored big nor was able to pick up wickets.

However, the Mumbai bowlers would need to forget

the hammering received at the hands of the CSK batsmen and start afresh.

> The pace duo of Jasprit Bumrah (6 wickets) and Trent Boult (8 wickets) have been exceptional at the death and would pose a big threat to the SRH batting unit, which has been inconsistent at best. Leg-spinner Rahul Chahar

> (11 wickets) has been the MI's main wicket-taker, but he would need support from Krunal, who has just three scalps.

The duo would need to keep things tight to contain the SRH batters.

Pollard, also picked up two important wickets in the last game and can fill in the role of fifth or sixth bowler. However, there are problems

aplenty for SRH. They are over-reliant on their top-order, especially Jonny Bairstow (248 runs), but their middle-order has faltered most often.

Against RR, they dropped Warner and opened with Manish Pandey and Jonny Bairstow, with Williamson coming in at three. If they persist with the same line-up, the three need to fire on all cylinders.

Also, the likes of Vijay Shankar (58 runs), Kedar Jadhav (40 runs), Abdul Samad (36 runs) and Mohammed Nabi (31 runs), if he plays, will have to get some runs for the side to have any chance of building a momentum.

On the bowling front, star legspinner Rashid Khan has been the pick of the bowlers with 10 butwickets pacers Bhuvneshwar Kumar (3 wickets) and Khaleel Ahmed (4 wickets) would need to find their form too. It remains to be seen if
