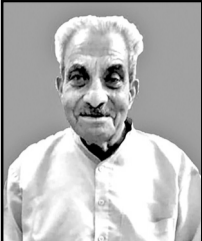

Capt Didar Singh was a brave soldier who bravely fought Indo-China wars of 1962 and 1965, but got injured in war of 1965. Capt Didar Singh never lost courage and after recovery, participated in Indo-Pak war of 1971 at R S Pura Sector and secured a number of medals. He retired from service in 1980 as a Captain. Capt Didar Singh breathed his last on April 27, 2021 after a brief ailment. He is survived by wife, two sons and grand children.

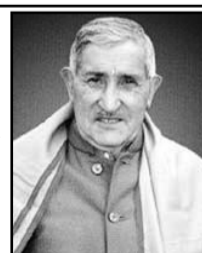
