






Shri Surinder Tikoo

CRIME REPORT

Fraud by maid agency 'Karishma Maid Bureau'; 2 arrested, Rs 74,000 recovered

SRINAGAR: Police on Tuesday arrested a maid & an agent of a maid agency 'Karishma Maid Bureau' involved in a fraud & recovered an amount of Rs 74,000 from their possession.

As per details, a complaint was received by Police Station Lalbazar wherein the complainant namely Muzamil Hayat, son of Faiz-ur-Rehman, resident of Qadeem Masjid lane, Lal Bazar stated that they had hired a maid through a maid agency 'Karishma Maid Bureau' via online platform. He further stated that, on May 9, 2022, at around 03:30 PM, the maid agency sent the maid namely Archana Chauhan along with an agent namely Rajini Jha to their home. The complainant further read that an advance amount for one year, totaling to Rs 74,000 was given to agent. However, both maid & agent fled from house in wee hours along with advance payment.

Accordingly, FIR number 26/2022 under relevant sections of law was registered at Police Station Lal Bazar and investigation was set into motion. Acting swiftly, various teams were constituted under the supervision of SDPO Hazaratbal and SHO Lal Bazar to nab the duo. After putting in hectic efforts, both maid & agent were arrested from Qazigund area within hours along with cash. Further investigation is going on.

37 bovines rescued, 4 smugglers arrested

KATHUA/REASI: Tightening noose over bovine smugglers, police on Tuesday rescued 37 bovines and arrested 4 smugglers.

As per details, under overall supervision of SSP R C Kotwal, a team of Police Station Hiranagar led by Insp Sunil Kumar under the supervision of SDPO Border Pankaj Soodan during patrolling duty near Dyalachak, Sallan noticed some suspects, who on seeing police party, fled away leaving behind bovines. During checking, police team found 9 bovines which were rescued. FIR No. 57/2022 under section 188 of IPC was registered at Police Station Hiranagar and further investigation started.

Meanwhile, on receiving information regarding smuggling of bovines in Mahindra Vehicles (JK02AW-6327 & JK08H-7466), a police team led by Insp Amit Sangra SHO Rajbagh under the supervision of SDPO Border Pankaj Soodan while on Naka checking duty in its jurisdictional area intercepted aforesaid vehicles driven by Ravi Singh, son of Yashpal, resident of R S Pura Jammu & Jagjit Singh, son of Amrik Singh, resident of Bhamo Chak Tehsil Ramgarh District Samba. During checking of vehicles, 8 bovines were found laden in them which were rescued. Both accused were arrested and FIR No. 96/2022 under sections 188 of IPC, 11 of PCA Act was registered at Police Station Rajbagh.

Further, a police team led by Insp Rajinder Khajuria Incharge Police Post Industrial Estates Kathua under the supervision of DySP Headquarters Kathua Shamm Kumar during Naka checking duty near Hatti Morth noticed a suspicious Auto Load Carrier (JK08J-9725) which was signaled to stop for checking. On seeing police party, the driver of vehicle managed to flee leaving behind the vehicle. On thorough checking, 2 bovines were found laden in it which were rescued and the vehicle was seized. FIR No. 182/2022 under section 188 of IPC, 11 of PCA act was registered at Police Station Kathua.

Meanwhile, a team of Police Post Dewal laid a surprise Naka at Dewal area and intercepted a bovine smuggler. 16 bovines were rescued from possession of smuggler, identified as Ajaz Ahmed, son of Mohd Younis, resident of Tulli Tehsil Chassanna, District Reasi. FIR No. 41/2022 under section 188 of IPC was registered at Police Station Mahore and investigation initiated.

Machinery involved in illegal mining seized

RAJOURI: A team of official of Geology and Mining department laid Nakas overnight at different locations to crack a whip on perpetrators of illegal mining. On directions of the Deputy Commissioner Rajouri, Vikas Kundal, the team on Tuesday conducted raids in Kotranka and Rajouri and seized three heavy excavators, a tractor-trolley and a dumper found involved in illegal mining.

He warned the people not to indulge in illegal mining activities and made it clear that violation of would be dealt with strictly.

Missing girl traced, reunited with family

In this regard, missing report was registered and investigation started. Subsequently family of missing girl was informed and she was handed over to family members after completing all legal formalities.

Bootlegger arrested, 64 quarters of illicit liquor recovered

JAMMU: Police on Tuesday nabbed a bootlegger at Domana and recovered 64 quarters of illicit liquor from his possession.

As per details, a team of Police Station Domana constituted under the supervision of SDPO Domana Sunil Singh led by SHO Domana Insp Tilak Raj laid a Naka in the area and rounded up a suspect. During search, 64 quarters of illicit liquor were recovered from accused, who has been identified as Nand Kishore alias Goolu, son of Girdhari Lal, resident of Bhadrode, Gho Manshan. He was arrested and FIR No. 169/2022 under section 48-A Excise Act was registered against him.

Theft case solved; accused arrested, stolen items worth Rs 60,000 recovered

JAMMU: Police on Tuesday solved a theft case by arresting an accused and recovered stolen items worth Rs 60,000 from his possession.

As per details, complaint was lodged at Police Post Sidhra regarding theft of 20 shuttering plates value worth Rs 60,000 from Lane No 8 Tawi Vihar Colony Sidhra under jurisdiction of Police Station Nagrota. On this, FIR No 19/2022 under section 380 of IPC was registered at Police Station Nagrota. After this, a team of Police Post Sidhra under supervision of SDPO Nagrota Pardeep Kumar led by SHO Nagrota Vishva Pratap Singh assisted by Incharge Police Post Sidhra SI Majid Hussain after putting in strenuous efforts arrested accused, who was identified as Ismail, son of Lt Faqir Mohd, resident of Ragoora Sidhra. During questioning, he confessed his crime and disclosed that he had stolen 20 shuttering plates, took them in his auto (JK02CT- 9628) and sold the same to Dharam Paul, son of Amar Chand, resident of Narwal Bala.

Tractor-trolley seized for illegal mining

KATHUA: Taking tough action against illegal mining within the district, Kathua Police under the overall supervision of SSP R C Kotwal on Tuesday seized a tractor-trolley indulged in illegal mining which was being used for illegal transportation of construction material in jurisdictional area of Police Station Lakhapur.

As per the details, a team of Police Station Lakhapur headed by Insp Vijay Kotwal SHO Lakhapur while on patrolling duty in its jurisdictional area found a tractor-trolley

Police detains 22 for drug peddling

Govt employee among two arrested, stolen forest wood recovered

RAMBAN: Police on Tuesday arrested two persons including a Government employee and recovered stolen forest wood (17 logs) from their possession.

As per the details, on May 8, information was received at Police Station Dharamkund through reliable sources that some unknown persons are illegally taking timber logs from forest area and loading the same in a Bolero pickup (JK19A/1755) at Gandhri.

On receipt of information, FIR No 19/2022 under section 379 of IPC, 26(1) of Forest Act was registered and Police rushed to the spot. After hectic efforts, police recovered 17 logs of forest wood and arrested 2 accused namely Mohan Lal, son of Lachhu Ram, resident of Gandhri (Govt employee working in Forest Department) and Mashoor Ahmed, son of Saraj Din, resident of Gandhri, Tehsil and District Ramban. The vehicle was also seized. The recovery and arrest was made by PSI Ganesh Dutt under supervision of Insp Sam Paul SHO Dharamkund and SDPO Gool Nihar Ranjan under overall supervision of SSP Ramban Mohita Sharma.
