Subject: Expression of Interest for cultivation of fallow land at SMF Chinore for growing of Maize crop particularly for silage purpose during Kharif 2022.

With the objective to enhance the production of milk by feeding the milk animals with green fodder throughout the year. Expression of Interest for cultivation of 680 Acre of Kharif fallow land is invited from private persons / parties / firms for growing maize as a silage crop on **terms and conditions** as below:

1. 680 Acre Kharif fallow land is available for cultivation by interested private persons / parties / firms on rent for a period of 03 months or so, to be vacated by or before 15th of September, 2022.

2. All inputs / services required by the private parties for cultivation of kharif crops for the said rental period viz. men, machinery, seeds, fertilizers, pesticides, watch and ward etc. to be arranged by the persons / parties themselves. **The Department shall provide land only.**

3. The rent of land for the period shall be fixed by Committee of officers as constituted for the purpose and shall be on basis of rates quoted by interested parties.

4. 100% rent to be deposited in advance at the time of award of contract.

5. All risks for the failure of crops shall be owned by the contractor and Department in no way responsible for failure of crops for whatsoever reason.

6. Department shall only allocate land equivalent to rent deposited by the person(s) / parties for a period not extendable beyond 15th September 2022. If a party does not harvest the crop from the rented field(s) by the stipulated time, the party shall lose rights over the standing crops and Farm Management can take up land preparation for Rabi crops w.e.f 15th September, 2022 onwards without notice.

7. Persons / parties / firms may quote rate in a sealed envelope delivered in the office of Joint Director (Farms, Spices, Medicinal Plants, Procurement Mandies, State Land Use Board) Jammu by or before 20th May, 2022 for an entire fallow 680 Acre land or part or parcel of land, the rates so quoted should be on per Acre basis.

8. Committee can further negotiate with parties and allocate land on rent to a person / group of persons / parties on rent rate as finalized or mutually agreed. The decision of the Committee shall be final.

9. FDR / CDR amounting to Rs. 3.00 Lakh may be deposited along with EoI in favour of Farm Manager, Seed Multiplication Farm, Chinore as a security.

10. Last date for submission of EoI is 20.05.22 up to 2PM hrs. Sealed envelope marked to the captioned address containing earnest money (refundable) of Rs.3.00 lakh by the way of CDR/FDR in favour of Farm Manager, Seed Multiplication Farm Chinore, Gajansoo Jammu Department of Agriculture Jammu payable at Jammu may be submitted mentioning "EOI for area to be cultivated out of total 680 acre fallow land at SMF Chinore for growing of Maize crop particularly for silage purpose during Kharif 2022".

11. Upon signing of MOU the department shall allocate land for cultivation at SMF Chinore on "as it is where it is" basis to the qualifying person/party.

12. Documents to be enclosed are PAN card, Aadhar card and format-I

13. Department will be the final arbiter in cases of potential conflicts of interest.

14. The EoI is not an offer and is issued with no commitment. Department reserves the right to withdraw EoI and of vary part thereof at any stage. The department further reserves the right to disqualify any bidder, should it be necessary at any stage.

The CDR/FDR/BG shall be valid for 45 Days beyond the bid validity period. The original instruments in respect of cost of documents, EMD and relevant documents of L1 be submitted to the Executive Engineer PWD (R&B) Const. Divn. No. II Jammu at the time of allotment.

2. The electronic bidding system would not allow any late submission of bids after due date and time as per server time. Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder need not to make any additional payment towards the cost of tender document. For bid modification and consequential re-submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. No bid shall be modified or withdrawn after the deadline of submission of bids.
