CRIME REPORT

Two narco smugglers nabbed; heroin, Ganja recovered

R S PURA: Continuing its drive against drug trafficking and substance abuse, R S Pura Police



arrested two narco smugglers and recovered 5.5 gm heroin and 3 Kg Ganja at two different Nakas.

As per details, a team of Police Station R S Pura constituted under the supervision of SDPO R S Pura Surinder Singh and led by SHO R S Pura Inspr Rajesh Sharma, while on Naka duty at two different places, rounded up two suspects, and on checking recovered 5.5 gm heroin and 3 Kg Ganja from their possession. FIR No 86/22 under section 8/21/22 of NDPS Act and FIR No. 89/21 under section 8/20 of NDPS Act were registered at Police Station R S Pura and duo got arrested. The accused were later identified as Ajay Kumar, son of Raj Kumar, resident of Phinder, R S Pura, arrested with heroin and Bhopinder Sahu, son of Ek Ram, resident of Bhuthana Malkhroda Jahangir Champa (Chhattisgarh), arrested with Ganja.

Two absconders nabbed after 9 years

JAMMU: Police on Saturday nabbed two absconders who were evading arrests since 9 years.

As per details, information was received at Police Post Narwal regarding an absconder evading arrest since 2013 i.e., 9 years in FIR No 147/13 registered under sections 457/380 of RPC at Police Station Bahu Fort. On this, a team of Police Post Narwal under supervision of SDPO East Syed Zaheer Abbas Jafari led by Incharge Police Post Narwal SI Aehal Rana, after putting in strenuous efforts, arrested the absconder identified as Sulieman Ahmed Sheikh, son of Ghulam Hussain Sheikh, resident of Parimpora, Srinagar. He shall be produced before the Court for further proceedings.

Similarly, information regarding an absconder who was evading arrest since 2013 i.e., 9 years in FIR No 76/2013 registered under section 188 of RPC was received at Police Station

Nagrota. On this, a team of Police Station Nagrota under the supervision of SDPO Nagrota Pardeep Kumar led by SHO Nagrota Inspr Vishav Pratap Singh arrested absconder, namely Mohd Nazeem, son of Kala Khan, resident of Kans Kassan Tehsil and District Reasi. It is pertinent to mention that a warrant under section 512 of CrPC has already been issued against him. Finally, he shall be produced before the Sub-Judge passenger Tax Court Jammu.

Minor boy reunited with family

As per details, information was received at Police Post Sidhra through reliable sources regarding a boy roaming unnecessarily in area. On this, a police team brought minor boy to Police Post Sidhra and offered him meals. After this, a team of Police Post Sidhra under supervision of SDPO Nagrota Pardeep Kumar led by SHO Nagrota Inspr Vishav Pratap Singh assisted by Incharge Police Post Sidhra SI Majid Hussain, after putting in strenuous efforts, finally contacted family members of boy, later identified as Shivam, son of Uttam Singh, resident of Madhya Pradesh, at present Dhok Waziran, Nagrota. He was handed-over to his family members after completing all legal formalities.

Bootlegger nabbed with 53 bottles of illicit liquor

MIRAN SAHIB: Police on Saturday nabbed a bootlegger and recovered 53 bottles of illicit liquor from his possession.

As per details, during Naka checking at Nandpur, one Ashwini Kumar, son of Ram Prasad, resident of Nandpur Miran Sahib was found selling liquor illegally. A police team led by SHO Police Station Miran Sahib Inspr Zaheer Mushtaq recovered 53 bottles of illicit liquor from possession of accused, who was arrested and FIR No. 50/2022 under section 48 of A Excise Act was registered against him at Police Station Miran Sahib. The overall operation was conducted under supervision of SDPO R S Pura Surinder Singh.

5 bovines rescued, smuggler flees

VIJAYPUR: Police on Saturday foiled an attempt to smuggle bovines by rescuing 5 bovines.

As per details, acting on reliable information regarding smuggling of bovines, a party of Police Station Vijaypur established a surprise check point near Vishwakarma Temple and signaled a Mahindra Vehicle (PB06AS-4629) to stop for checking, but instead of stopping vehicle, the driver accelerated the vehicle and jumped the Naka. The police party successfully chased the vehicle and intercepted it a few meters away but driver managed to escape from spot taking advantage of darkness. On checking of vehicle, 5 bovines were found laden inside it which were rescued. FIR No. 69/2022 under section 188 of IPC, 11 of PCA Act was registered at Police Station Vijaypur and investigation started.

Army Jawan commits suicide in Ramban

BANIHAL/JAMMU: An Army jawan died by suicide in Ramban district of Jammu and Kashmir, police said on Saturday.

The deceased has been identified as Ravi Kumar (25), a resident of Haryana. He was on guard duty at Neel top post in Banihal on Friday evening when he shot himself with his service rifle, a police official said.

He said the reason behind Kumar taking the extreme step is yet to be ascertained.

Police have initiated inquest proceedings. The body was sent to Kumar's unit after the completion of medico-legal formalities, the official said.

The mortal remains of the deceased are being handed over to his family for the last rites, he said.
