

DC Jammu conducts extensive tour of Khour, Kharaballi; listens to public grievances

JAMMU: To get first-hand account of the public grievances, Deputy Commissioner, Avny Lavasa on Saturday conducted an extensive tour of Khour and Kharaballi and listened to the issues and grievances of the Public faced by them in day to day life.

The PRI representatives including DDC members highlighted the issues one by one regarding their respective areas which were mainly related to irregular supply of water and electricity, Revenue services, delay in land compensation, issuance of ration cards, PMAY houses, Road connectivity, drinking water availability, repair and installation of hand pumps, services in health centres etc.

The Deputy Commissioner gave a patient hearing to and passed on the spot directions to the concerned departments for early redress of the genuine grievances projected on the occasion.

She assured that all the issues of public importance will be taken up with higher authorities while the pendency and public service delivery slackness shall be reviewed thoroughly.

The Deputy Commissioner also convened a meeting with the district officers and reviewed the progress under the flagship government schemes including SWAMITVA, writing of Jamabandis, PMAY, KCC etc.

The concerned official apprised the Deputy Commissioner that the first survey regarding SVAMITVA has been completed and second survey has been already initiated.

Survey of villages and mapping with improvised technology in village areas) scheme aims to provide rural people with the right to document their residential properties so that they can use the same for economic purposes.

The concerned official also informed that writing of Jamabandis was in full swing and will be completed soon.

The Deputy Commissioner also impressed upon the officers to work with zeal to achieve the targets ensuring the delivery of the benefits to the rural masses.

DDC member Bhushan Abrol, SDM Khour Anil Thakur, PRI members along with other officers of the line department and a large number of people were present at the program.

**Tourism Deptt team checks several city hotels for service delivery, tariffs**

SRINAGAR: Continuing with its efforts to check overpricing of tourism services by service providers, a team of officers of the Tourism Department on Saturday conducted checks of various hotels in the city to check the services and their pricing being offered to visitors.

During the checking, the team of officers inspected some prominent hotels in the city. The units were served notices under relevant clauses of J&K Registration of Tourist Trade Act for many of the deficiencies, including, unjustifiable tariff slabs and fines were slapped on spot.

It may be recalled that the Department, after receiving several complaints by tourists and locals of overcharging and other service deficiencies has constituted a Central Committee of officers to regulate the tourism services across Kashmir and ensure that proper services are delivered at reasonable prices.

The drive of the Committee is planned to intensify in coming days.

The Department has cautioned all the service providers against overcharging, cheating or touting while appealing them to conduct their business within the highest hospitality traditions of the place and not let the law enforcing agencies take any action against them for any violation.

#### PUBLIC NOTICE

The General Public is hereby informed that Hon'ble Supreme Court vide its Order (Reportable) dated:- 24th March 2022 in the Miscellaneous Application NO. 1805 of 2021 in Writ Petition (C) No. 539 of 2021 has issued following key directions'

- Fixing of Outer Time Limit of 60 Days [w.e.f 24-03-2022 , the date of the Hon'ble Supreme Court's Order] to file the claims for compensation in case the death occurred due to COVID-19 Prior of 20th March 2022.
- For future deaths ninety days' time shall be provided from the date of death due to COVID-19 to file the claims for compensation.
- The earliest Order to process the Claim and to make the actual payment of compensation within a period of thirty days from the date of receipt of claim shall continue to be enforced.
- In case of extreme hardship where any claimant could not make an application within the time prescribed, it will be open for the claimant to approach the Grievance Redressal Committee and make the claim through Grievance Redressal Committee which be Considered by the Grievance Redressal Committee on case to case basis and if it is found by the Grievance Redressal Committee That a Particular claimant could not make the claim within the stipulated time which was beyond their control his/her case may be considered on merits.
- In a bid to minimize the risk of fake claims, a random scrutiny of the 5% of the claim applications shall be made at the first instance. If it is found that anybody has made a fake claim, the same shall be considered under section 52 of the Disaster Management Act, 2005 and liable to be punished accordingly.

In pursuance to Notification No.037-BOPEE of 2022 dated 22-04-2022 and subsequent receipt of shortfall from Colleges with regard to admission for BPT course, it is hereby notified for information of the eligible and desirous candidates that the Board has decided to reduce the cut- off score for BPT Course only as per below table for eligibility of registration of candidates against the said course for admission in Composite Regional Centre, Bemina, Srinagar and Jammu College of Physiotherapy, Jammu of the UT of J&K:-

- ii) 12th class Marks Card
- iii) NEET Score Card-2021.
- iv) Category Certificate, if any.
- v) Domicile Certificate

Any candidate who has not registered earlier and is not figuring in the UT merit list of 2021 but wants to be considered for BPT course in the College/ Institute shown below may also report for registration within the prescribed date and time schedule indicated herein above.

- Mere registration of candidates does not confer any right to have a claim on any vacant seat(s) which as of now are to be filled up on the basis of the available candidates in the BOPEE Office and willing to opt for a seat subject to the merit/preference of the candidates.
- The candidates who are participating for the first time in the counselling process shall have to deposit a fee of Rs.1500/- (Rs. One thousand & five hundred only) as a counselling fee at the time of registration. However, the payment shall be made through POS machine available in the BOPEE Office by using credit/debit card.

The following shall be eligible to participate in this special round of physical counselling:-

- Candidates who have not been allotted any seat during any round of online or offline counselling can participate physically in this round of counselling as per the terms of conditions contained in the Information Brochure.
- Candidates who have been allotted seat during any round of online/ offline counselling and have joined the college/institution and wish to participate in this round for purpose of upgradation, provided that he/she shall have not been upgraded earlier in any round of counselling.

The following shall not be eligible to participate in this special round of physical counselling:-

- The candidates who have already resigned against the seats allotted to them during any round of online/offline counselling.
- The candidate(s) who have been upgraded/allotted BAMS or BUMS seats in any Govt./ Pvt. Institution and have joined in the respective allotted College/ Institute shall not be eligible for this round of counselling.
- The updated Seat Matrix shall be uploaded before the start of the physical counselling.
- The other terms and conditions shall remain the same as contained in the e-Information Brochure, Notifications/Notices issued by the Board from time to time in this regards.
