threats. "The overall situation is progressively improving due to the proactive Rashtriya Rifles-gridded deployment leading to a positive and conducive environment for accelerating the developing initiatives of the government," the Army commander said.

He said dividends of peace have started reaching the people and they are further getting motivated to preserve and sustain it.

As per reports, as many as 17 Kashmiri Pandits (KPs) and non-locals have been killed by militants in Kashmir after the special status of J-K was revoked in 2019. In 2021, three KPs, one Sikh and five non-local labourers were killed.

Ten KPs and non-local labourers have been shot at and injured by terrorists in South Kashmir and Srinagar so far this year.

Three Kashmiri Hindus have been targeted since March this year. Two of them -- Satish Kumar Singh and Rahul Bhat, a revenue department employee were killed in the attacks. A Kashmiri Pandit, Bal Krishan, who did not migrate in the 1990s and ran a medical shop, was also shot at and injured in Shopian in April.

central Kashmir's Budgam district on Thursday.

"A group of terrorists barged into his office, asked his name and shot him there and then. It felt like a premeditated killing where the terrorists had decided to murder a Kashmiri Pandit. The Indian Army killed two terrorists in just 24 hours after the incident. But today a question faces the nation - why aren't the Kashmiri Pandits safe in Kashmir even today?" He said.

He also said the Kashmiri Pandits who protested against the incident the next day were lathicharged and stressed that they are mourning the loss of a loved one and "deserve our love and care not our animosity".

"After this incident, all Kashmiri Pandits living in the region are completely terrified. When these people set out to protest to voice their anger against the brutal killing, they were met with brute action. They were stopped. Their voices were suppressed. They had to face teargas and lathicharge. They were locked inside their own colony. Why? This is not right at all. The officers behind this action must be suspended immediately," he said.

He said this "is not a political issue but a national issue".

"Kashmiri Pandits want security. They don't feel safe there. If Kashmiri Pandits don't get proper security in their homeland then how will the Kashmiri migrants living all over the country rehabilitate to their homes? There won't be any assurance greater than law and order that will motivate them to rehabilitate the valley," he said.

"With folded hands I request the Centre, please do whatever you can and help the Kashmiri Pandits lead a dignified life. No matter how much it costs, every provision needed must be implemented," he added.

"We all must come together to work for the upliftment and rehabilitation of the Kashmiri Pandits living all over the country," he said.

### 2 timber smugglers arrested; illicit timber seized

BUDGAM: Police on Monday seized illicit timber at Rathsun crossing of Budgam and arrested 2 persons involved in crime.

As per details, a party of Police Station Beerwah at a checkpoint established at Rathsun crossing intercepted a Load Carrier (JK13E-8766) and during checking, recovered 39 logs of illegal timber laden it in. Two smugglers identified as Siraj-u-Din Bhat, son of Ghulam Ahmad Bhat & Sajad Ahmed Bhat, son of Sona-ullah Bhat, both residents of Rathsun Beerwah were arrested on the spot and shifted to Police Station where they remained in custody. The vehicle used in commission of crime was also seized. Accordingly, FIR No. 56/2022 under relevant sections of law was registered at Police Station Beerwah and investigation started.

### 37 bovines rescued, 8 smugglers nabbed

POONCH: Police on Monday rescued 37 bovines from clutches of 8 smugglers while foiling bovine smuggling bids in Surankote and Thannamandi areas.

As per details, on direction of SSP Poonch Rohit Baskotra under the close supervision of ASP Poonch Musheem Ahmed, teams headed by DySP Surankote Tanveer Jeelani, SHO Surankote Insp Niaz Ahmed, Incharge Police Post Behramgalla SI Sushant Singh, SI Rohit Manmar established Nakas at Mirza Morh Surankote, Baffiaz, Behramgalla, Panar areas. During checking, police apprehended 5 bovine smugglers and seized 5 vehicles (JK12A 9172, JK16A 2799, JK11F 3798, JK11F 5743 & JK12B 9656). Five FIRs viz Nos 118, 119, 120, 121 & 122 of 2022 under sections 188 of IPC, 11 of PCA Act were registered at Police Station Surankote and further investigation started.

At Rajouri, rescuing nine bovines loaded in three vehicles, police in Thanamandi sub division arrested three smugglers.

Police said that a team headed by SHO Thanamandi Shoket Chowdhary under the supervision of SDPO, Dr. Intiaz Ahmed intercepted three vehicles which were playing on Thanamandi road.

Nine bovines were found loaded in the vehicles which have been rescued and three smugglers have been arrested besides seizure of three vehicles.

The seized vehicles include JK18 3027, JK11E 6900 and JK11F 4198 while arrested accused include Azmat Khan son of Mohd Hafiz resident of Kunder Dhan Reasi, Bajeer Hussain son of Ali Mohd resident of Arabal Kulgam and Ghulam Hussain son of Jamal Din resident Hamshipura Shopian.

### 5 stunt bikers arrested, 3 bikes seized

JHAJJAR KOTLI: Police on Monday arrested 5 bike riders including two pillion riders for performing stunts at Jhajjar Kotli.

As per details, information was received at Police Station Jhajjar Kotli regarding some persons performing stunts on motorcycles and riding bike in a negligent manner. On this a special team of Police Station Jhajjar Kotli led by SHO Vikram Sharma rushed to the spot and arrested accused persons besides seizing their bikes. FIR No.105, 106 & 107/2022 under sections 279/336 of IPC were registered at Police Station Jhajjar Kotli. The arrested accused and seized bikes included Motorcycle Enfield Classic 350 (JK02CD/5976) driven by Vishal

Monday's survey of the mosque complex started at 8 am and ended around 10.15 am.

"All parties were satisfied with the work," Varanasi District Magistrate Kaushal Raj Sharma told reporters.

He said the next order of the court will be known only on Tuesday, the deadline set by it for the advocate commissioner to submit the survey report.

"Till then nobody should disclose what has been found inside the court complex, the DM said. "However, if anyone is disclosing it on his own, then its authenticity cannot be proved. Only the court is the custodian of this information," he said.

Earlier, while reporting the "finding" to the media, Madan Mohan Yadav, who represents the Hindu side, said he and senior advocate Harishankar Jain had submitted an application in the district court to secure the Shivling.

### LeT module busted...

Lone, resident of Gundpora. The arrested terrorists were tasked to carry out attacks on Police/SF and other soft targets particularly in Bandipora district.

He said the Pakistan-trained terrorist has been identified as Arif Ajaz Shehri alias Anfal, who went to Pakistan on a valid visa in 2018 through Wagah Border and infiltrated back to this side after obtaining illegal arms training.

He said the four terrorist associates have been identified as Riyaz Ahmad Mir alias Metha Shehri, son of Gh Mohammad Mir, resident of Plan Bandipora; Gh Mohammad Waza alias Gul Bab, son of Gh Qadir Waza, resident of Tawheedabad Bagh; Maqsood Ahmad Malik, son of Mohammad Jamal Malik, resident of Chittibandy Aragam and Sheema Shafi Waza, daughter of Mohammad Shafi, resident of Tawheedabad Bagh.

Preliminary investigation revealed that the arrested terrorist associates were involved in harbouring terrorists, providing logistics and material support including transportation of terrorists in Bandipora district. The arrested female terrorist associate was also involved in providing Wi-Fi hotspot, accommodation and ferrying terrorists in Bandipora town, the spokesman said.

Incriminating material, arms and ammunition including two pistols, three pistol magazines, 25 pistol rounds and three hand grenades were recovered from their possession, he said, adding one van, bearing registration No. JK15A-1528 which was being used in ferrying of terrorists from Bandipora to Srinagar was also seized.

Besides, three scooters, one Maruti-800 car and one Pulsar Bike were also seized. These were being used for doing recee of police, security establishments, monitor movement of security forces and ferrying of terrorists, he added.

### India categorically rejects...

"We are dismayed that the OIC secretariat has once again made unwarranted comments on the internal affairs of India," Bagchi said.

"As in the past, the Government of India categorically rejects the assertions made by the OIC secretariat on the Union Territory of Jammu and Kashmir which is an integral and inalienable part of India."

Bagchi was responding to media queries on the OIC statement on the delimitation exercise in Jammu and Kashmir.

"The OIC should refrain from carrying out its communal agenda vis-a-vis India at the behest of one country," he said.

India has been hitting out at the OIC for its comments on Jammu and Kashmir.

In a statement earlier, the general secretariat of the OIC "expresses deep concern over India's attempts to redraw the electoral boundaries" of Jammu and Kashmir, alleging it is a violation of the rights of the Kashmiri people.

"Referring to the long-standing and principled position on the Jammu and Kashmir dispute and relevant decisions of the Islamic Summit and OIC Council of Foreign Ministers, the general secretariat reiterates its solidarity with the people of Jammu and Kashmir," it said.

Singh informed that the Jammu & Kashmir grievance system had already been integrated with the central grievance portal in October, 2020, thus making it the first Union Territory of India to have its district level grievance offices integrated with the Centre's Centralised Public Grievance Redress and Monitoring System (CPGRAMS).

Describing it as a successful story of the first-ever experiment to integrate district portal with state and thereof with the national portal, the minister hoped that this mechanism will also be emulated by more states and Union Territories, the statement said.

Singh said, Jammu and Kashmir became the first UT in the country to have Good Governance Index and was also the first to launch District Good Governance Index for 20 districts of the Union Territory of Jammu and Kashmir in January this year.

He said, the index represented a major administrative reform in bench marking good governance at district level and a significant step for timely collation and publication of statistics at state/ district level.

Singh said the central government is committed to raising the living standards of its citizens and ensuring inclusive growth for all.

In his address, Secretary, DARPG, V Srinivas said the conference is an effort to bring the government and citizens closer through various administrative reforms at centre, state and district level.

This is being enabled by the use of digital technology, pursuing next generation reforms and innovations with policy objective of "maximum governance, minimum government", entailing government process re-engineering, universal access to e-services, excellence in digital initiatives at district level and excellence in adopting emerging technologies and use of ICT management, he said.

Arun Kumar Mehta, Chief Secretary, J&K informed about the various reforms around good governance and effective implementations of schemes and initiatives over the recent past.

### French Prime Minister resigns

PARIS: French Prime Minister Jean Castex resigned Monday in an expected move after the reelection last month of centrist President Emmanuel Macron, who will quickly name a replacement.

Castex came to the Elysee presidential palace on Monday to formally offer his resignation, which the president accepted, the Elysee said in a statement.

Macron is expected to name a new prime minister shortly. French media say Labour Minister Elisabeth Borne is the favourite for the job. In France, it's common for presidents to have more than one prime minister during their terms.

Macron and his new prime minister will then hold talks in order to appoint France's full new government in the coming days.

The new prime minister's first mission will be to make sure that Macron's centrist party and its allies do well in France's parliamentary election in June. The vote, scheduled for two rounds, will determine which group holds the majority of seats at the National Assembly, which has the final say over the Senate in France's law-making process.

Macron also promised a bill addressing the rising cost of living in France, where food and energy prices are surging. It will be prepared by his new government and is expected to be presented just after the parliamentary election.

If Macron's party wins a majority in the Assembly, the prime minister will then need to ensure that pension changes promised by the president are put into law, including raising the minimum retirement age from 62 to 65. The proposed changes have been criticized by workers, unions and left-wing voters.

Macron also promised that the new prime minister would be directly in charge of green planning, seeking to accelerate France's implementation of climate-related policies. Macron vowed to go twice as fast in his second term to curb greenhouse gas emissions.
