JAMMU: To get first-hand account of the public grievances,

Deputy Commissioner, Avny Lavasa on Wednesday conducted an extensive tour of the Bishnah and Arnia area and held public outreach camps. DDC members, Sarpanchs Panchs besides scores of individuals apprised her about the problems being faced by them in day to day life.

The PRI members one by one highlighted the issues regarding their respective Panchayats which were mainly related to irregular supply of water and electric-
