1. Whereas in terms of the Excise Policy for the year 2022-23 issued by Finance Department vide S.O 71 dated 22.02.2022, JKEL-2 licenses are to be allotted through e-auction, and accordingly, e-auction for 279 locations across Jammu and Kashmir was held from 09/03/2022 to 15/03/22; and,	
2. Whereas the HI bidders for these locations were required, inter alia, to deposit 50% of the bid amount within 5 working days and the remaining 50% amount within 10 working days from the date of conclusion of auction for their respective location; and,	
3. Whereas out of the 279 HI bidders, 28 HI bidders failed to deposited the bid amount in the time permitted the details of which have been communicated by the Deputy Excise Commissioner (Executive), Jammu vide letter number DECEJ/e-auct,on 2022-23-JKEL-2/Exc/10731 dated 24-03-2022; and,	
4. Whereas the claim of those 28 HI bidders was forfeited vide Order No. 351-EC of 2022 dated 25-03-2022 as per the clause 2.4.9 of the Excise Policy and clause VIII & Clause XIII of the Bid Document; and,	
5. Whereas the cases of these 28 locations where the claim of HI bidders was forfeited were placed before the Committee constituted vide Government Order No. 43-FD of 2022 dated 28-02-2022 in its meeting held on 26-4-2022 to scrutinize them and suggest appropriate action as per relevant provisions of the Excise Policy and Bid Document 2022-23; and,	
6. Whereas as recorded in the minutes of meeting of the Committee issued vide no. EC/Exc/e-auction/2022-23/1097-1103 dated 02-05-2022, it was decided that in 17 cases listed in Annexure-I to this order, the H2 bidder should be given the opportunity to match the H1 bid; and in 11 cases listed in Annexure-II to this order, the cases should be put to re-auction as these locations cannot be offered to the H2 bidder on account of ineligibility of the H2 bidder for reasons recorded in the afore-said minutes.
