**CRIME REPORT**

**Gang of burglars busted; ex-Sarpanch among 4 arrested, stolen property recovered**

DODA: Police on Thursday busted a gang of burglars by arresting 4 persons including an ex-Sarpanch and recovered 33 stolen batteries of vehicles from their possession.

In an official statement, SSP Doda Abdul Qayoom said that Police Station Doda received many complaints regarding theft of vehicles batteries during night from different parts of Doda and accordingly a team was constituted led by Incharge Police Post Doda ASI Ashwani Kumar under supervision of DySP Hqrs Doda Jaswant Singh. On basis of some technical and human leads, the team arrested 4 suspects from Doda town who during interrogation confessed their involvement in crime. After their disclosures investigating team recovered 33 stolen vehicles batteries from a scrap dealer namely Qamar Din who is also an ex-sarpanch. During initial investigation, it came to fore that during early morning, the burglars used to first break glass of vehicle followed by stealing of batteries and then to sell it to scrap dealer. So far, Doda police has arrested 4 accused who were identified as Mohd Irfan, son of Abdul Rashid Sheikh, resident of Baboor; Aftab Ahmed, son of Mohd Shafi, resident of Paryote; Qamar Din (Ex-Sarpanch & Scrap dealer), son of Mohd Yousef, resident of Pull Doda and Tanveer Ahmed, son of Qamar Din, resident of Pull Doda (Serap).

It is pertinent to mention here that ex-Sarpanch namely Qamar Din was also booked in 2017 for same offence. SSP Doda Abdul Qayoom said that further legal formalities and investigation is going on.

**Major narcotics smuggling bid foiled; woman among two arrested with 1,028 Kg poppy straw****STATE TIMES NEWS**

RAMBAN: Police on Thursday foiled a major narcotics smuggling bid by arresting two persons including a woman with 1028 Kg poppy straw

As per details, during routine checking at Banihal, Police party intercepted a Truck (JK02 AQ 1611) and during thorough checking in presence of a Magistrate, found it loaded with poppy straw like substance in big white polythene bags, which on weighing came out to be 1028 Kg. The driver of the vehicle on questioning disclosed his identity as Mohd Naveed, son of Abdul Qayoom Qazi, resident of Dodaj Tehsil Darhal and his accomplice who happens to be his sister-in-law (Bhabhi) was identified as Uzma Kousar, wife of Mohd Wahid Qazi. Duo was arrested and FIR No 115/2022 under sections 8/15/29 of NDPS Act was registered against them in Police Station Banihal. The overall recovery and arrests were made by the police team under supervision of Insp Muneer Ahmed SHO Banihal, Nissar Ahmed Khoja SDPO Banihal and under supervision of Mohita Sharma, SSP Ramban.
