

## KEEP FINGERS CROSSED

As the delimitation exercise has finally come to conclusion, it is time for the people to keep their fingers crossed as anytime from now onwards the Election Commission of India (ECI) can declare the election schedule for the upcoming Assembly elections in Jammu and Kashmir. It is pertinent to mention that Delimitation Commission has rendered yeoman's service by completing the delimitation exercise in J&K in a short span of time despite number of bottlenecks including the worst ever pandemic COVID-19 that brought life to standstill for about two years in succession. According to the Law Ministry the orders of the Delimitation Commission which redrew the Assembly and Parliamentary Constituencies in Jammu and Kashmir have come into force yesterday and from now onwards the report of the Commission will form the basis of Assembly polls in the Union Territory of Jammu and Kashmir. This change paved the way for the Assembly Elections in J&K followed by restoration of statehood as was announced by Home Minister Amit Shah on various occasions. Though several changes have been made in the delimitation exercise, the exact scenario will become clear only after the Assembly elections will be carried out in the UT as different views are being shared by the different political outfits with several criticizing the aforesaid exercise while others supporting the same. It is pertinent to mention that the delimitation panel had given six additional Assembly seats to Jammu region and one to Kashmir Valley and brought areas of Rajouri and Poonch under the Anantnag Parliamentary seat. Jammu division will now have 43 assembly seats and Kashmir 47 in the 90-member house. Although many political parties are making hue and cry over the changes made in the process, what will be the final outcome is nobody's guess because it is not that easy to foretell things as far as electoral processes are concerned. Definitely the changes made in the constituencies' structure will make a difference but who is going to get benefit out of it is still a big question and the answer to it lies only in the upcoming Assembly polls.

## MET DEPTT'S ROLE CRUCIAL

While another life has been lost to vagaries of weather in the Union Territory of Jammu and Kashmir, the role of Meteorological Department becomes crucial to save human lives from the inclement weather conditions and extreme happenings due to natural occurrences as the officials have state of art facilities to forecast weather conditions precisely. Reportedly, a man was killed after he was struck by lightning in Poonch District. Though in this case, the nature didn't give any chance to the victim to save his life but as far as Met Department is concerned it can save many lives by giving information about inclement weather conditions beforehand as its branch has given the same to Shikarwallahs and tourists to refrain from venturing outside for a day or two as strong winds and gale, and thunderstorms are likely to hit the Valley and other parts of the Union Territory. This is a noble job to save lives as in the past many accidents had been caused due to storms. In the unfortunate Poonch incident, the man was at his home when natural lightning struck and he fell unconscious. He was taken to hospital but the doctors on duty declared him dead. In this context, many parts of Jammu and Kashmir received rain while the aforesaid department has predicted more "intermittent" showers and thunderstorms till May 24. This is the time when the Met Department can play a vital role by publicizing the weather forecast well in time especially for places having hilly and difficult terrain as chances of landslides, mudslides and other catastrophes are more in such places as seen in the cases in the past. The people should also be informed about the precautions which they have to take during the time of inclement weather as many a time lives can be saved by following the precautions. Every year strong winds used to cause accidents in world famous Dal Lake as Shikaras overturned causing injuries and even deaths of tourists who are not used to handling such emergencies therefore Met Department's advisories are of great significance in making things safer in Jammu and Kashmir Union Territory.

#### A New Commandment

What's new about the commandment to love each other? The key to the answers is found in the words in the second half of the verse: "... just as I have loved you, you also are to love one another." When a lawyer and expert of the law asked Jesus what the most important commandment is, Jesus responded, "To love the Lord your God with all your heart, with all your soul, and with all your mind... The second is to love your neighbor as yourself." (See Matthew 22:36-40) When carefully considered, Jesus' answer was really a perfect response not only to the religious people of His day but also to all modern "religious" people". Jesus gives us two commandments that summarize all the laws and commands in Scripture. In other words, the entire Bible has been given to us to teach us about loving God and loving people.

## Farmer Producer Organization: A Paradigm towards Doubling Farmer's Income

Agriculture has always been a lifeline and significant contributor to the nation gross domestic product and Indian economy providing livelihood to millions of farmers.

Around 70 per cent of rural population depends on farming and allied activities. The population has increased 3.5 times from 350 million to 1.40 billion hence demand for food has increased while total cultivable land has shrunk.

The grain area per person has been shrinking steadily for several decades from 0.22 ha to 0.10 ha and it is projected to be as less as 0.06 ha per person in 2050. So the big, alarming question on food and income security has been raised.

Besides this the marginal and small farmers are facing a rapidly overflowing basket of challenges.

Though they produce food of sufficient amount, the output which they get of the input isn't worth satisfying mainly due to lack of facilities like market facilities i.e., transportation, storage, processing etc. value chain addition, credit facilities, input supplies, proper support of technical staff, information dissemination. However the high production cost, low access to credit as well as poor market linkages also hinders the growth.

Rapid alteration and uncertainty like scarcity of irrigation water, menace of wild animal, shortage of labour growing inter-farm as well as inter-regional disparity, unequal household income and low productivity are the prominent witnesses in present day agriculture.

The problems have imposed critical implications on farming community and as a result every day more than 2000 farmers are leaving agriculture and many more rural youth are migrating to cities for other professions.

One of the major joint initiative of the National Democratic Alliance (NDA) government and Prime Minister of India, Narendra Modi under NITI Aayog also emphasizes on doubling the farmer's income. In this scenario the solution is possible through exploring innovative market led extension models in order to integrate the farmers, especially the small farmers; with the value chain so that the net return at the farmers end is remunerative enough for them to remain

in agriculture.

Several institutional models have been tried in India to integrate farmers with production and value chain like Self Help Groups, Farmers Interest Groups, and Farmers Cooperatives etc. But the recent model "Farmer Producer Organization" is one of the major initiative which enables farmers to organize themselves as collective, provides them a business outlook to agriculture, links them to market and to improve their own economics and social situation.

Strategies to boost income through Farmer Producer Organization (FPO), a formal or informal institution for collective action in which most of its members are the one whose main source of income and livelihood is agriculture and allied activities.

FPO provide services which are the main source to enhance the livelihood, access to market information, inputs and advocacy FPO helps in improving socio economic condition of farmers, enhancing the capacity of farmers through better market access and improving the social situation to lessen the transaction costs of accessing inputs and outputs, obtaining the essential market information, securing access to new technologies, and to enter into the high value markets, providing better quality produce. Procurement of input in bulk at lesser cost and selling them in a market at bulk would help the farmers in getting better prices for the produce and thus help in enhancing the income of the farmers.

Linking farmers to market: Linking farmers to markets is critical for improved livelihood of smallholder farmers and beneficial for the consumers.

Smallholders are more efficient in production, yet they face serious disadvantage mainly on account of marketing their produce.

Farmer producer organizations assured marketing linkages and provide small farmers to participate in the marketing collectively and more effectively, they are in a better situation to lessen the transaction costs of accessing inputs and outputs, obtaining the essential market information, securing access to new technologies, and to enter into the high value markets, providing better quality produce. Procurement of input in bulk at lesser cost and selling them in a market at bulk would help the farmers in getting better prices for the produce and thus help in enhancing the income of the farmers.

Value chain addition: FPO has better value chain addition processing unit.

Providing Services: FPO provides various services to their farmers from enhancing the capacity by providing capacity building services, improving market access by providing better market linkages and increasing production per crop by

providing better quality seeds, fertilizers, and their development through increasing linkages with better institutions.

Better income to farmers: Better services provided by FPO helps in strengthening the socio economic condition of farmers by making Net increase in output and improving production of the farmers produce by providing better quality produce. Procurement of input in bulk at lesser cost and selling them in a market at bulk would help the farmers in getting better prices for the produce and thus help in enhancing the income of the farmers.

Linking farmers to market: Linking farmers to markets is critical for improved livelihood of smallholder farmers and beneficial for the consumers.

Smallholders are more efficient in production, yet they face serious disadvantage mainly on account of marketing their produce.

## Progressing Jammu & Kashmir From Laggard to Leader; J&K witnesses completion of 65,000 projects in 3 years

### UT administration completes 1193 works languishing since past 10-20 years

reflecting exponential rise in completion of development works and establishing itself as leader from laggard in the world of progress and prosperity, Jammu and Kashmir has completed over 60,000 development projects in the past three years.

According to official document, 66,724 development projects have been completed in the Union Territory from 2019 to January 2022.

The break up details stated that 9229 projects have been completed during 2018-19, 12637 in 2019-20, 21943 during 2020-21 exhibiting a steep increase as compared to previous years' achievements while 22975 works have been completed during the financial year 2021-22, till January 2022.

The records added that "financial reforms and interventions" initiated by the Centre have facilitated completion of such a long list of development projects within the set timelines in the Union Territory.

"Authorization of projects and resources allocation is made through Budget Estimation, Allocation and Monitoring System (BEAMS), which is a real-time and paperless system. Through these interventions, the Union Territory has witnessed an unprecedented rise in completion of development works and projects in three years," the document reads further.

Similarly, implementation of transformative reforms such as BEAMS which enables online budgetary process and timely release of funds against approved works, online submission of bills through J&K PaySys, Mandatory Administrative Approvals, Technical Sanctions and e-Tendering, digital payments, GFR, GeM and related measures have paced up the development works and brought J&K at par with any other progressive state in the country.

Apart from prioritizing newly sanctioned works, the administration has also focused on languishing projects.

During a review meeting of the Jammu & Kashmir Infrastructure Development Finance Corporation (JKIDFC), it was revealed that a total of 2357 projects have been approved in HPCs for funding under JKIDFC for an amount of Rs. 7110.78 crore, of which, 1239 projects for an amount of Rs 1748.65 crore have been completed.

It was also informed by the officials of JKIDFC that till date disbursement amounting Rs 2270.08 crore with 4637 payments for 1923 projects has been made out of total 2500 crore loan lifted from different financial Institutions and Nationalized Banks.

JKIDFC has achieved tremendous transparency with incorporation of online payment tracking mechanism, tender details/allotment information and geo-tagging of all the projects approved for funding under the languishing scheme of JKIDFC that in itself is a unique model across the country, maintained an official spokesperson.

The J&K administration linked every project approved under JKIDFC with Google Earth for real time monitoring which facilitates public viewing on the official website of JKIDFC. It was stated that these measures had been taken to ensure the quality and timely completion of all these infrastructural projects languishing in the UT for a long time, he added.

The official figures revealed that 1193 projects worth Rs 1984 crore have been completed including five projects which had been lying incomplete for more than past 20 years, 15 projects for more than 15 years, and 165 projects for more than 10 years under the languishing projects programme.
