WHEREAS, vide order issued under endoresment No DDRSK/2022-23/40-41 dated 12.04.2022, you were directed to report in the Directorate of Rural Sanitation, Jammu for further duties;
AND WHEREAS, Vide Communication No DDRDK/222-23/54 dated 15.04.2022 issued by Deputy Director Rural Sanitation, Kashmir it was informed that you have applied for eight days Casual leave w.e.f 15.04.2022 to 23.04.2022(which were actual Nine days) on the ground of ill health.
AND WHEREAS, you did not join after availing of Casual Leave and continued to remain absent from duties.
AND WHEREAS, Vide No DRS/2022-23/Actts/711-15 dated 27.04.2022, a Show cause notice was served to you with the direction to explain your position as to why action as warranted in terms of Article 128 of J&K CSR (Volume-1) of 1956 shall not be initiated against you for remaining un-authorizedly absent from your legitimate duties w.e.f 25.04.2022.
AND WHEREAS, despite issuance of notice neither you justified un-authorized absence nor resumed your legitimate duties w.e.f 25.04.2022.
