CRIME REPORT

2 drug peddlers arrested; psychotropic substances recovered

KULGAM: Continuing its efforts to eradicate menace of drugs and taking stringent action against drug peddlers, police on Tuesday arrested two drug peddlers and recovered psychotropic substances from their possession. As per the details, a party led by SHO Police Station Kulgam under supervision of DySP Hqrs Kulgam during Naka checking at Srandoo crossing, intercepted three suspects riding a Scooty (JK03H-6702). During search, 29 bottles of liquor (Rum) and 20 bottles of Codeine Phosphate were recovered from their possession. Two accused were identified as Bilal Ahmad Dar, son of Nazir Ahmad Dar, resident of Bogund and Gulzar Ahmad Dar, son of Ghulam Qadir Dar, resident of Naibasti, Anantnag while one drug peddler, Farooq Ahmad Dar son of Abdul Rashid Dar, resident of Bogund managed to flee from the spot. The two accused were arrested and shifted to police station where they remained in custody. FIR No. 63/2022 under relevant sections of law was registered at Police Station Kulgam and investigation started while efforts are on to nab absconding drug peddler.

8 vehicles seized for illegal mining

JAMMU: In a quest to stern menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which teams of Police Station Jhajjar Kotli, Gharota, Police Posts Phallian Mandal, Canal and Bathindi acted stringently on the specific inputs and raided at different locations in their respective areas and seized 8 different vehicles involved in illegal mining.

The seized vehicles included two tippers (JK14E-9455 & JK02AP-0265) seized by Jhajjar Kotli police; a dumper (JK02BF-6535) seized by Gharota police; a dumper (JK02BF-6535) seized by Phallian Mandal police; a dumper (JK02CU 7487) and a tipper (JK02CU 1109) seized by Canal Police and two dumpers (JK02CT9260 & JK02CV 7088) seized by Bathindi police. The recoveries were made by SHO Jhajjar Kotli Insp Vikram Sharma, SHO Gharota Insp Rajesh Khajuria, Incharge Police Post Phallian Mandal PSI Ajesh Singh Jamwal, Incharge Police Post Canal PSI Amreek Singh and Incharge Police Post Bathindi PSI Mohd Younis Khanday in their respective jurisdictions.

91 bovines rescued; 10 smugglers nabbed

NAGROTA/POONCH/UDHAMPUR: Police on Tuesday foiled various bovine smuggling bids by rescuing 91 bovines and arrested 10 smugglers.

As per details, Nagrota Police rescued 33 bovines during Naka checking at Ban Toll Plaza Naka and seized three vehicles (JK02AA 5425, JK02AG 5095 and HP38G 6021). Three FIRs vide No 228, 229,220/2022 under sections 188 of IPC & 11 of PCA Act were registered at Police Station Nagrota and 5 smugglers were arrested, who were identified as Mohinder Pal Singh, son of Madan Singh, resident of Miran Sabih and his associate Bashir Ahmed, son of Mohd Qasam, resident of Nikki Tawi; Arif, son of Yaqoob, resident of Saharanpur UP and Darshan Lal, son of Chaman Lal, resident of Tandia Hoshiarpur (Punjab) and his associate Umer Khan, son of Farooq Ahmed, resident of Kokernag, presently staying at Narwal. The overall arrests and recoveries were made by SHO Nagrota Insp Vishav Pratap Singh assisted by ASI Janak Raj under supervision of SDPO Nagrota Pardeep Kumar. Poonch Police also rescued 14 animals from clutches of bovine smugglers while foiling bovine smuggling bids in Surankote area. On directions of SSP Poonch Rohit Baskotra under close supervision of ASP Poonch Musheem Ahmed, police teams headed by DySP Surankote Tanveer Jelani, SHO Surankote Insp Niaz Ahmed, Incharge Police Post Behramgalla SI Sushant Singh, SI Rohit Manmar established Naka at Behramgalla and Panar areas. During checking, two bovine smugglers were arrested and 2 Tata mobile (JK12A 6761 & JK12 4679) vehicles were seized. FIRs No 125 & 129 /2022 under sections 188 of IPC, 11 of PCA Act were registered at Police Station Surankote.

Udhampur Police under overall supervision of SSP Dr Vinod Kumar also arrested 3 smugglers and rescued 44 bovines. Police team led by SHO Udhampur Insp Chaman Gorkha under the supervision of DySP Hqrs Udhampur Sahil Mahajan

seized two vehicles and rescued 20 bovines. Three bovine smugglers namely Irshad Ahmed, son of Farid Ahmed, resident of Zero Morh, Reasi; Tariq-Ul-Islam, son of Mohd Ramzan, resident of Kulgam and Mohd Rafiq, son of Ghulam Mohd Bhatt, resident of Kulgam were arrested on the spot and FIR Nos. 229 & 231/2022 under relevant sections of law were registered at Police Station Udhampur.

In another incident, a party from Police Station Chenani led by Insp Om Parkash under the supervision of SDPO Chenani Ahmed Shaafi intercepted a truck (PB 10FF5862) and rescued 24 bovines at Motorshed, Chenani. In this regard, FIR under relevant sections of law was registered at Police Station Chenani and vehicle was seized.

Three narco-smugglers nabbed; 18 gm heroin recovered

JAMMU: Continuing its drive against drug trafficking and substance abuse, Police on Tuesday arrested three narco smugglers and recovered 18 gm heroin at a Naka near Ghoda Chowk, Nanak Nagar.

As per the details, a team of Police Station Gandhi Nagar under the supervision of SDPO South Sachit Sharma led by SHO Gandhi Nagar Insp Pankaj Sharma while on Naka duty at Ghoda Chowk Nanak Nagar rounded up three suspects. On search, 18 gm heroin was recovered from them. The accused identified as Raju Massi, son of Kashmir Massi, resident of Gurdaspur; Aditya Partap alias Munna, son of Mohan Singh, resident of Nanak Nagar and Vasu Sharma, son of Rakesh Kumar Sharma, resident of Gandhi Nagar were arrested and FIR No. 126/2022 under sections 8/21/22 of NDPS Act was registered against them at Police Station Gandhi Nagar.

Two Punjab-based truckers nabbed with 40 Kg poppy straw

UDHAMPUR: Continuing its war against drug menace, police on Tuesday recovered 40 Kg poppy straw from two Punjab-based truckers at Motor Shed Naka, NHW Chenani and Lakhampur respectively.

As per the details, a party of Police Station Chenani established a special Naka for checking at Motorshed and intercepted a truck (PB13AF 7402). During checking, officials detected a special cabin inside truck in which 2 bags filled with poppy straw (30 Kg) were hidden. The driver of truck identified as Sharafat Ali, son of Showkat Ali, resident of Qila Rehmatgarh, Malerkotla, Punjab was arrested and FIR No. 83/2022 under section 8/15 of NDPS Act was registered in Police Station Chenani. The Naka party was led by SHO Chenani Insp Om Parkash under supervision of Addl SP Udhampur Anwaar Ul Haq and SDPO Chenani Ahmed Shaafi.

Meanwhile, Lakhampur police also arrested a Punjab-based trucker and recovered 10 Kg poppy straw from his vehicle, which was intercepted by a police team led by Insp Vijay Kowal near Golden gate. The accused driver was identified as Ashok Kumar, son of Devi Dass, resident of Govind Nagar, Choura Bazar, Jalandhar, Punjab.

Bootlegger nabbed with 60 bottles of illicit liquor

VIJAYPUR: Intensifying its drive against sale of illicit liquor under supervision of SSP Samba, Dr Abhishek Mahajan, Police arrested a bootlegger on Tuesday and recovered 60 bottles of illicit liquor from his possession.

Man arrested, snatched money recovered

Youth arrested for harassing girl by creating fake profile on social media

UDHAMPUR: Police on Tuesday arrested a youth who made a fake account on social media (Instagram) under a girl's name.

As per details, based on a complaint lodged by a girl (name withheld) stating that one miscreant has created a fake Instagram account using her name without her consent and regularly harassing her. In this regard, FIR No. 69/2022 under section 66(c) was registered at Police Station Ramnagar and investigation started.

A special team led by Incharge Police Post Ghordi PSI Rhythm Sharma under the supervision of SDPO Ramnagar Dr Bhishm Dubey was constituted and with the help of technical surveillance, police traced out details of the owner of fake Instagram account and identified him.

The accused, identified as Rohit Sharma, son of Charan Das, resident of Prowa Jagir, Jaganoo who arrested by the police team.

Car stolen from parking

Army personnel rescue 12 people from overturned bus in Ladakh

LEH: Twelve passengers, including five children, trapped inside an overturned mini-bus following an accident were rescued by the Army and provided necessary medical assistance here, a defence spokesperson said on Tuesday.

Two passenger mini-buses collided with each other on the Shyok-Durbuk road on Monday, following which one of the vehicles turned turtle, he said.

The spokesperson said a team of 12 soldiers of the Jammu and Kashmir Light Infantry (JAKLI) returning from Durbuk witnessed the accident.

"As first responders, the team immediately swung into action and evacuated the trapped civilians from the bus and also provided first-aid," he said, adding that there was no loss of life in the accident.

A second quick-reaction team, along with an ambulance, was also sent from the battalion headquarters, which further provided medical assistance to the injured, the spokesman said.

J&K reports 3 new COVID cases

SRINAGAR: Jammu and Kashmir reported three new COVID-19 cases on Tuesday, taking the infection tally in the union territory to 4,54,207, officials said here.

All the three cases were reported from Jammu district, the officials said here.

There are 57 active cases in the union territory, while the number of recoveries has reached 4,49,398, they said.

The COVID-19 death toll in the union territory stands at 4,752 as no fresh fatality was reported in the last 24 hours.

The officials said there were 51 confirmed cases of mucormycosis, also called black fungus.
