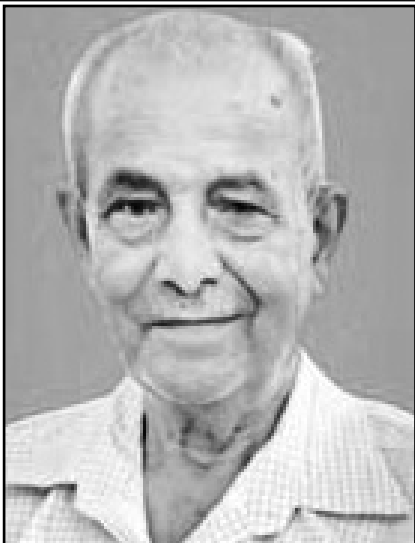

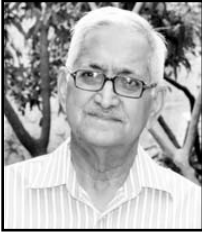

CRIME REPORT

Hit & Run case solved; accused arrested, vehicle seized

REASI: Police on Wednesday solved a hit & run case by arresting an accused and seized the vehicle.

As per details, on May 11, 2022, Sgct Ramesh Chander, son of Om Prakash, resident of Brabi Tehsil Nowshera got hit by an unknown vehicle when he was on way from Nowshera to Katra on his bike (JK 11D 2003). Romesh was shifted to District Hospital Reasi where he succumbed to injuries. FIR no. 28/2022 under sections 279, 304A of IPC was registered at Police Station Pouni and investigation started. Sensing gravity of offence, SSP Reasi constituted multiple teams of Police Station Pouni to trace the vehicle and nab the accused. Police teams rounded up a number of suspects, who were put under interrogations. After sustained efforts, the team zeroed upon a dumper (JK 02 BM 9668), and after hectic efforts the vehicle was traced and driver, identified as Showkat Ali, son of Altaf Shah, resident of Doongi Laiter Pouni was arrested. During sustained interrogations he confessed his crime, after which vehicle was also seized.



13 vehicles seized for illegal mining

JAMMU: In a quest to stern menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which teams from Police Stations Miran Sahib, Kahnachak, Bishnah, Akhnoor, Jhajjar Khotli and police Post Pargwal acted stringently on the specific inputs and raided at different locations in their respective areas and seized 13 different vehicles involved in illegal mining.

The seized vehicles included a Tractor-Trolley without registration number seized by Miran Sahib Police; a Tractor-Trolley without registration number seized by Kanachak police; two dumpers (JK21G 7977 and JK21H 5080) and a tractor without registration number seized by Bishnah police; three tractors without registration numbers seized by Akhnoor Police; a tipper (JK02AR-7539) seized by Jhajjar Kotli police and a dumper (JK02-BJ4671) seized by Pargwal police. The recoveries were made by SHO Miran Sahib Insp Zaheer Mushtaq, SHO Kanachach Insp Kunal Singh Jamwal, SHO Bishnah Insp Pawan Kumar, SHO Akhnoor Insp Hilal Azhar, SHO Jhajjar Kotli Insp Vikram Sharma and Incharge Police Post Pargwal PSI Baljeet Singh Parihar in their respective jurisdictions.

10 bovines rescued, vehicle seized

JHAJJAR KOTLI: In a massive drive against bovine smuggling, Jhajjar Kotli Police rescued 10 bovine animals during Naka checking at Suketar and seized a vehicle (JK02AG-1341). Theft case solved, three stolen motorcycles recovered

JAMMU: Police on Wednesday solved a theft case by arresting an accused and

recovered three stolen motoreycles from his possession.

As per details, a complaint was lodged at Police Post Talab Tillo Jammu regarding theft in area. On this, FIR No. 59 /2022 under section 379 of IPC was registered at Police Station Nowabad and investigation started.

After this, a team from Police Post Talab Tillo under supervision of DySP Hqrs Swati Sharma led by SHO Nowabad Insp Vijay Kumar assisted by Incharge Police Post Talab Tillo PSI Rajesh Kumar; after putting in strenuous efforts, arrested accused identified as Ankush Rathore, son of Jai Nand Kumar, resident of Rusulabad Kanpur (UP) and presently staying at Bhagwati Nagar. During questioning he disclosed that he has stole three motorcycles which included Super Splendor (JK02-CE0287); Bajaj DTS-I bearing Chassis No.MD2A14AZ5CPH36513 and Hero Honda Ambition bearing engine No. 04J60M05093, which were also recovered.

Narco smuggler nabbed with 2 Kg Ganja

JAMMU: Continuing its drive against drug trafficking and substance abuse, Police on Wednesday nabbed a narco smuggler near Bahu plaza and recovered 2 Kg of Ganja from his possession.

As per the details, a team of Police Station Bahu Fort under the supervision of SDPO East Syed Zaheer Abbas Jafari led by SHO Bahu Fort Inspr Nayat Ali while on Naka duty near Bahu Plaza rounded up a suspect. On search 2 Kg Ganja was recovered from the possession of accused, identified as Sanjay Singh, son of Jagannath Singh, resident of Fatehpur (UP), at present Bikram Chowk. He was arrested and FIR No. 142/2022 under section 8/20 NDPS Act was registered against him at Police Station Bahu Fort.

Bootlegger nabbed with 54 bottles of illicit liquor
