- The elections of District Gurdwaras Prabhandhak Committees (DGPC) are held under the provisions of Jammu & Kashmir Sikh Gurdawaras and Religious Endowment Act, 1973 and the Jammu & Kashmir Sikh Gurdawaras and Religious Endowment Rules 1975. The last elections to the DGPCs were held in 2015.
- As per Rule 3(1) of the Jammu and Kashmir Sikh Gurdawaras and Religious Endowment Rules, 1975, there shall be an Election Authority for arranging elections of Gurdwara Prabhandhak Committees in each district. The Election Authority of the District is Assistant Commissioner Revenue [notified vide SRO 475 of 1975 dated 30-09-1975].
 - Under Rule 3(2) of the Jammu and Kashmir Sikh Gurdawaras and Religious Endowment Rules, 1975, the Financial Commissioner exercises superintendence, direction and control over elections.

- Certain key aspects are mentioned below:-
 - The counting of votes shall be taken up on the day of poll unless notified otherwise, followed by announcement of the results.
 - Hours of poll – 7:00 A.M. to 1:00 P.M.
 - The DGPC Elections shall be held through Ballot Boxes.
 - Divisional Commissioner, Jammu/Kashmir have been appointed as Nodal Officers in respect of Divisions for coordination of these elections vide Govt. Order No. Rev/Gen/54/2020 dated 10-10-2020.
 - Photo Electoral Rolls have been prepared for the DGPC elections for the first time.
 - The qualifying date has been kept as 01.04.2022, in accordance with the latest amendment in the Representation of the People Act, 1950 regarding the eligibility of an elector.
 - The filing and disposal of the claims and objections have been made electronically for the first time, leading to generation and updating of electoral rolls automatically.
- The following modifications have been made to address some gaps in the Jammu and Kashmir Sikh Gurdwaras and Religious Endowment Rules, 1975 vide SO 123 dated:8.04.2021:
 - A person who is eligible to be registered as voter under these rules shall be allowed to be added to the electoral rolls till the last date of filing nominations (Rule 7).
 - The Election Authority shall cause the electoral rolls to be prepared which shall include the name of every such sikh who is registered or eligible to be registered as a voter in the corresponding electoral roll of the Jammu & Kashmir Legislative Assembly (Rule 5 (1)).
 - Appeal: - Rule 31(a) has been added for making a provision for an appeal against the election of elected members of the DGPC. The appeal shall lie to the authority as may be notified by the Government within period of 30 days from the date of declaration of results. Similarly, rule 45 (a) has been added for making a provision for an appeal against the election of the elected members of the Board. The appeal shall lie to the authority as may be notified by the Government within period of 30 days from the date of declaration of results. Sd/-
