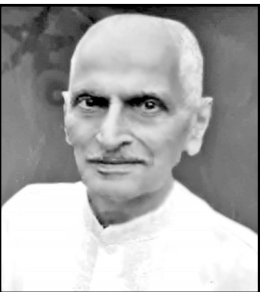

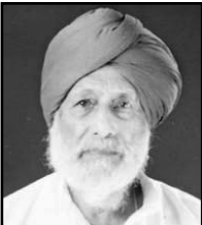

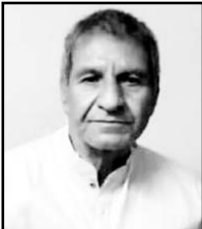

# CRIMEREPORT

## Ten gamblers arrested in Srinagar & Jammu; stake money seized

SRINAGAR/JAMMU: Acting tough against social crimes, Police on Saturday arrested 10 gamblers in separate actions in Srinagar and Jammu and seized stake money from their possession. As per details, following an input about gambling activities, a party from Police Station Khanyar raided a gambling site at Chola Mohalla Khanyar and arrested two gamblers, identified as Arif Ahmad Chola, resident of Aram Masjid, Khanyar and Arshid Ahmad Mir, resident of Konakhan. Officers also seized stake money amounting to Rs 12,300, playing cards and 4 mobile phones from their possession. However, 4 other gamblers namely Shabir Ahmad Chola, Hilal Ahmad Chola, both residents of Chola Mohalla, Gowher Ahmad Halwai, resident of Anderwari Naidkadal and Gulzar Ahmad Bhat resident of Eidgah managed to flee and efforts are on to nab them. During the preliminary investigation, the arrested gamblers revealed that stake money of more than Rs 2 lakh was taken by absconding gamblers. Similarly, in another action, officers from Police Station Bemina raided a gambling site near JVC Hospital and arrested 3 gamblers, who were identified as Mukhtar Ah Fafao, resident of Boatman Colony, Amir Ah Kahloo and Shakeel Ahmad Misri, both residents of Mansoor Colony. Officers also seized stake money amounting to Rs 3,450 and playing cards from their possession. Accordingly, cases under relevant sections of law have been registered in respective police stations and further investigation initiated.

In another action, in an act of alertness and prompt action, a team of Police Station Nagrota headed by SHO Nagrota Inspr Vishva Partap and assisted by SI Majid Hussain while on patrolling duty received information regarding some gambling activities in the area under jurisdiction of Police Post Sidhra. On this police teams raided the spot and nabbed five gamblers along with Rs 10,920 as stake money. FIR under section 13 of Gambling act was registered at Police Station Nagrota and all 5 accused were arrested, who were identified as Srinawas Rao, son of Harikesh Rao, resident of Orrisa, at present Nikki Mohalla Sidhra; Mohd Sarwar, son of Mohd Farman, resident of Kishanganj Bangal; Akhter, son of Mohd Din, resident of Kishanganj Bangal, at present Nikki Mohalla Sidhra; Vikram Thakur, son of Arjun Thakur, resident of Bihar, at present Nikki Mohalla Sidhra; Sagir Ali, son of Tahir Ali, resident Lucknow UP, at present Tawi Vihar Colony Sidhra. The overall arrests and recoveries were made under the supervision of SDPO Nagrota Pardeep Kumar.

## Police destroys poppy cultivation

HANDWARA: Continuing its efforts to eradicate the menace of drugs from the society, Police along with civil authorities destroyed poppy cultivation in villages Bakihakar and Gorihakar falling in jurisdiction of Police Station Handwara.

## 9 Govt employees found absent in Doda, action initiated

DODA: To ensure punctuality and quality service delivery in Government offices, Assistant Commissioner Development Doda Phulail Singh Bandral conducted sur-

prise inspections of BDO office Gundana and BDO Office Ghat.

During inspection, he interacted with the office staff and public who had visited BDO office for different works. It was found that four employees of BDO office Gundana and five employees of BDO office Ghat were absent from their legitimate duties without any approval from competent authority. Action was initiated against the absentees and their salary was stopped with immediate effect. Further, BDO Dali Udhyanpur and BDO Khalleni were appointed Enquiry Officers to inquire into reasons of their absence.

## Missing girl traced, reunited with family

JAMMU: Police on Saturday missing girl and reunited her with family within 24 hours of registration of complaint. As per details, a complaint was lodged at Police Post Bathindi, by the legal heirs of a girl, stating that she went missing from her house. Accordingly, a missing report vide DDR No. 05 dated May 25, 2022 was registered at Police Post Bathindi and investigation started.

On this, a team was formed under the supervision of SDPO East Zaheer Abbas Jafri led by SHO Bahu Fort Insp Nayat Ali assisted by Incharge Police Post Bathindi PSI Mohd Younis Khanday, and after putting in strenuous efforts the location of missing girl was traced in Uttarakhand & Uttar Pradesh. A team was sent to location, which raided several locations in Uttarakhand and Uttar Pradesh and finally recovered the missing girl from Tanda, Bareilly (UP). Subsequently, family of missing girl was informed and traced girl was handed over to her family members after completing all the legal formalities.

## 7 vehicles seized for illegal mining

JAMMU: In a quest to stern menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which teams from Police Stations Miran Sahib, Jhajjar Kotli, Police Posts Pargwal and Pallanwala acted stringently on the specific inputs and raided at different locations in their respective areas besides seizing 7 different vehicles involved in illegal mining. The seized vehicles included a tractor-trolley (JK02BR-9460) seized by Miran Sahib police; a Dumper (JK02BB-7703) seized by Jhajjar Kotli police; a Tractor (JK02BR- 5785), a tractor-trolley bearing chasis No. NHN36000ZHE388003 and a JCB bearing registration number JK213255 seized by Pargwal police, a tractor-trolley without registration number seized by Pallanwala police; a tractor-trolley bearing Chassis No MBNB G53AGMCG20524 seized by Phallain Mandal police.

The recoveries were made by SHO Miran Sahib Inspr Zaheer Mushtaq, SHO Jhajjar Kotli Insp Vikram Sharma, In-Charge Police Post Pargwal PSI Baljeet Singh Parihar, Incharge Police Post Pallanwala PSI Vijay Kumar and In-Charge Police Post Phallain Mandal PSI Ajesh Singh Jamwal in their respective jurisdictions.

## Woman among three arrested; 7 Kg narcotics, 2 IEDs recovered

KUPWARA: In a major success against narco-terrorism, a joint team of Kupwara Police and Army 7 RR has recovered huge quantity of narcotics and IED from a vehicle during a routine check-up at Sadhna Top.

As per details, late in evening on May 27, 2022, during a routine Naka checking by Police & Army at NC Pass (Sadhna Pass), a LP truck bearing registration number JK01AN-8218 driven by one Intiyaz Ahmad, son of Habibullah Khan resident of Chitterkote, Karnah was put to sustained checking. During search of the vehicle, 7 packets of heroin like narcotics substance weighing about 7 Kg and two IEDs were recovered from possession of three accused namely Intiyaz Ahmad, son of Habibullah Khan; Ghulam Nabi, son of Ashiq Ali and Shams Begam, wife of Zakir Hussain, all residents of Chitterkote, Tanghdar. From initial investigations, it transpired that the trio was transporting narcotics & IEDs to other parts of the valley

to aid terrorist activities. Case under relevant sections of law was registered at Police Station Karnah and investigation started.

## 90 bovines rescued; 12 smugglers nabbed

JAMMU: Police on Saturday foiled various bovine smuggling bids by rescuing 90 bovines and arrested 12 smugglers.

As per details, a team from Police Station Chassana led by Insp Parmod Singh SHO Chassana under supervision of Chabail Singh SDPO Mahore established a surprise Naka at Pagooli Tulli area and intercepted a bovine smuggler namely Mohd Yousaf, son of Shamas Din, resident of Dandote, Tehsil Budhal and rescued 2 bovines. He was arrested and FIR No. 27/2022 under section 188 of IPC was registered at Police Station Chassana.

In another incident, a team of Police Station Chassana during surprise Naka checking, foiled bovine smuggling attempt in Gota area of Chassana by intercepting bovine smuggler namely Mohd Manir; son of Mohd Younis, resident of Tulli, Reasi and rescued 5 bovines from his possession.
