

## TRANSPARENCY IN WAQF BOARD

Taking a cue from the mega reformatory spree initiated by the ruling dispensation to improve the working of every sector and Government department in J&K, especially after the bifurcation of the erstwhile State into two Union Territories, many other social and religious organisations are also following the same steps and taking several significant decisions for brining transparency and accountability in their working so that they can serve the masses in a much better way without any chance of misconduct or misappropriation of funds. The Waqf Board of Jammu & Kashmir is one such organisation which is responsible for the upkeep and welfare of various ancient shrines and other religious places located across the length and breadth of the Union territory. Further, keeping proper check on the donations at these shrines and to ensure that the money thus accumulated is spent only for welfare of shrine, providing facilities to pilgrims besides welfare of people, also comes under the domain of Waqf Board. But, during the last few years, like other department and sectors, the board was also lacking necessary check and accountability, thereby raising several questions on its working and management. Soon after formation of Union territory, necessary changes were made in the managements of all such boards, with induction of several new faces having a honest and stain-free background, which not only gave the much necessary boost to these organisations but also improved their working significantly. The Waqf Board, during its meeting on Thursday, has taken several new decisions, not only for welfare of shrines but also to ensure several facilities to pilgrims, which were earlier missing from years. During the meeting, where it was decided to hold counting of donation boxes in all shrines under camera surveillance supervised by the Board representative along with officials from bank and police to establish transparency, on the other hand it was also decided to switch-over to online transactions for any purchase or expenditure. Moreover, now the board has also decided to make necessary arrangements for receiving donations online, so that people can contribute without any problem. The members also accorded necessary approval to construction of a first-ever modern Cancer Hospital in J&K. These people-friendly decisions by the Board show that very soon, it would emerge as a productive organization working for welfare of masses besides revival of our spiritual traditions.

## DECLINING IMR

In its series of initiatives to ensure quality healthcare facilities for the resident of Union Territory of Jammu & Kashmir, the Government has taken numerous significant steps in the recent past, which are now yielding the positive results as desired. It is only due to dedicated efforts of the administration and the far-sighted vision of Government, that now the people of Union territory are getting quality healthcare services, that too at affordable prices and at their doorsteps. On one side, where the existing health institutes are being upgraded with ultra-modern facilities on the other hand, several new prestigious projects are near completion and will be dedicated to the people very soon. It is only due to serious implementation of the various schemes and other healthcare programmes in letter & spirit that the Union Territory is now emerging at top in the list, in comparison to several other states and UTs. In this regard, as per the latest reports, the Union Territory has witnessed unprecedented decline in Infant Mortality Rate (IMR) during last one year, which is really a matter of satisfaction. Pertinent to mention here that IMR in Jammu & Kashmir has witnessed a decline from 20 to 17 in just a year, which is far better than the IMR's national average, which stands at 28 as per Sample Registration System (SRS) 2020 report released by Registrar General of India (RGI-SRS). It needs to be mentioned here that IMR is a crucial health indicator, which indicates number of deaths of children up to one year of age against per 1000 live births. It is only due to dedicated efforts of the healthcare employees, especially those working under National Health Mission (NHM), who worked hard in ensuring necessary medical facilities and awareness among people, in rural and far-flung belts as well, for well-being of new-borns and expecting mothers, that IMR has witnessed such a significant decline. The further good thing is that the Department for Health & Medical Education is still putting in place persistent & tireless efforts so that essential neonatal care is not only kept restricted to few selected health institutes but is made available at all Government health institutions across the Union Territory without any failure, so that the coming generations can enjoy a healthy and diseases-free life.

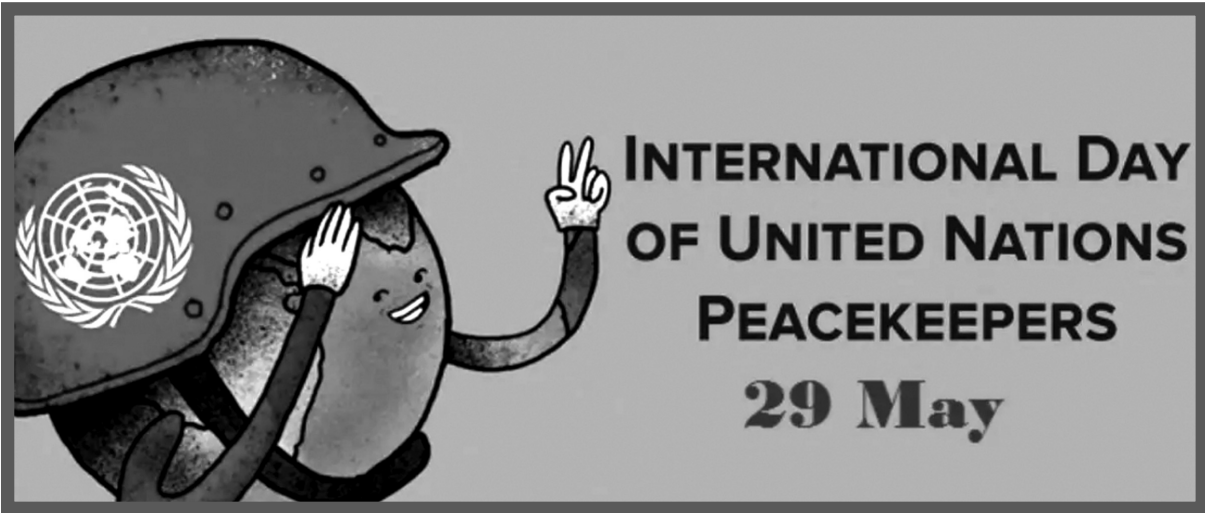

## YOUR COLUMN PM Package employees & Kashmir imbroglio

Apropos to letter 'Listen to Woes of PM Package Employees' by Vivek Koul published in your esteemed newspaper on 27th May, 2022, wherein writer has vividly highlighted the woes and miseries of protesting PM package employees. The spine chilling and shocking incident of Rahul Bhat's killings has shaken the entire KP community. Martyr Rahul Bhat was appointed as a clerk in the year 2010 under a special PM's employment package but very unfortunately became the victim of terrorism two weeks before. The security scenario in Kashmir is in shambles and the J&K UT administration has completely failed to protect minorities living in Kashmir. Earlier in the year 2021, a PM package employee Deepak Chand was mercilessly gunned down by terrorists in the school premises while he was on duty. Even after the abrogation of Article 370 and 35-A the normalcy has not returned in Kashmir. Further, all PM package employees are living in fear and deep distress & the gun culture in Kashmir has spoiled the future of school going KP children. The government has no control over inno-

cent and targeted killings in Kashmir. This job package now seems to be like a deception package only and the centre government is not paying any heed as far as relocation of these employees is concerned. However, targeted killings goes unabated in Kashmir and some terrorist organisations have been issuing warning letters against Kashmir Pandits directing them either to leave the valley or be ready to face bad consequences. All this boils down to the facts that the PM package employees have become now soft targets of militants and thus rightly the protesting package employees are demanding their relocation outside the Kashmir valley and other safer places of India. The protesting package employees are not demanding anything impractical. Their demand is genuine and thus should be fulfilled by the centre government and J&K UT administration. One wonders as to why the centre government is showing lackadaisical approach towards their demand of relocation inspite of knowing the fact that the minorities are not safe in Kashmir. The ground situation in Kashmir is terribly volatile so PM package employees should not be made scapegoats. These hapless and unfortunate migrant package employees need a healing touch from the government and therefore the government must immediately relocate all PM package employees outside Kashmir valley.

#### 'Mission Youth' instrumental towards satiating aspirations of youth

Young people should be respected, valued and listened to, be supported and encouraged in building personal and social relationships, developing their innate abilities and talents for their own benefit and benefit of the society at large", envisioned the J&K Youth Mission initiative of UT government. Implementation of Mission Youth in Jammu and Kashmir has proved to be instrumental in satiating aspirations of youth of the UT facilitating them with a perfect platform to exploit their job potential to the fullest. The Mission was intended to simultaneously achieve the twin goals of harnessing the rich demographic dividend and transforming youth of J&K into ambassadors of innovation, peace and development through systematic interventions for Youth Engagement and Outreach under six domains including livelihood generation, education/skill development, financial assistance, counseling/theory, sports and recreation.

To meet aspirations of youth, J&K administration has taken numerous steps towards creating infrastructure, schemes and policies to speed up their socio-economic development under Mission Youth. Jammu and Kashmir is bestowed with a predominantly young population with about 69 per cent of the people being below the age of 35 years. In order to provide a platform for holistic implementation of all youth engagement and outreach initiatives and to bring the interests and empowerment of youth to the centre of policy making, government of Jammu and Kashmir has rolled out a pioneering initiative 'Mission Youth'.

Under Munkin scheme, unemployed youth are facilitated to procure small commercial vehicles, on subsidized rates, to establish a sustainable livelihood line in the transport sector. Also, a module has been developed on JK-e Services portal for operating the scheme digitally in a complete transparent manner. As a special incentive under this scheme, Mission Youth is contributing 0.80 lakh or 10per cent of On-Road Price of Vehicle (whichever is Minimum) per beneficiary and an equivalent amount is also contributed by the vehicle manufacturers. Mission Youth has tied up with reputed vehicle manufacturers as scheme partners for providing the best in class options of vehicles to the youth. Pertinently, discretion to choose type of vehicle is left to the youth under scheme guidelines.

A dedicated portal has been launched by Mission Youth in collaboration with Vision India to connect youth of J&K with the industry. The initiative aims to provide more than 10,000 job opportunities to youth in 2022. J&K administration has taken many steps to create infrastructure, formulate schemes and policies to speed up economic development and meet the aspirations of Youth so that they can contribute to society and achieve self growth. Mission Youth under its AVSAR (Connect to Opportunities Initiative) has signed a MoU with Vision India for providing job opportunities to the youth of J&K. A dedicated portal of employment opportunities for youth of J&K has been provisioned to facilitate them in getting the best jobs. In its endeavor towards empowering women socially and economically, Lieutenant Governor, Manoj Sinha, launched Tejasvini scheme for implementation in the Union Territory. This is a start up funding programme for adolescents and young women of the UT making them empowered and self dependent through their own business ventures. The broad aim of the scheme is to provide financial assistance to young women of 18 to 35 years of age for setting up of gainful self-employment ventures, suited to their skills, training, aptitude and local conditions. Under the scheme, female entrepreneurs shall be facilitated to avail financial assistance under Mudra from J&K Bank to the extent of Rs 5.00 lakh. Mission Youth, J&K shall provide an amount of Rs. 50,000 or 10per cent of project cost as subsidy. Besides, interest component of the loan shall also be sponsored by Mission Youth as special incentive and repayment of loan will technically be interest free for the young female entrepreneurs who apply for assistance under the scheme.

Mission Youth is focused on continuously encouraging, engaging and mobilizing young volunteers of J&K to support the government efforts towards socio-economic transformation of Jammu and Kashmir. Another initiative under Mission Youth is Youth Clubs. The youth volunteers of these Youth Clubs are being given training on all aspects of government schemes. They will be part of emergency and crisis plans and will be involved in the planning and decision making regarding volunteer led activities to be done in Panchayats or wards. The Youth Clubs are also provided special incentives in the form of grant-in-aid to support their activities. Youth Engagement programs have been convened in all districts through these youth clubs and more than 2 lakh youth have been associated with the programme.
