People protest against PDD for low voltage, illegal operationalisation of welding units

SUNDERBANI: The people from Thandapani of block Sunderbani and adjoining villages including Bhajwal, Beanigala and several others held a protest demonstration against the Power Development Department (PDD) authorities for operationalization of illegal welding sets, low voltage and frequent unscheduled power cuts in the area.

A large number of people of the town and villages, including local Panchs, Sarpanchs and other prominent members came on road and raised slogans against power development department (PDD) Sunderbani. They later met District Development Council (DDC) Sunderbani Rajinder Sharma and appraised him that the existing transformers are overloaded by illegal connections of AC, illegal welding units at Beanigala, Sunderbani, Kalideh, Thandapani and other areas for which many time people complaint to AEE of PDD Sunderbani but department haven't took any action.

Enforcement teams recover Rs 200 fine from violators

The enforcement teams, during the inspection in their respective jurisdictions, recovered a fine of Rs. 200 from violators, the enforcement officers urged the people to wear face masks and maintain physical distance besides taking Covid vaccination doses at their nearest CVC.

As per daily bulletin issued by the Chief Medical Officer Ramban, Dr. Mohammad Fareed Bhat, the Health Department has collected 1284 samples including 462 RT-PCR and 823 RAT samples besides administering Covid vaccine to 32 persons at various dedicated Vaccination Centres in the district.
