In this context, you will please recall that payment on account of work done claim for the construction of aforementioned work was released in favour of your Firm by this office in December 2021. Thereafter the work on the aforementioned road remained suspended during the winter and has not been resumed as yet which cannot be appreciated.

This Department has made as varoiur communication with your Firm vide letter No:- PMGSY/K/3873-77 Dated:- 13-02-2022, PMGSY/K/673.76 Dated:- 18-05-2021, PMGSY/K/2241.45 Dated:- 14-08-2021, Chief Engineer PMGSY Jammu letter No:- CEJ/ PMGSY/ 11041-44 Dated:- 07-09-2021 and vide this Office letter No:- PMGSY/K/3266-70 Dated:- 08-10-2021 regarding speed up/resumption of work on the above said Road.

Asst, Executive Engineer, PMGSY Sub-division, Kishtwar personally visited the aforementioned road on 24-04-2022 to ascertain whether any activity is going on at aforementioned road or not. But it was observed at the site of work that there was no activity on the aforementioned Road in that day. So there is a huge gap between your words and action on ground which clearly speaks about your non seriousness regarding executive of work allotted to your firm.

It is pertinent to mention that we have received number of complaints on various govt, portals like Mari Sadak, JK Grievences for the work allotted to your firm which you have abandoned for more than four months without any valid reason and is against the sprit and ethos of PMGSY program. I would not hesitate to mention that peoples have dropped written complain to central Quality Monitor(CQM), NRIDA, Delhi against your Firm and has even raised the question regarding the quality of work just because you left the damaged wall unattended for which communications have been made by the Department with your Firm which may please be noted.

Now, you are finally directed to resume the work on the aforementioned road within a four days positively and also furnish an up dated works program of the scheme for its completion within the stipulated time.

In case the aforementioned work is not resumed by your firm within a four days then action as per the clauses of the Agreement/SBD shall be initiated against you firm and the contract shall be recommended for termination as per clause 52.2 (a) of part- 1 General condition of contract of standard biddingf Document (SBD) on Your risk and responsibility, which may please be noted.
