







## Narco smuggler nabbed with 1.5 Kg Ganja

JAMMU: Continuing drive against drug trafficking, Jammu police on Thursday arrested a narco-smuggler from Bathindi and recovered 1.5 Kg Ganja from his possession.

As per details, a team of Police Post Bathindi constituted under the supervision of SDPO East Syed Zaheer Abbas Jafari and led by SHO Bahu Fort Inspn Nayat Ali assisted by Incharge Police Post Bathindi PSI Mohd Younis Khanday, while on Naka duty, rounded-up a suspect. On search, 1.5 Kg Ganja was recovered from his possession. The accused, identified as Babu Lal alias Babloo, son of Gangaram, resident of Piparbhuan Baloda Bazar, Chhattisgarh, at present Malik Market, Narwal Jammu was arrested and FIR No 129/2022 under sections 08/20 of NDPS Act was registered against him at Police Station Bahu Fort.

## 17 bovines rescued; 3 smugglers arrested

UDHAMPUR/KATHUA: Police on Thursday foiled two bovine smuggling bids by rescuing 17 bovines and arrested 3 smugglers.

As per details, a police team led by Incharge Police Post Tikri PSI Abdul Satar under supervision of Sahil Mahajan DySP Hqrs Udhampur and overall supervision of SSP Dr Vinod Kumar intercepted 2 groups of bovines at Naka point Tikri, which were taken on foot by smugglers separately towards Kashmir. All 15 bovines were rescued and two smugglers namely Jamat Ali, son of Mohd Mustafa, resident of Miran Sahib, Jammu and Mohd Rafiq, son of Haji Babu, resident of R S Pura were arrested on spot. FIR Nos 90 & 91/2022 under relevant sections of law were registered against them in Police Station Rehambal.

Meanwhile, a team of Police Post Marheen led by PSI Swaran Singh Manhas Incharge Police Post Marheen under supervision of SDPO Border Pankaj Sodar during Naka checking duty noticed movement of one suspicious Load Carrier (JK08F-6290) driven by one Kuldeep Raj, son of Naseeb Chand, resident of Jogial Tehsil Marheen District Kathua and signaled it to stop for checking. On checking, 2 bovines were found laden in vehicle, which were rescued. The accused was arrested and FIR No. 91/2022 under sections 188 of IPC, 11 of PCA Act was registered at against him Police Station Rajbagh.

## Man nabbed with 30 lts illicit liquor

## Drug peddler nabbed with 1.1 Kg Charas

DODA: Police on Thursday nabbed a drug peddler and recovered 1 Kg & 120 Gm Charas like substance from his possession.

In a statement, Police said that it was learnt through reliable sources that one Afrim Ahmed, son of Farooq Ahmed, resident of Shamdelian Kahara, at present Malipeth Kishtwar was carrying Charas with him and moving towards Kishtwar.

Acting swiftly, a party of Police Station Gandoh led by Insp. Vikram Singh SHO Gandoh assisted by PSI Rohit Sharma Incharge Police Post Kahara apprehended the accused near Kahara-Jai Bridge, who was coming in a load carrier (JK17- 3497). During search, 1 Kg & 120 Gm Charas like substance was recovered from him in presence of Executive Magistrate, which he had concealed in the vehicle behind driving seat. FIR No. 27/2022 under sections 8/20 of NDPS Act was registered at Police Station Gandoh and vehicle involved in smuggling was also seized.

The forward/backward links of the accused are being ascertained during investigation to unearth source of supplier and network of drug peddling. The recovery and arrest was made by Police party under the supervision of Shahzada Kabir Matoo SDPO Gandoh and overall supervision of Abdul Qayoom SSP Doda.

## Burglary case solved; accused arrested, stolen property recovered

BARAMULLA: Police on Thursday solved a burglary case by arresting an accused and recovered stolen property from his possession.

As per details, Police Station Tangmarg received a complaint from one Fayaz Ahmad Lone, son of Ab Majeed Lone, resident of Maheen Tangmarg stating therein that during intervening night of May 2-3, 2022, some unknown burglars barged into his shop and decamped with mobile phones, mobile accessories and laptops worth lakhs.

Accordingly, FIR number 37/2022 under relevant sections of law was registered at Police Station Tangmarg and investigation started.

During the course of investigation, a special investigation police team led by SHO Tangmarg under the supervision of SDPO Tangmarg was constituted, which, after putting in hectic efforts, zeroed in on a suspect identified as Owais Ahmad Lone, son of Ab Rasheed, resident of Ferozpora Tangmarg. On questioning, the accused confessed his crime and on his disclosure, stolen property worth lakhs was recovered. He has been arrested and shifted to police station where remained in custody.


